



Bosse Hosts State of the City

Mayor Lili Bosse delivered the State of the City Address at the annual Evening with the Mayor at Greystone Mansion on Sept. 28 where a sold out crowd was in attendance

Bosse shared about her passion and purpose to lay the foundation for 'healthy people, a healthy economy, and healthy government'.

Just six months ago the community came together for another sold out event at the Wallis where Bosse was installed by Ambassador Nicole Avant. At her installation, Bosse pledged that public safety was her number one priority.

"We do not defund police, we fund our police," Bosse said, to significant applause.

Bosse glorified the "Real Time Watch Center", this system ensures that cameras across the City are monitored 24 hours a day, every day.

"This new surveillance has already helped solve cases and bring criminals to justice. Just last week, we announced the arrest of multiple suspects in connection with a smash and grab robbery on South Beverly Drive," Bosse said.

Bosse praised BHPD Alert, which is a text alert that informs the community of police activity. Bosse also commended LIVE 911, where officers can hear emergency calls live in the field as they come



in. This allows them to respond without having to wait for instructions from dispatch.

The City is also actively recruiting new officers and has ensured BHPD officers are among the highest paid in the region.

"Thank you to Chief Mark Stainbrook and the entire BHPD family for their quick work to bring these initiatives to life and for their ongoing commitment to keeping Beverly Hills safe. Police and Community together," Bosse said.

Bosse made it known that the business

community is also a big part of the City.

"We have welcomed so many new businesses to Beverly Hills this year and there are still so many more on the way. From Sweetgreen and Erewhon to Shake Shack and Jon and Vinny's – businesses want to be in our City," Bosse said.

Bosse credits this to the City taking steps to incentivize and attract restaurants by relaxing parking restrictions and allowing rooftop dining.

Another initiative Bosse believes has brought the community together is Business with Bosse.

"I cannot tell you how many people have come to me during an event to say they had never stepped inside that business before – and now they are telling their friends and family about it," Bosse said.

Bosse said the City continues to see recovery and improvement in the big four tax revenues - Property Tax, Sales Tax, Business Tax, and TOT, since the pandemic.

Property values have improved while Citywide valuation rose 5.2%, Bosse said. Sales tax has fully recovered and exceeded pre-pandemic levels and business tax has also recovered to pre-pandemic levels. TOT is about 85% of pre-pandemic levels.

"While our beloved business community across the

City continues to thrive, Rodeo Drive remains a retail force on a global scale. Visitors from around the world continue to make it a 'must see' in our City. We also see the potential investment by LVMH with the proposed Cheval Blanc Hotel," Bosse said.

Bosse concluded her speech by thanking the many people who have supported her along the way. This includes retiring City Manager George Chavez, Assistant City Manager Nancy Hunt-Coffey, who will succeed Chavez, and Ryan Gohlich,

who will serve as one of the new Assistant City Managers.

"So in the remaining months of my term, I will continue to put the safety and health of our community first, champion our local businesses and listen to you. You have my word and my heart Beverly Hills. And as I always say, the best is yet to come," Bosse said.

Candidates Spar at Forum for Supervisor Race

The Sherman Oaks Homeowners Association held a candidate forum on Sept. 22 for the Board of Supervisors District 3 race. The forum was moderated by journalist Jill Stewart.

The 3rd district includes Beverly Hills, West Hollywood, and a large portion of the San Fernando Valley.

The forum consisted of community members sending in questions, which generally focused on homelessness, local control, transportation, and public safety.

The Los Angeles City Council recently passed Ordinance 41.18, which makes it illegal for people to live or camp within 500 feet of a school. The two candidates, Bob Hertzberg and Lindsey Horvath, were asked if the County Supervisor had a role to play in fixing this problem.

Horvath said that she supports local control and that cities should have the ability to pass ordinances they think are best.

"What I think is missing from 41.188 is - what happens to people who are moved from these spaces? Certainly, we want to make sure that we're protecting our public places, we shouldn't let our sidewalks become de facto homeless shelters. We also need to make sure these people get the care and support that they need and so I think that's the piece that is missing and that's the piece that the county can deliver," Horvath said.

Hertzberg supports 41.18 and does not believe children should be exposed to that.

"I would support it throughout the

county working with other jurisdictions and I think it's the right thing to do and a minor inconvenience and yet, nobody has the right to die on the street and my goal is to get people off the streets as fast as possible," Hertzberg said.

Both candidates were asked what they propose to do for resolving daily transit needs for residents.

"Parking, you've got to have more parking in the near terms," Hertzberg said.

The winning Supervisor would be a member of the Metro Board.

"It's about how we move people throughout the region. I think we need to create transit solutions that actually do that. We need to make sure that our bus lines that exist are expanded - that they run on time, that they actually move, and that they get people where they need to go," Horvath said.

The candidates were asked how they would improve the working relationship with the Sheriff and avoid the challenges seen with the recent Sheriff's Department search of supervisor Sheila Kuehl's home.

Hertzberg said he hated the search and that people hire the supervisor to get the job done, not to fight amongst each other.

"At the end of the day, the public wants to be safe. I've been endorsed by every single law enforcement agency that's endorsed. I just got endorsed today by the highway patrol and 10 other groups. Let me tell you, they want to be safe. Cut it out. Stop pointing fingers. Get the job done. Work with whoever the public elects to make things happen, that's my philosophy," Hertzberg said.

Horvath recently sent out a statement prior to the forum saying that the search was likely politically motivated and meant to attack critics and dissenters of the Sheriff.

"I think that what we need is accountability in the sheriff's department, which is why I've been working with Chief [Robert] Luna on ideas for exactly that in our department. How we can work together to make sure that law enforcement has the resources they need to fight violent crime but we also clean up the problems in the department that have been plaguing public trust," Horvath said.

Another question was specifically directed towards Horvath in regard to her vote to defund the West Hollywood Sheriffs.

"The city council did not vote to defund the sheriffs. In fact, the LA Times, which endorsed me, quoted that in their endorsement we didn't vote to defund the sheriffs. We actually have seen crime decrease in the past two months since we passed our vote in June," Horvath said.

Horvath said it is important to invest in public safety as a whole and not ask law enforcement officials to respond to calls for service for which they are not "uniquely trained". She said that is why West Hollywood has also invested in security ambassadors and in building out a comprehensive behavioral crisis response team

That said, the West Hollywood City Council did vote to cut funds from the Sheriff's department.

Hertzberg pointed out how Horvath actually supports Los Angeles District Attorney George Gascon.

"I've done a lot to deal with Criminal Justice Reform but the police organizations - whether it's the sheriff, or the Santa Monica Police Department, or San Fernando, or Beverly Hills, or any other ones, basically have chosen me because they know I act responsibly. There are 700 open positions because of this stupid fight between the supervisors and they won't fund the sheriff. I want to fund those positions so people are safer in their communities," Hertzberg said.

Some controversy arose after the forum due to the candidates being asked about who can compete in women's sports. Specifically, if biological men who identify as women, or transgender women, can compete in women's sports.

"I think that all women, all people who identify as women, should be able to participate in women's sports and Title IX supports women's rights to participate in sports," Horvath said.

Hertzberg declined to give a definitive stance on the topic as he said he does not like to speculate on things he has not done the "homework on."

"'I'm so focused on the details of public safety and homelessness and stuff, you know. If it comes to me I'll do the homework on it. I know it's complex, I know what it means and I just don't like speculating on stuff that I haven't done the homework on," Hertzberg said.

This caused Horvath to later send out a statement condemning Hertzberg's statement.

"I have long stood shoulder to shoulder with our LGBTQ community. And I will continue to affirm and support the entire LGBTQ family, just as I did at the Sherman Oaks Homeowners Association candidate forum," Horvath said in a statement after the forum. "I encourage my opponent to do the same."

Beverly Hills City Hall Lit in Memory of Mahsa Amini

To honor the life and legacy of an Iranian woman murdered in a horrific act of violence, as of last Thursday evening, Beverly Hills City Hall will be illuminated with the message "Justice for Mahsa Amini."

22-year-old Mahsa Amini died earlier this month in the custody of Iran's "morality police" who enforce the strict hijab rules of the country. The rules mandate covered hair and loose-fitting robes for women. It is believed that Amini was taken into custody and severely beaten by the officers – she later fell into a coma and died

"What happened to Mahsa Amini is a disgusting, heinous act that is inhumane and unbearable to comprehend," Mayor Lili Bosse said. "The Beverly Hills City Council strongly condemns this evil, cruel, and barbaric act and strongly supports that all women deserve to live a life without repression, brutal violence and restric-

tions on their basic human rights."

At the City Council meeting on Sept. 20, Bosse opened the meeting with comments followed by a moment of silence and all Councilmembers expressed united outrage.

Many Iranian women are removing their veils in protest of the long standing rules while international human rights organizations are calling for a criminal investigation into her death.

On Oct. 11 the City Council will consider a resolution condemning the government of Iran for the physical beating and death of Mahsa Amini by Iran's morality police.

According to the staff report, the total cost of the event is \$192,900, with \$35,000 going towards talent and \$142,00 going towards Authentic Agency for event management and production services. Other costs includes \$28,000 for production and labor staff, \$2,900 for administrative expenses, \$2,500 for pre-production and CAD surveys, \$12,000 for location costs, including security, \$43,000 for creative and scenic costs, \$7,000 for site production, \$22,500 for agency managemnt fees, and \$25,000 for stage sounds, lights, and rentals.



BHPD Chief Mark Stainbrook on Public Safety

"We are really using

Why did you first want to become a police officer?

I didn't want to become a police officer, I wanted to become a military officer But I was in the reserves at the time and I needed a job. I met with some Vermont State Troopers and they said 'hey, we pay to work on the weekend and in the summer on the boats on Lake Champlain and the snowmobiles in the winter.' I thought that sounded a lot better than the job I had, which was bussing tables. So, I went to the police academy in Vermont and did those things, which was so much fun. When I got in the Marine Corps they [asked if I had] any specialized skills. I said I was a reserve police

officer in Vermont and they said I could be a Military Police [MP]. I liked being a cop so I said I would do that. I think sometimes your career is directed for you by your experiences and what you do.

What made you interested in applying for the Beverly Hills Police Chief position?

It's a unique city and I think the ability to come here as officers' ability on the police chief and have ground to fight crime" the funding to do law enforcement in what I

would consider the 'right way' was very appealing to me. And to have citizen and community support is very appealing. We really should have a model police force, which is what I always wanted to

You spent a lot of your career working for LAPD. Tell us about that.

I started out in the Hollywood division as a probationer. I always wanted to work gangs so I got a chance to work [that] very early on and I did that for about seven years all total in my career. That was very enjoyable. But then I wanted to start changing the department and changing the people around me and I wanted to take on leadership positions. So, I started to promote fairly early and I became a sergeant after four years and

a lieutenant after about seven years. And then I realized I wanted to lead my own department. Working LAPD was great, I hit all the right spots. I went to internal affairs, I was watch commander. I was kind of hitting the right spots to promote and at the time I needed to make a break to go to a smaller department so I could learn how to manage a smaller department. That's when I went to the Harbor police [in San Diego], after 17 years at

The department has been trying to recruit more police officers. How is that going?

It's going well, Beverly Hills is very

attractive because the officers like the community support and the pay is very good. The younger officers are really interested in technology and Beverly Hills is a department that can offer the types of technology that the officers want to use. We have about 15 officers that fly our drones and there are not many departments where you can go be a drone pilot. They love things like that. We're starting to do things like being the transmissions from the drone out to the

officers in the field so they can see it on their camera or computer. It's things like that I think that attract younger officers. Bigger agencies, any bigger organization - getting the technology out to the field and making it work, and making it work right, is more difficult. Smaller agencies are typically more nimble. So, I think there's an appeal there.

It is a very difficult time to become a police officer. Has that affected your recruitment?

Probably to some extent. My understanding is about 10 years ago we were getting 2,000 applicants a year, now it is down to about 400. So, I think nothing is just one thing. What I have always noticed in police work, is when the economy is good - and the economy has been

pretty good the last ten years - people shy away from government jobs because they can make more money in the private sector. But when the economy is rough, they know they can go to the public sector and make a good steady paycheck every two weeks and have benefits. So, that might be part of it. The second thing is with the digitization of everything - it's tough. You do work nights, you work on the weekends. You're away from your family on birthdays, weddings, things like that. People now know they have options where they can work from home, be a digital nomad, Youtube star, or whatever. I'm sure the negative effects of the George Floyd incident, the rioting, and the violence that took place in the anti-police sentiment after that has affected people, or their families don't want them to be a police officer [because] it's too dangerous. We still attract a certain type of person that wants to do public service, that wants to help other people. I think the bottom line is - when you ask people why they want to be a police officer - certainly when you ask me - [it's because] I like helping people. It's pretty cool to get paid to help people.

Did the reputation of the prior Beverly Hills Police Chief Sandra Spagnoli make you reluctant to apply for the

No, I try not to make too many judgments on past leaders. I don't know everything she was dealing with. I don't know the issues there. Being the chief of police is a tough job. You have pressures on you from your employees, your staff, the community, and the City Council - it is highly politicized. I just come in knowing I can try to do the best I can do. For me to be successful, my main job is to make everyone else successful. That's what I try to concentrate on. So, that didn't really have any effect. I certainly appreciate the pressures that other leaders are on no matter what position they are in. You know the mayor is always in a tough position or the city manager. So, that's the burden you bear when you choose those types of positions.

Your first day on the job was the same day as the Jacqueline Avant shooting. Tell us about that.

Obviously because of the Netflix [documentary] "The Black Godfather", it was a very high-profile murder, and it was in Beverly Hills. We didn't initially have a good line on who the suspect was. A lot of the concern was - was it targeted? Was it random? Of course, [there was] a lot of media attention. With anything, you have to slow things down. I think our folks did a great job handling the crime scene and then gathering evidence and information. Luckily, we have good partnerships with other agencies. The city is sort of an island surrounded by mostly LA and West Hollywood. We have those good relationships, so when over in Hollywood they saw something that could be related to that case, they immediately contacted us and we were able to work and put things together. Of course, there was a lot of pressure there. But the main thing is you just feel sad for the victims. You feel bad for the victim's family. This was the kind of crime in my mind that never should have happened. This individual should never have been out of prison. That is something we are going to have to start dealing with as a society. Who, why, and how long do we keep somebody in prison, and if we release them, are we giving them the ability to succeed and integrate back into society? Which I am not seeing right now.

How has the department been tackling the rise in crime?

Luckily, since I have been here we have started seeing a decrease in violent crime and property crime. We are really using technology to bolster and enhance the officers' ability on the ground to fight crime. We are using our 2,000 cameras that are now monitored 24/7. We have a drone that flies 10 hours a day. We have license plate readers literally surrounding the city. They are telling us when criminals and stolen cars [are coming in]. That has helped quite a bit. We are able to interdict a lot of them before they commit the crime. Or, if we know that they are a certain person that has committed a crime here before, we are able to see when they come into the City and stop them before they commit the crime. We are doing a good job at that. A lot of it too is our partnerships with our community and people seeing things and knowing who to call if they see suspicious activity. So, we always rely on the community to help.

What is one thing you want the community to know about public safety?

Public safety starts with you. A lot of the crimes we have is because people don't lock their doors. They leave valuables in a car, they don't lock their car doors. They go on vacation and don't tell their neighbors or use their security systems. A lot of time crime can be stopped by vigilant people, knowing your neighbors, and using those systems you have in your house - locks, lighting, gates, closed windows, [and] security systems to stop crime before it happens. If you do see suspicious activity - because the community is our eyes and ears - call 911, report it to us, and we will go check





BHHS Football Team To Forfeit Friday's Football Game

Beverly High will forfeit Friday's scheduled home Ocean League football game against Leuzinger "because of a lack of healthy available players," coach Marquis Bowling said.

The Normans began the season with 34 players and had 28 in uniform for Friday's 52-0 loss to Morningside, according to Bowling. When the team met for practice Monday, there were 16 players available, Bowling said.

Bowling said he texted Tim Ellis, the Beverly Hills Unified School District's director of district athletics, and Vonzie Paysinger, the school's athletic director, Monday about his decision to forfeit. Ellis and Paysinger were sitting next to Leuzinger athletic director Marlon Mendez at a meeting of South Bay Athletic Association athletic directors when they received Bowling's text, he said.

The sidelined players include five who are in the concussion protocol, Bowling said.

"We're going to err on the side of caution when it comes to anything that remotely resembled a concussion," Bowling said. "It's very possible the guys we have in concussion protocol don't have concussions.

"At the top of our list is kids' safety. That's why we have those guys in concussion protocol because we don't want to put them in unnecessary danger."

The team's concussion protocol includes taking a player's helmet and keeping "them out of activity," Bowling said.

Bowling said he is optimistic the team will be able to play its next scheduled game, Oct. 14 at Hawthorne.

"I'm hoping to get back a good amount of guys that were unavailable to us this week," Bowling said.

This is the first time Beverly High has had to forfeit a football game because of a lack of players. The Normans forfeited three games in 1989 because of a teachers strike.

The Normans trailed 20-0 at the end of the first quarter and 28-0 at halftime Friday night in the Ocean League opener for both teams at El Camino College.

"The effort, the decision-making, the execution, overall everything just didn't come to together," Bowling said.

Bowling said before the game, "If we're going to stand a chance, we're going to have run the ball effectively." Beverly Hills rushed for 38 yards on 25 carries against the Monarchs (3-3), according to statistics posted on the high school sports website Maxpreps.

"We just didn't execute," Bowling said. "The plays were there. We had the opportunities. We just didn't make the right decisions and capitalized on them."

A thigh contusion the previous week limited Oscar Mantville to three yards on five carries after running for 104 and 102 yards the previous two games, Bowling said.

Quarterback Matthew Recupero completed nine of 17 passes for 89 yards with one interception for the Normans (0-6).

"We've got to make better decisions," Bowling said. "When we came out at the second half we abandoned the running game and started throwing the ball. He made some passes but there were a lot of things he left on the field that he could have taken advantage of."

Running back-cornerback Jackson Rosenberg "played the most solid of the group," said Bowling, who also praised the play of defensive end Josh Park for making two quarterback sacks and getting pressure on the quarterback.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.

Contractors are responsible for submitting and having their documents accepted before the closing time set forth in the request for qualifications. NOTE: Pushing the submit button on the electronic submittal system may not be instantaneous; it may take time for the Contractor's documents to upload and transmit before the documents are accepted. It is the Contractor's sole responsibility to ensure their documents are uploaded, transmitted, and arrive in time electronically. The City of Beverly Hills will have no responsibility for documents that do not arrive in a timely manner, no matter what the reason.

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent permitted by law. However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the

end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors may submit prequalification packages during regular working hours on any day that the offices of the CITY are open. Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-appli-

cation for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Public Works Department senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal
