

BHHS Wrestling Coach Formally Terminated

Beverly High Wrestling Coach Ryan Faintich was officially terminated by the Board of Education at its Tuesday meeting after a video surfaced of him shoving a student. Some parents and students have rallied behind Faintich, alleging he was standing up for another student who was being bullied.

Board members Mary Wells, Mandy Stern, and President Noah Margo, were previously served with recall papers, on behalf of a vocal contingent who spoke on behalf of the coach. However, the recall efforts have since been abandoned because the petitioners did not formulate the recall paperwork properly.

Proponents had to collect approximately 4,200 valid signatures (20% of the approximate 21,000 registered voters in Beverly Hills) to qualify the recall for the ballot and also comply with a number of formalities for the petition to have been accepted.

Planning Commission to Not Pursue New Hedge Height Guidelines

At last Thursday's meeting the Planning Commission decided not to pursue changes to the rules regarding wall, fence, and hedge height requirements that would have focused on hedge heights in side and front yards.

"It is not necessary in our community. We do live in a relatively safe place," Commissioner Peter Ostroff said.

In Oct. City Council approved a recommendation from the Planning Commission to amend the Beverly Hills Municipal Code to increase the allowed height of walls, fences, and hedges in the rear yard and alley-facing side yard of single-family residential properties in the Central Area of the city.

The City regulates the allowable maximum height for walls, fences, and hedges in residential zones. Generally, the heights are regulated based on the zone of a property, as well as the location of a wall, fence or hedge on a property.

The City has recently received an influx of inquiries regarding increasing allowable wall, fence, and hedge heights due to security concerns, particularly along rear alleys.

The commission believed that there was not much of a need to change the Beverly Hills Municipal Code to increase the allowed height of walls, fences, and hedges in side and front yards.

"Large fences in many instances are a problem and not a solution. It is a security thing because you do not know what is hiding behind it and a police vehicle driving can't really see what is there, but if it is open they can. That is a good thing in my opinion. I am not persuaded that any of these rules need to be changed," Ostroff said.

That said, the commission did agree

to pursue a discussion regarding possible changes to the allowable height for camera poles on residential properties.

Currently, residents are allowed have a camera pole between 18" to depending on which area of the city the property is located and where in the front yard the pole is proposed. The

commission expressed a desire to pursue possible changes to allow for these poles to be taller than existing regulations.

The Commission will consider allowing for increased height for pole-mounted security cameras, at a future meeting.

BHEF Dedicates Bench to Leah Newman

The Beverly Hills Education Foundation (BHEF) held a bench dedication ceremony on Jan. 1 in honor of Leah Stephanie Newman, a 2006 Beverly High graduate who tragically passed away giving birth. The bench is located at Beverly High in the new B1-B2 Court-vard.

The project applicant has put in a request for a Development Plan Review to construct a new six-unit condominium building. The project site is a 8,161 square-foot triangular lot located in the R-4 Multiple Residential Zone.

The building is expected to contain six units. The residential structure is proposed at a height of 55' and includes 20 parking spaces in a garage accessed from North Oakhurst Drive, an outdoor living space on the roof, and one unit for affordable rentals.

The applicant has put in a variance request to deviate from the required rear yard setback that consists of a reduction along the south side property line, from the required 15' setback to the proposed 5' setback.

A variance has also been requested to deviate from the parking standards to allow for compact parking stalls to be used to satisfy parking requirements. The request consists of providing 10 of the 20 required parking stalls in a compact configuration in-lieu of providing all parking spaces with standard dimensions.

The commission is expected to hold the public hearing and either approve the project or possibly send it back for revisions. The commission may also deny the project.

'MADE' Proposes Weekend Event in Beverly Hills

At last Tuesday's meeting the Arts and Culture Commission discussed a proposal from 'MADE' to possibly hold a weekend of events in May.

The project is currently in the proposal phase and is called MADE in Beverly Hills. The organization is called MADE, which stands for modernism, architecture, design, experiences. They're proposing a weekend of specialty events in the same spirit of Modernism Week in Palm Springs, which is an 18 year old festival that the same organizers throw annually. The proposed event is expected to take place from May 4 through 7.

The organizers intend to create a weekend celebration and education of art, architecture, landscapes, and community aspects of Beverly Hills. It is a collection of tours that will be both residential and of lectures, films, and movies. They are also trying to incorporate local businesses to be able to participate at night, which would be called MADE in Beverly Hills at Night or After Dark. They anticipate about 6,000 tickets being sold.

The weekend will consist of both free events as well as paid activity events. Residents will be able to purchase tickets two weeks in advance before they go on sale for the general public. Residents will also get a discount of 25% for the tickets that they purchased.

MADE is a non-profit focused on the intent to foster and nurture the appreciation of architecture and design, as well as encourage education and preservation. The Palm Springs event draws 100,000 attendees and is an 11-day celebration. Its mission is to give back. They have a scholarship program that is for students that are studying design and architecture.

Some things the event will consist of include opening night parties on Thursday night, and a Saturday evening party that will happen in a different location. There is a featured home that's yet to be announced for tours inside that residence. There will be a tour at the Beverly Hills Hotel, as well as a chili cookoff at the farmers market on Sunday. A tour of the chocolate factory will also take place, this is synonymous with the "I Love Lucy" chocolate episode. The organizers hope to engage with the business

The Wallis will be presenting an evening of chamber music with inaugural Grauman Fellow Artem Diaz Kolesov Fominyx, violin, on Saturday, Feb. 4. Joined by Evelyn Lee, piano, Kolesov performs Violin Sonatas No. 1 ("Regensonate"), 2 ("Meistersinger"), and 3 by Brahms.

Kolesov Fominyx, whose Fellowship began on Sept. 28, 2022, was described by the Chicago Tribune as "a violinist of

fine promise." Born in Maloyaroslavetz, Russia, he won international competitions in Tallin, Estonia, and Freiburg, Germany, among others, and performed with the Saint Petersburg

Philharmonic at age fifteen.

Violinist Artem Diaz Kolesov Fominyx's performance with the Saint Petersburg Philharmonic led to a full scholarship to study with Philippe Djokic at Dalhousie University in Halifax, where he won second prize in the National Music Competition in both solo and chamber categories and gave performances across Canada. When studying with Almita Vamos in Chicago, he performed Brahms' Violin Concerto in Chicago Symphony Hall. As a former member of the Yas Quartet, he was a prize winner at the Schoenfeld International Competition in 2016 and a guest artist at the Colorado College Music Festival. Among his other awards are CCPA Concerto Competition Winner; winner of the Symphony Nova Scotia Apprenticeship competition; second prize at Canadian National Music Festival (Solo and Chamber); outstanding young artist award, St. Petersburg, Russia, and first prize at the Freiburg International Violin Competition. He received his Master of Music in 2022 at the University of Southern California and is currently working on his Doctorate of Music at USC while studying with celebrated violinist Bing Wang.

Evelyn Lee, pianist, is a collaborative artist, and music educator based in the Greater Los Angeles area. As a collaborator and soloist, she performed at various venues throughout the United States

You started your career in municipal government as a librarian in the City of Glendale. Tell us about that.

I started working in my childhood branch library in Glendale shelving books. I worked my way up to a variety of different positions in the library system over there. I did a few years working in the city's information technology department and then came back to run the Glendale Library System.

You previously served as Assistant City Manager under recently retired City Manager George Chavez. What advice has he given you since it was announced that you would be taking over?

It can be a very challenging position. You could work 24 hours a day and still not finish all of the work there is to be also be mindful of the done. His advice was basics. Maintenance is to just make sure that I take a little time for my family and take a little time for myself.



Someone will respond and engage with that individual to make sure they're all right and offer services.



What have you learned from other city managers you have worked for?

I think from George, I learned a lot of things. He's a wonderful translator of very technical information. I also learned from George to have some patience. Sometimes you need to act and you need to act aggressively. Sometimes you need to just pause and be thoughtful. George was able to do both of those things, and so I learned from him the importance of patience, occasionally taking a pause, and thinking through issues. Mahdi Aluzri was the city manager before that, he was so smart and taught me a lot about the community, taught me a lot about how to work with the council, and to work with the community to build consensus and get things done. I've had really great city managers here that I have worked under, and they've taught me a great deal.

Tell us about your family.

I am married [to my husband Jon Coffey] and we have two children. My daughter [Julia Coffey] is 18. She just started UCLA this year. My son [Sean Coffey] is 16 and is currently at a tennis academy in Florida. He's a major tennis player and does online schooling. He's doing great. I grew up in California and my dad lives in Glendale. So, I see him quite frequently. We [also] have a dog named Sophie.

One year from now, what would you have liked to accomplish?

We have a number of initiatives that are underway right now, and I think those are all important and need to be completed. For example, some of our water

pipes that run under Coldwater Canyon are decades and decades old. We want to make sure that we not only have water reliability, but we don't have major outages. We need to replace those pipes and it will have an impact on the community, a pretty substantial one that is very important for the long term benefit. There's a lot of projects like that.

I think a year from now I'd like to see a really cohesive plan for managing all of the development that'll be happening in the city moving forward so that we minimize the impact on the community as much as we can. [I would like to] continue to push forward with public safety with phase two of the Real Time Watch Center. We have some initiatives with the fire department having the Mobile Stroke Unit on site. So, not only stopping crime, stopping fires, but also preventing them before they occur. Initiatives that will benefit the health and welfare of the community. We're going to be negotiating the new Joint Powers Agreement with the school district this year. As part of that, we've had a lot of conversations with the schools about really focusing on early childhood development. [I hope to have] a plan in place a year from now for preschool, working hand in hand with the school district on developing maybe an early childhood development center for our youngsters. At the end of the day, I want to try to also be mindful of the basics. Maintenance is so important and it's something that's very easy to ignore. So, really maintaining our roads, maintaining our sidewalks, just basic things like that can prevent trips and falls, and degradation of our streets. Maintaining what we have is very important.

Looking Beyond Luncheon Co-Chair

Looking Beyond is a nonprofit organization dedicated to promoting awareness and enriching the lives of children and young adults with special needs. They support various organizations, programs and services through events and fundraising opportunities.

You are the co-chair of Looking Beyond. Tell us about that.

Looking Beyond is a not-for-profit charity that's been around for 23 years now. We have a two-part mission. One is to fundraise for organizations on the ground that are working with disabled young adults and children. The second part is to bring awareness to the community that people with disabilities do live full lives. We're a 100% volunteer-based organization. Almost all of the money we raise goes directly to helping individuals with special needs. Last year, we raised over \$500,000 and distributed that to more than 30 charities and organizations, and most of them are in the local area.

Tell us about the luncheon you are hosting.

We have an annual fundraising event we do. Most of the time it's a luncheon. This year, we're hosting it on Feb. 8 at the Beverly Hills Hotel and it includes a silent auction and raffle. For every event, we honor a person who has had a disability since they were young. They give an aspiring speech and give attention to how they lived a full and interesting life. This year our special presenter for Our Soaring Spirit award is Halle Berry, who is an Academy Award winning actor. My co-chair for the event is Shilla Hekmat.

Tell us about some opportunities Looking Beyond has created for special needs children.

The main one is fundraising for organizations that do that kind of work. One of the things that we are excited about moving forward - it is not set in stone yet but it's looking pretty likely that we're going to be donated a billboard that'll help promote our cause. I think the presentation of Our Spirit Award helps people who are in our audience gain acceptance and understanding of what it is to live with a disability and how it does not hold somebody back.

What made you want to join the committee?

I've only actually been part of the organization for a couple of years, but I've always been really impressed by the work that they do. The cause of disability has always been important to me. My kids went to Santa Monica where they have a lot of special needs kids in the education system and I thought that enhanced the knowledge of my own children who are not living with a disability. Also, my friends who have kids with special needs, whether it's autism or physical disabilities - I see how important it is to them. In terms of recipients and disbursement from last year, we

have given to some organizations that are well known. such as Children's Hospital LA and Health Foundation, to much smaller organizations that are not able to do that much fundraising on their own, such as Help Group and No Limits Theater.

What do you hope the luncheon accomplishes?

a lot of money. We're working hard to solicit sponsors and donors. I'm looking forward to having a really special presentation of Our Soaring Spirit honoree. His name is Jacob Smith. One of the things that he said that I really loved was - it was asked, 'aren't you scared?' He said 'after everything I've been through I'm not scared about a few broken bones. I'd rather keep doing what I love.'
