

Westfield Century City Requests Metro to Not Link Mall to Subway

Unibail-Rodamco-Westfield, the luxury mall owner, has requested L.A. Metro not construct an underground entrance from the Century City-Constellation station to its Westfield Century City mall, according to CoStar news. The Century City-Constellation station is the next stop after Wilshire/Rodeo, heading westbound.

Unibail-Rodamco-Westfield said it wants to avoid disruptive construction at the site as it attempts to sell off its U.S. properties. Metro is currently constructing its Purple Line extension with stops in Beverly Hills and Century City, ahead of the 2028 Olympics.

Unibail previously announced it wanted to sell all 24 of its U.S. properties by the end of the year, which is valued at about \$13 billion.

The subway tunnel will run under Beverly High.

Litigation against Metro from BHU-SD began in 2012 when the district filed suit to block the Westside subway route.

The District received a judgment of approximately \$1 million in the Metro (MTA) case after spending millions in legal fees. BHUSD demanded \$15 million and Metro offered \$1.2 million. The jury came in slightly less than Metro's final offer.

"As a developer of mixed-use destinations committed to the economic, social, and environmental vitality of the communities we serve, we strongly support public transportation projects. In reviewing plans for an underground Metro entrance and tunnel at Westfield Century City, we determined that an alternate entrance at the intersection of Constellation Boulevard and Avenue of the Stars would be just as easily accessible by riders and would eliminate the need for disruptive construction at our center," Unibail-Rodamco-Westfield Spokesperson Molly Morse said.

Traffic and Parking Commission to Discuss Proposed Locations for New Pedestrian Crossings

The Traffic and Parking Commission is expected to provide feedback on a list of possible future pedestrian crossings citywide and the evaluation criteria for prioritizing locations, at their Thursday meeting.

One of the primary goals of the Complete Streets Plan is to make walking a more convenient and safer option. The Action Plan recommends exploring opportunities to expand pedestrian infrastructure.

The City is actively working on efforts to improve walkability and safety in preparation for the opening of the Purple Line stations at Wilshire/La Cienega in 2024 and Wilshire/Rodeo in 2025, as the number of people walking in Beverly Hills is expected to increase by a substantial amount.

In 2020, the City began replacing existing marked crosswalks on all street classifications with higher-visibility continental crosswalks. Continental crosswalks are longitudinal stripes designated where to walk across the road.

All crosswalks are scheduled to be converted to the continental style by next year. Construction is also starting soon on five crosswalk projects funded in part through a Metro grant from 2015.

These projects include enhancement of the following three existing crosswalks: Robertson Boulevard/Chalmers Drive, Wilshire Boulevard/South Palm Drive, and the 200 block of South Beverly Drive, and two new midblock crosswalks at the 400 block of North Bedford and 400 block of North Camden.

When construction is completed, all marked crosswalks on collector or arterial streets, which is a road that can carry a large volume of local traffic at a generally high speed, will either have some level of traffic control or include added visibility enhancements, such as flashing beacons. A collector road is a low-to-moderate-capacity road intended to move traffic from local streets to arterial roads.

The purpose of this project is to identify locations on arterial and collector streets where existing spacing between controlled crosswalks is so long that it acts as a deterrent or obstacle for pedestrians.

City staff is expected to propose a da-

ta-driven approach that will identify a prioritized list of possible future crosswalk projects that is intended to improve safety and pedestrian access to community services.

The commission is expected to provide feedback on the list of proposed locations for new pedestrian crossings citywide. City staff will then revise the evaluation criteria and return with an updated list of ranked crossings prior to beginning conceptual design for the top ranking projects.

Planning Commission Approves 457 North Oakhurst Drive Project

The Planning Commission approved a project located at 457 North Oakhurst Drive, at their Jan. 26 meeting.

The project requested to reinstate previously approved entitlements for the construction of a new five-story, six-unit condominium building. The project site is an 8,161-square-foot triangular lot that is currently developed with a two-story duplex. Parking for the project would be provided within a single-level parking garage for 20 vehicles.

On May 28, 2020, the Planning Commission approved a Development Plan Review to allow construction of the new condominium building. As part of the approval, the project expired within two years unless exercised by obtaining a building permit for the project or applying for a time extension.

On March 30, 2021, the applicant submitted complete construction documents for a building plan check review to obtain a building permit. During this time, building code issues resulted in the applicant electing to remove the rooftop bathrooms from the project and additional corrections resulted in the removal of one parking space from the basement garage to accommodate an additional van-accessible parking space to make the project ADA compliant. The applicant was originally providing 21 parking spaces within the basement garage.

As the applicant was finalizing project corrections, the entitlements for the project expired, as the applicant was unable to complete building plan check prior to the expiration of the entitlements on May 20, 2022.

Subsequently, the applicant submitted a new development plan review to reinstate the previous approvals for the project. The project remains similar to the project that was originally approved in 2020, with minor changes. However, because these applications were filed in 2022, this project is now subject to the replacement unit requirements in the Housing Crisis Act of 2019 and the City's inclusionary housing requirements, which did not apply at the original approval date. As a result, the applicant is now providing one affordable unit for rental to low income households to comply with these requirements.

sioner Gary Ross said.

Traffic and Parking Commission to Discuss Beverly/Cañon/Lomitas Intersection Improvements

The Traffic and Parking Commission is expected to discuss conceptual design options for infrastructure improvements at the Beverly/Cañon/Lomitas intersection.

At the May 5, 2022 Traffic and Parking Commission meeting, city staff provided an introduction to the traffic issues observed at the intersection and discussed an evaluation being conducted by engineering design firm, GHD, Inc.

At the Sept. 1, 2022 meeting, staff presented the results of a safety review and revealed this intersection has experienced a low record of reported collisions, with a total of 23 injury collisions between 2014-2020.

Video analysis of the intersection found that there are conflicts between

road users or narrowly avoided collisions occurring all day. The design is intended to improve safety and accessibility for pedestrians.

Six conceptual design options have been prepared for consideration. This includes raised midblock crosswalks, raised midblock crosswalks and turn pockets, intersection crosswalks, intersection crosswalks and turn pockets, roundabout, or no change.

A traffic signal is not recommended at this intersection due to projected operational delay involved with signalizing the six approaches and multiple turning movements. Curb extensions are also not recommended because curb radii are not the same at all approaches, which results in sight distance issues.

The Traffic and Parking Commission is expected to provide feedback on the six conceptual design options outlined above, including any recommendation to the City Council on a preferred alternative.

Staff expects to present the options and any recommendation for City Coun-

cil consideration at the March 21, 2023 Study Session.

City Council Oks LA Marathon Three Year Contract

At last Tuesday's Study Session the City Council approved a request from the Los Angeles Marathon for special event street closures over the next three years until 2025.

The annual Los Angeles Marathon "Stadium to the Stars" is scheduled for Sunday, March 19. The 26 mile race route spans through Downtown Los Angeles, Little Tokyo, West Hollywood, Beverly Hills and ends at Avenue of the Stars. This year's route will continue to include Rodeo Drive. The route is intended to allow participants to enjoy an interactive experience close to hotels, transportation and shopping and dining areas.

The LA Marathon is requesting to take place on Sunday, March 19, with street closures in the City from 5:00 am - 1:00 pm. The street closures will include portions of Doheny Drive, Burton Way, South Santa Monica Boulevard, Rodeo Drive, Wilshire Boulevard, and North Santa Monica Boulevard. While the finish line is in Century City, traffic detours on South Santa Monica Boulevard at

The Project involves amendments to the City's General Plan Housing Element as adopted on October 12, 2021 for the planning period from 2021 to 2029. No physical development nor construction is currently proposed as part of the Project. The Housing Element is a planning document that contains programs and policies to guide housing development in the City. The Housing Element includes the following topics: analysis of the City's demographic characteristics and housing needs; evaluation of resources and opportunities available to address housing needs; analysis of potential constraints to meeting the City's housing needs; a review of the City's accomplishments during the previous planning period; and updated policies and programs intended to address the City's housing needs for the period through 2029. Additionally, the Housing Element discusses how the City's land use and zoning regulations and programs will accommodate the City's Regional Housing Needs Assessment (RHNA), which is the number of housing units expected to be needed for the next planning period (2021-2029), and includes housing at various levels of affordability. The Project area covers the entire City of Beverly Hills, since the Housing Element addresses housing conditions throughout the City. The City Council will also review an addendum to the Initial Study/Mitigated Negative Declaration prepared for the Project. The revised Housing Element document will be available on January 27, 2023 at: www.beverlyhills.org/ housingelementupdate.

The revisions to the Housing Element have been made in response to the comments provided in letters from the state Housing and Community Development Department (HCD), and primarily consist of changes to the policies and programs in the Housing Plan, such as the addition of greater details and specific timelines, the addition of a more extensive section on Affirmatively Furthering Fair Housing (AFFH), and changes to the sites inventory to add further detail and remove possible sites to accommodate housing. The Planning Commission has reviewed the amendments to the Housing Element document at their August 25, 2022 regular meeting, and the City Council was informed of the revisions as a C Item at their September 20, 2022 meeting.

ENVIRONMENTAL REVIEW

The City of Beverly Hills has previously adopted a Mitigated Negative Declaration (MND) for the updates to the Housing Element of the General Plan (Project). The City of Beverly Hills was the lead agency, pursuant to the California Environmental Quality Act (CEQA), and was responsible for the preparation of the MND and related initial study. The previously adopted MND document is available at <u>www.beverlyhills.org/environmental</u>. If a digital copy cannot be obtained by an interested party, please contact the staff listed in this notice and alternate arrangements will be made.

The previously adopted MND indicated that the Project would not result in significant impacts to Agricultural and Forestry Resources, and Mineral Resources, and less than significant impacts, with certain mitigations, related to Aesthetics, Air Quality, Biological Resources, Cultural Resources, Energy, Geology and Soils, Greenhouse Gas Emissions, Hazards and Hazardous Materials, Hydrology and Water Quality, Land Use and Planning, Noise, Population and Housing, Transportation/Traffic, Public Services, Recreation, Tribal

Cultural Resources, Utilities and Service Systems, and Wildfire. An addendum to the previously adopted MND for the revisions to the adopted Housing Element document has been prepared, pursuant to California Code of Regulations, Title 14, §15164. A copy of the addendum will be available as part of the agenda materials for this meeting date, on www.beverlyhills.org/citycouncilmeetings, at least 72 hours before the meeting. The Project description and location are described above, and the adoption of amendments includes changes that are limited to minor technical revisions and the addition of information. The primary changes to the adopted Housing Element that will be evaluated in the addendum include: changes to the policies and programs in the Housing Plan, such as the addition of greater details and specific timelines, the addition of a more extensive section on Affirmatively Furthering Fair Housing (AFFH), and changes to the sites inventory to add further detail and remove possible sites to accommodate housing. Since these changes consist of minor technical changes and the addition of information that will not result in significant impacts to the areas of study in the adopted MND, and none of the conditions in California Code of Regulations, Title 14, §15162 have occurred, the City Council will consider the adoption of the addendum to the previously adopted MND.

Planning Commission Approves L'Ermitage Hotel Project

At last Thursday's meeting the Planning Commission approved a request for a renewal of a Conditional Use Permit, Development Plan Review, and Extended Hours Permit allowing for the continued operation of a hotel restaurant with open air dining and hotel rooftop uses with extended hours for the L'Ermitage Hotel located at 9291 Burton Way.

Specifically, the request sought to continue the operation of the hotel restaurant that is open to the public; continue the operation of open air dining associated with the restaurant that would be served by existing parking supply and valet operations; and, continue the use of the rooftop area for special events.

The approvals granted by this resolution would have expired on Jan. 23, 2022, unless renewed by the Planning Commission. On Dec. 17, 2021, Spencer Kallick, representative for the hotel, submitted an application to renew the permits. At that time, the request included amendments to conditions that would have modified operational requirements that have been previously imposed by the Commission. However, these amendments are no longer part of the request.

The previously proposed amendments include: increasing the number of tables and chairs within the open air dining area along Burton Way, from seven tables and 20 chairs to 10 tables and 26 chairs; allow for amplified sound from inside the restaurant to the open air dining area; increase the time that all patrons must exit the dining area, from 10:30 P.M. to 11:00 P.M.; remove the requirement to pick-up trash and debris on the south side of Burton Way, across the street from the hotel; and, to reduce the penalties that are currently imposed for violations of the conditions of approval.

These amendments will be included as part of a future request that would include physical improvements at the project site that require review by the Planning Commission, at a future meeting.

Informational Meeting on Upcoming City Labor **Negotiations Set for Feb. 9**

As the City prepares to commence negotiations with its six non-sworn employee bargaining groups, the public is invited to attend a community meeting detailing the negotiation process on Thursday, Feb. 9, beginning at 6:30 p.m. in the Council Chambers.

The independent labor negotiator and City staff will provide a general overview of negotiations including future opportunities for public input, timelines and the process for City Council consideration and approval.

In 2014, the City Council adopted a Civic Openness in Negotiations "COIN" ordinance in order to provide additional impartiality and transparency to the collective bargaining process. The meeting of Feb. 9 is the initial step in that process. The first public meeting seeking specific community input will be held at the City Council meeting of Feb. 21

In accordance with state law, Beverly Hills participates in labor negotiations with its employee associations. The results of the negotiations process are written agreements or contracts reached between the City and the City employee associations. These agreements are referred to as a Memorandum of Understanding (MOU).

New Software to Tackle **Absenteeism Possibly Coming to BHUSD**

The Board of Education tabled an agenda item at their Jan. 17 meeting that would have approved a software intended to tackle absenteeism, and will discuss it at a future meeting.

Attention2Attendance is a software and service solution that if implemented would be for the entire district. According to the staff report, this software is proven to improve K-12 student attendance and help with the growing chronic absenteeism rate that has been rising since the return of school related COVID closures.

"I was unaware that there was a problem and I thought that we should study this a little bit more before we approve it," Board member Rachelle Marcus said.

The software will give the district and the schools :

Attendance analysis and reporting, timely reporting by school, grade level, absence type, absence ranges, subgroups and more, comparative analysis, actionable data, reports dashboard, and selfserve reports.

The contract is for three years, starting with the 2022-2023 school year. The cost is \$52,700 per year.

Smiles Through Art Founder Sharon Persovski

Smiles Through Art was created by designer and former Beverly Hills Architecture Commissioner Sharon Persovski with the purpose of helping children, adolescents, and adults with health conditions and special needs. Its mission is to find ways to express thoughts creatively and use art as a tool in achieving healing.

Tell us about Smiles Through Art.

I design art programs for children and young adults that have health conditions or that are located in underserved communities. I design the programs depending on the audience and the needs of the group. They create art and use it as a healing tool. Once they do the artwork, the artwork gets implemented in healthcare offices, institutions, hospitals, or sometimes they take it with them. It depends on the project. This organization is also international. We have programs in Mexico, we have done programs in Mexico City. I always have the intent of helping people through

artwork and how to express [themselves]. That's in general what the organization is about.

to create a nonprofit *it very special for me*" Beverly Hills where specifically tailored to people with special needs?

I've always been very involved with the arts. I was a former Architectural Commissioner as well. A lot of the projects that I have done around the world have been very successful and I wanted to use my talent to help other people. I didn't know how to do it. I started to get into the idea of - if I would start gathering groups and expressing or teaching them my skills, that would be something that would be helpful for them. This is how the idea was born. For many years I was doing programs with arts and education, and I was involved in an arts program at BHU-SD that I managed for many years. That made me realize that art is very important in the lives of people because it helps them express what they sometimes cannot express with words. I started realizing that if I use those talents that I already have and try to help the people that I want, then I could create an organization. I thought that this is more than an organization that is a service to the community and to the people. To create some helping and some healing, it would be something that would be useful for humanity.

You are a former Beverly Hills Architecture Commissioner. Tell us about that.

I worked for many years in the design industry for different transnational firms in Mexico and the U.S with a lot of projects that were around the world, like in China, Singapore, and in Japan. I already had good experiences working with architects and designers. I was starting to get involved with things from the city. I was already involved with things from

> government work. Then I started realizing that there were a couple of commissions that dealt with my area of expertise, which would be architecture, design, planning, and arts. There were four commissions that I could have fit in and there was an opening on the Architectural Commission. I started reading the description and saw that I fit in from the experience that I had in the past. Being an Architectural Commissioner has been a wonderful experience. I really loved learning about how local government works. Being a designer, I never thought that I was going to be able to do something in government. I realized that being an architectural com-



missioner was extremely important in order to be able to prepare a lot of our history in regards to architecture and design.

Tell us about some of the ongoing art programs.

The first program that I did was with BHUSD many years ago helping our children. That was how I started the organization. It was around 2013. This project was talking about butterflies and metamorphoses because it was helping children with cancer. We saw that the concept of metamorphosis is like the illness, and how it can be transformed. If it gets healing, then it can be turned into a beautiful butterfly. The children designed these little boxes with different butterflies and then those butterflies were implemented in a wall in an institution.

The second project that I did was in Mexico City for an organization that was in a very underserved area. I worked with 150 children, designing the concept of low-income communities. Everything that they were doing was about the concept of blooming flowers. They created beautiful art collections, paintings, and artwork.

During the pandemic, with the Mexican consulate of Los Angeles, we had to think of a way to do it virtually. With the Mexican consulate, we did a program that would target all of the Latin communities that reside in L.A. It was for Cinco de Mayo and they asked me to create some kind of artwork. I decided to do a fabric art collage using the colors of the Mexican flag. It was very interesting because

able to work with them next to me. I was still able to communicate with the people. Especially during the pandemic, [people] could use an art program to help with mental health because everybody was inside and indoors.

even though I was not

The last project I worked on was in partnership with an organization called ETTA. This is an organization in Los Angeles County that primarily is focused on helping people with intellectual

disabilities or different health conditions that are more on the severe side. They asked me to create an art program working with them. This is a Jewish organization, so it was for the holiday Tu BiShvat, which is a holiday that focuses on the relationship with nature and the birth of trees. So, I decided to create a project that is called the 'Tree of Life'. A lot of the conditions of these people are really limited. For instance, some of them cannot move their arms, some of them, their motor skills are very limited. So, the projects are interesting because you really have to target what are the needs of the project or the people who are doing it. You have to really adapt to the needs of the group. You see their smiles and just see that they're really enjoying it - that's what makes it very special for me.

Another project that I'm working on is in Tijuana. There is a hospital that is like a children's hospital. I will be working with them in the next couple of weeks.

What do you hope your organization accomplishes?

My ultimate goal is to teach them art skills and create some healing for them. Without even noticing, you are expressing your emotions and creating art. That is the goal. It's a healing process. The goal is to do healing through the arts. I also want to give them a little bit of happiness. When I see the name of my organization 'Smiles Through Art', it really describes the goal.

COVERSTORY CONCERNS RAISED OVER NEW PARKING PERMIT SYSTEM

Residents Cite Lack of Communication and Registration Glitches

By Danielle Berjikian

Several residents voiced their frustration with the recent changes to the parking permit system at last Tuesday's City Council meeting, after fewer than 2,000 residents have renewed their permits. The parking permit program relaunched with the intent of relying primarily on vehicle license plates, also known as "Permit by Plate". The

Police Department said they will utilize license plate recognition technology to further expand consistent coverage and maintain visibility within neighborhoods. Residents will now be given the option to register their license plates should they choose not to utilize the current placard system, however, they can no longer use hang tags for overnight parking. The purpose of this change in the system

automated DMV verification, integrated technologies, and improved parking management efficiency.

Councilmembers and Commissioners receive a class one permit, allowing them to park in any permit zone.

Common concerns voiced at the meeting include, application and account difficulty, logistical changes, the renewal process, and utilizing guest parking.

"This has been a disaster. No one knows when the new system starts. No one got letters to this effect. It has led to massive frustration among the residents. There are more than 400 homes just in the southwest homeowners association area,'

Southwest Homeowners Association President Ken Goldman said.

Due to the fact that so many residents have had issues registering their license plates, the Police Department said that they will extend the registration deadline from Feb. 1 to March 1. They also said they will not begin issuing tickets right away, and rely more on warnings.

OBITUARIES Marlene Zimmerman

1933-2023 Marlene Sudmin Zimmerman, age 89, of Beverly Hills, California, passed away on January 15, 2023. Marlene was born in Los Angeles in 1933 to Lillian (Strauss) and Morris Sudmin. She attended Beverly Hills High School (1950) and UCLA (1966)

An acclaimed artist, Marlene showed her work in exhibits from Los Angeles to New York to Zagreb, including at the Skirball Museum, the Downey Museum of Art, the San Bernardino County Art Museum, the Westwood Center of the Arts, the LA Craft and Folk Art Museum, the Museum of Tolerance, and the Museum of Women in the Arts. She has works in the permanent collection at the Skirball and at the Clinton Presidential Library. In 1999, a ceramic menorah that she created as a tribute to the historic Breed Street Shul in Los Angeles was selected by Hillary Clinton to exhibit at the White House and led to an invitation to celebrate the holidays in Washington. The Clintons used the menorah in an Oval Office Hanukkah celebration, and the photo of that menorah lighting is shared each year by the Clintons to welcome in the holiday. The National Womens' Political Caucus published posters of two portraits she made of prominent women from American history.

Her art made her a constant presence in her hometown. Her portrait of major historical figures, *Their Presence was Felt*, was featured at the Beverly Hills public library for decades. Her painting of the Beverly Hills schools was used as the cover of the district directory for many years. She designed her 1980 work Celebration of the Peoples of Los Angeles specifically to highlight the diversity of her city, through small portraits of people from every national or ethnic group she could identify. She was a founding artist at the Beverly Hills Art Show (originally the Affaire in the Gardens), where her work was represented at every show, twice a year for 49 years.

She was recognized with many awards over her career, including winning first place out of 3,000 entries in the national Ladies Home Journal Grandma Moses Competition (1974), and being honored at the Malibu Art Festival, the LA Street Scene, the Beverly Hills Art Show and the Santa Monica City Art Show. She earned the "Mayor's Purchase Award" at the Beverly Hills Art Show many times. In 2002, Beverly Hills High School named her to its Alumni Hall of Fame.

Marlene was predeceased by Fred, her husband of 70 years (see issue #1204), and is survived by children Shelley Galant (Jerome), Bonnie Zimmerman, Cindy Dubin (Mark), and David Zimmerman (Liz); and grandchildren Zachary Galant (Hilary), Sophie Galant, Jake Galant, Anya Zimmerman-Smith, Alex Dubin, Josh Dubin, Ellie Dubin, Ryan Dubin, Julia Zimmerman, Drew Zimmerman and Charlie Zimmerman.

LOS ANGELES MEASURE ULA PASSED NEW TRANSFER TAX ON LOS ANGELES RESIDENTIAL & COMMERCIAL REAL PROPERTY

DOES NOT APPLY TO PROPERTIES IN BEVERLY HILLS

Measure ULA or 'Mansion Tax' imposes a new 'Homelessness and Housing solutions Tax' on transfers of residential and commercial real estate property in the city of Los Angeles valued in excess of \$5 million.

Under the measure, sales of residential and commercial real property valued at over \$5 million but less than \$10 million are subject to an additional tax at the rate of 4%, while sales of properties valued at \$10 million or more are subject to an additional tax at the rate of 5.5%.

The new tax applies to the entirety of the sale value, not solely the amount in excess of the \$5 million and \$10 million thresholds, and regardless of whether the property is sold at a gain or a loss. The tax will apply to property sales occurring on or after April 1, 2023.

No bid will be accepted from a Contractor that has failed to comply with these requirements. If two or more business entities submit a bid as part of a Joint Venture, or expect to submit a bid as part of a Joint Venture, each entity within the Joint Venture must be separately qualified to bid. The CITY will use these documents as the basis of rating Contractors with respect to whether each Contractor is qualified to bid on the Project, and reserves the right to check other sources available. The CITY's decision will be based on objective evaluation criteria.

The CITY reserves the right to adjust, increase, limit, suspend or rescind the prequalification rating based on subsequently learned information. Contractors whose rating changes sufficiently to disqualify them will be notified, and given an opportunity for a hearing consistent with the hearing procedures described below for appealing a prequalification rating.

While it is the intent of the prequalification questionnaire and documents required therewith to assist the CITY in determining bidder responsibility prior to bid and to aid the CITY in selecting the lowest responsible bidder, neither the fact of prequalification, nor any prequalification rating, will preclude the CITY from a post-bid consideration and determination of whether a bidder has the quality, fitness, capacity and experience to satisfactorily perform the proposed work, and has demonstrated the requisite trustworthiness.

All qualifications submittals are required to be submit electronically via PlanetBids. The electronic submittal system will close exactly at the date and time set forth in this request for qualifications.

Any questions regarding the questionnaire and qualification package should be submitted via PlanetBids by 2:00PM, February 10, 2023. Questions sent via email or over the phone; with the exception of those related to accessing or using PlanetBids, will not be answered.

Contractors are responsible for submitting and having their documents accepted before the closing time set forth in the request for qualifications. **NOTE**: Pushing the submit button on the electronic submittal system may not be instantaneous; it may take time for the Contractor's documents to upload and transmit before the documents are accepted. It is the Contractor's sole responsibility to ensure their documents are uploaded, transmitted, and arrive in time electronically. The City of Beverly Hills will have no responsibility for documents that do not arrive in a timely manner, no matter what the reason.

The prequalification packages submitted by Contractors are not public records and are not open to public inspection. All information provided will be kept confidential to the extent permitted by law. However, the contents may be disclosed to third parties for purpose of verification, or investigation of substantial allegations, or in an appeal hearing. State law requires that the names of contractors applying for prequalification status shall be public records subject to disclosure, and the first page of the questionnaire will be used for that purpose.

Each questionnaire must be signed under penalty of perjury in the manner designated at the end of the form, by an individual who has the legal authority to bind the Contractor on whose behalf that person is signing. If any information provided by a Contractor becomes inaccurate, the Contractor must immediately notify the CITY and provide updated accurate information in writing, under penalty of perjury.

The CITY reserves the right to waive minor irregularities and omissions in the information contained in the prequalification application submitted, and to make all final determinations. The CITY may also determine at any time that the prequalification process will be suspended for the Project and the Project will be bid without prequalification.

Contractors may submit prequalification packages during regular working hours on any day that the offices of the CITY are open. Contractors who submit a complete prequalification package will be notified of their qualification status no later than ten business days after submission of the information.

The CITY may refuse to grant prequalification where the requested information and materials are not provided by the due date indicated above. There is no appeal from a refusal for an incomplete or late application, but re-application for a later project is permitted. Neither the closing time for submitting prequalification packages for this Project will be changed in order to accommodate supplementation of incomplete submissions, or late submissions, unless requested by the CITY in its sole discretion.

In addition to a contractor's failure to be pre-qualified pursuant to the scoring system set forth in the prequalification package, a contractor may be found not prequalified for either omission of or falsification of, any requested information.

Where a timely and completed application results in a rating below that necessary to pre-qualify, an appeal can be made by the unsuccessful Contractor. An appeal is begun by the Contractor delivering notice to the CITY of its appeal of the decision with respect to its prequalification rating, no later than two business days following notification that it is not pre-qualified. The notice of appeal shall include an address where the Contractor wishes to receive notice of the appeal hearing. Without a timely appeal, the Contractor waives any and all rights to challenge the decision of the CITY, whether by administrative process, judicial process or any other legal process or proceeding.

If the Contractor gives the required notice of appeal, a hearing shall be conducted no earlier than five business days after the CITY's receipt of the notice of appeal and not later than five business days prior to the date of the Notice Inviting Bids for this Project. Prior to the hearing, the Contractor shall, in writing, be advised of the basis for the City's pre-qualification determination.

The hearing shall be conducted by a panel consisting of three members of the Public Works Department senior management staff (the "Appeals Panel"). The Appeals Panel shall consider any evidence presented by the Contractor, whether or not the evidence is presented in compliance with formal rules of evidence. The Contractor will be given the opportunity to present evidence, information and arguments as to why the Contractor believes it should be pre-qualified. Within one day after the conclusion of the hearing, the Appeals Panel will render a written determination as to whether the Contractor is pre-qualified. It is the intention of the CITY that the date for the submission and opening of bids will not be delayed or postponed to allow for completion of an appeal process.

ORDINANCE NO. 23-O-2870

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING REGULATIONS IN THE BEVERLY HILLS MUNICIPAL CODE RELATED TO THE ADJUSTMENT OF LOT LINES THAT WOULD CREATE OR EXPAND LOTS ACROSS THE JURISDICTIONAL BOUNDARIES OF THE CITY

THE CITY COUNCIL OF THE CITY OF BEV-ERLY HILLS HEREBY ORDAINS AS FOL-LOWS:

Section 1. On January 26, 2021, the City Council adopted Urgency Ordinance No. 21-O-2833 (the "Urgency Ordinance"), which amended portions of Title 10 (Planning and Zoning) of the Beverly Hills Municipal Code to modify regulations related to lot line adjustments on lots that are located along the jurisdictional boundaries of the City. The City Council subsequently adopted Ordinance Nos. 21-O-2834 and 22-O-2855 to further extend the effective period of the Urgency Ordinance.

Section 2. On October 13, 2022, the Planning Commission held a duly noticed public hearing to review a draft ordinance that would prohibit, on a permanent basis, the creation or expansion of a lot that crosses jurisdictional boundaries. Thereafter the Planning Commission adopted Resolution No. 2004 recommending that the City Council amend the lot line adjustment regulations in the City of Beverly Hills Municipal Code to prohibit the adjustment of a lot line that is coterminous with the City boundary which if approved, would result in a parcel located both within the City and another city (collectively, the "Amendments"). On November 15, 2022, the City Council held a duly noticed public hearing, received public testimony, and thereafter introduced this Ordinance.

Section 3. This Ordinance and the Amendment were assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. The City Council finds that adoption of the Amendment is exempt from CEQA pursuant to Section 15305 of Title 14 of the California Code of Regulations because the average slope of the City is less than 20 percent and the Amendment represents a minor alteration in land use limitations and does not result in any changes in land use or density. In addition, the City Council finds that the adoption of the Amendment will not have a significant environmen-tal impact and is exempt from CEQA pursuant to Section 15061(b)(3) of Title 14 of the California Code of Regulations, which states that CEQA applies only to projects which have the potential for causing a significant effect on the environment. This exemption is applicable because the Amendment would not result in physical changes to the subject properties other than the adjustment of lot lines, and no potential for causing a significant effect on the environment exists.

Section 4. The Amendments are consistent with the objectives, principles, and standards of the General Plan. General Plan Goal LU 2 Community Character and Quality calls for a built environment distinguished by high level of site planning, architecture, landscape de-sign, and sensitivity to its natural setting and history. Similarly, General Plan Policy LU 2.1 – City Places: Neighborhoods, Districts, and Corridors encourages the maintenance of the City's distinctive residential neighborhoods and open spaces. General Plan Goal LU 4 – Land Use Distribution and Urban Form also calls for enhancing the distinguishing qualities of the City, and the livability of neighborhoods, while preserving environmental resources and the well-being and health of the City's residents. General Plan Policy LU 5.1 - Neigh-borhood Conservation further requires that the densities, character, amenities, and quality of the City's residential neighborhoods are conserved. Amending the lot line adjustment sections of the Beverly Hills Municipal Code will protect the character of the City's residen-tial neighborhoods, as it will help limit development across jurisdictional boundaries that does not comply with all of the City's regulations. In addition, the proposed Amendments will help to ensure that development in the residential neighborhoods is of an appropriate scale and is consistent with existing neighborhood character. For the foregoing reasons, the public interest, health, safety, morals, peace, comfort, convenience, or general welfare requires the code amendments.

Section 5. The City Council hereby amends paragraphs E and F of Section 10-2-303 (Lots:) of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to read as follows, with all other provisions in Section 10-2-303 remaining in effect without amendment:

"E. City Boundary: For any property located in a one-family residential zones, a lot line shall not be adjusted which would either create or expand a lot that crosses the City boundary. Further, a lot line that is coterminous with the boundary of the City shall not be adjusted away from the City boundary.

1. Exemption: The property known as 1276 Beverly Green Drive, located on the eastern side of Beverly Green Drive, and more specifically described as: Lots 15 and 16 of Tract 11178 in the City of Beverly Hills, Los Angeles County, State of California, as per the maps recorded in map book 203, pages 49-50 of the Los Angeles County Recorder's Office, shall be exempted from the requirement in subsection E above.

F. Variances: Whenever the size of the parcel of land to be subdivided or altered as the result of a lot line adjustment, its street and alley frontage, its contour, and its location with reference to surrounding property, are such that the requirements of this section work undue and unusual hardship, and a different size and arrangement would not result in undue detriment to surrounding property or the residents thereof, the planning commission may, in its discretion, approve a different size and arrangement of the lots in the proposed subdivision."

<u>Section 6.</u> The City Council hereby amends Section 10-2-805 (Approval of Lot Line Adjustments) of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-2-805: APPROVAL OF LOT

LINE ADJUSTMENTS:

Upon receipt of the map, the director shall examine it to see whether it complies with all the requirements of this article and whether:

A. The proposed lot line adjustments will not deny access to any parcel;

B. The proposed lot line adjustment will not result in a conflict with any public or private easement; and

C. The proposed lot configurations conform with the local general plan, any applicable specific plan, and meet all standards of the zoning, subdivision, and building ordinance provisions, except that existing, legally nonconforming lots need not meet all standards of the zoning, subdivision, and building ordinance provisions, provided that the proposed lot line adjustment will result in either a decrease or no change in the degree of any existing nonconformity, and will not create a new nonconformity.

Public noticing for a lot line adjustment proposal shall be provided in accordance with article 2.5 of this chapter for a planning review and the city's public notice guidelines.

If the director makes these findings, the direc-

tor may approve the adjustment. However, if in the opinion of the director, an application merits review by the planning commission, the director may refer such application to the planning commission and the planning commission shall serve as the reviewing authority and shall conduct a noticed public hearing regarding the requested lot line adjustment."

Section 7. The City Council hereby amends Section 10-2-806 (Appeals) of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-2-806: APPEALS:

If an applicant is dissatisfied with the decision of the director, the decision may be appealed to the planning commission. Such appeal shall be in writing and shall be received by the City Clerk's Office within fourteen (14) days after the date of the director's action.

Any decision of the planning commission, either as the initial reviewing authority for the lot line adjustment or on appeal of a director decision, may be appealed by the applicant to the city council pursuant to title 1, chapter 4, article 1 of this code."

Section 8. The City Council hereby amends Section 10-2-807 (Decision of the Planning Commission) of Article 3 of Chapter 2 of Title 10 of the Beverly Hills Municipal Code to read as follows:

"10-2-807: DECISION OF THE PLANNING COMMISSION:

If the decision of the director is appealed to the planning commission, the planning commission may reject, uphold, or modify the decision of the director. The decision of the commission shall be further appealable to the city council, pursuant to Section 10-2-806, which may reject, uphold, or modify the decision of the planning commission."

Section 9. Severability. If any section, subsection, subdivision, sentence, clause, phrase, or portion of this Ordinance or the application thereof to any person or place, is for any reason held to be invalid or unconstitutional by the final decision of any court of competent jurisdiction, the remainder of this Ordinance shall be and remain in full force and effect.

Section 10. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the City within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance, and shall cause this Ordinance and her certi-

fication, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

Section 11. Effective Date. This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.
