



# **Cheval Blanc Ballot Arguments Filed with City**

Ballot arguments were filed last week with the City for both sides of the arguments regarding the Cheval Blanc project that will be included in the Vote-By-Mail ballot residents will receive prior to the May 23 special election. The City Council previously approved a special election for the successful referendum petitions against two ordinances approving the Cheval Blanc project, and required that the ballot will include arguments and the impartial analysis as part of the election process. The two ordinances are now known as 'Measure B and C'.

The ballot arguments are signed by several residents vouching the arguments to be accurate.

The community members who signed the ballot argument in support of a "Yes" vote on Measures B and C include Mayor Lili Bosse, President of the Beverly Hills Firefighters' Association Victor Gutiérrez, President of the Beverly Hills Police Officers Association Alexander Duncan, Beverly Hills Education Foundation Board member Rose Kaiserman, and Chamber of Commerce Board member David Mirharooni.

The opposition is signed by Councilmember John Mirisch, former Mayor Charles Aronberg, former Planning

Commissioner Rose Norton, Director of "Residents Against Overdevelopment" Deborah Blum, and Beverly Hills resident Darian Bojeaux.

The argument in favor of reaffirming the City Council's decision to approve the project states that the "hotel will generate hundreds of millions of dollars to support public safety, Beverly Hills schools, and other critical City services for decades to come."

The arguments in favor of both Measure B and C are the same.

The argument against Measure B states that the hotel "would rezone our lovely village to allow the building of a massive hotel along little Santa Monica, from Rodeo Drive to Beverly Drive, up to 9 stories in height, far exceeding our 3 story height limit."

Opponents also claim the hotel will add more traffic onto little Santa Monica

Opponents for Measure C claim that the "development agreement for the Cheval Blanc hotel is a bad deal for Beverly Hills," and that the hotel is "taking a public museum and turning it into part of an exclusionary enclave for billionaires."

City Hall will be an 11-day Vote Center. In-Person voting begins May 13.

# City Council Approves Grant Application for La Cienega Park Wells Project

At last Tuesday's meeting the City Council adopted a resolution to authorize the execution of all grant-related documents to the California Department of Water Resources (DWR).

The California Department of Water Resources (DWR) offers grant opportunities related to efforts to mitigate drought concerns and reduce dependence on imported water. City staff believes grant funding is essential to meet the long-term water independence goals and objectives of the City.

DWR is administering the Urban Community Drought Relief Grant intended to provide aid in the implementation of drought relief projects including projects that enhance local water supply, new wells or rehabilitation of existing wells, and other projects that address drought impact.

The City is pursuing the Grant to offset costs for the La Cienega Park Wells Project and the Advanced Metering Infrastructure and Automated Meter Reading Project. The La Cienega Park Wells Project provides immediate drought relief by drilling two new wells in a very low priority basin that will provide water, reducing imported water supplies by an equal amount, reducing the regional drought impacts to the water supply, and increasing local water supply reliability.

The Advanced Metering Infrastructure and Automated Meter Reading Project is a long-term project to evaluate and pilot test 2,720 meters that will lead to the replacement of the existing meters and metering network with new infrastructure. The new meters will provide accounting of water consumption and use technology that provide reporting in real-time of

water use which will allow the City to alert customers sooner of potential water leaks and excessive consumption.

City staff has submitted the application which was due on Jan. 31. DWR requires a City Council Resolution for the grant application.

The Urban Community Drought Relief Grant administered by the DWR requires a minimum non-State cost share of 25% of the total application costs. The City is requesting \$9,324,000 with the City's cost share portion at \$3,108,000.

# Planning Commission Approves 312 North Rodeo Drive Project

At last Thursday's meeting the Planning Commission approved a Development Plan Review to allow for the construction of a third story addition with an outdoor terrace on an existing commercial building at 312-314 North Rodeo Drive.

The project involves the construction of a new third story addition to an existing commercial building with a new outdoor terrace. The existing commercial building was most recently occupied by Dolce & Gabbana.

Rolex and Patek Phillippe would occupy the tenant spaces. These retail uses would be located on the first and second floor. The third floor addition would be used as a VIP sales lounge with access provided by invitation only. Ground floor access to the tenant spaces would continue to be provided via the corresponding main pedestrian entrances along North Rodeo Drive. The third story addition would be minimally visible from the streetscape.

# City Council Discusses Educational Programming for Jewish American Heritage Month

At last Tuesday's Study Session the City Council discussed a presentation regarding programming for Jewish American Heritage Month in May after it was requested by Mayor Lili Bosse and Councilmember John Mirisch.

City staff has been in contact with representatives from the North American Affairs Office of the Combat Antisemitism Movement (CAM) to explore ways

that the City can participate and provide programming that aligns with their mission. CAM is a non-partisan, global grassroots movement of individuals and organizations across all faiths, united to combat antisemitism.

Since 1996, the United States has proclaimed May as Jewish American Heritage Month.

The following were proposed ways the City can provide programming:

Proclaim May as Jewish American Heritage Month at a City Council Meeting; during the month of May, the Public Library will display relevant titles in the collection; create a bibliography list of resources that can be located on the City's website; a special music performance will be hosted at the Farmers' Market in May, and Host a Critical Conversation event with the Human Relations Commission in honor of Jewish American Heritage Month.

# White House Committee Nominates Beverly High Students for Presidential Scholars Program

Beverly High seniors Miles Kottler and Alexandra Bakshian have been

named nationally as part of only 5,000 candidates in the 2023 U.S. Presidential Scholars Program.

The candidates were

selected from millions of students expected to graduate this year. Inclusion in the program is one of the highest honors bestowed upon graduating seniors Scholars are selected on the basis of superior academic and artistic achievements, leadership qualities, strong character, and involvement in community and school activities.

The Presidential Scholars Program was established in 1964 to recognize some of the nation's most distinguished graduating seniors for their accomplishments in many areas: academic success, leadership, and service to the school and community. It was expanded in 1979 to recognize students demonstrating exceptional scholarship and talent in the visual, creative, and performing arts. In 2015, the program was expanded once again to recognize students who demonstrate ability and accomplishment in career and technical fields.

Annually, up to 161 scholars are chosen from among that year's class, representing excellence in education and the promise of greatness in America's youth. A distinguished panel of educators will review these submissions and select approximately 600 semifinalists in April. The Commission on Presidential Scholars, a group of up to 32 eminent citizens appointed by the President, will select the finalists, and the Department



PROJECT: 9600 Wilshire Boulevard Specific Plan

The City of Beverly Hills is preparing a Draft EIR for the proposed 9600 Wilshire Boulevard Specific Plan and its accompanying Conceptual Plan (herein referred to as "9600 Wilshire Boulevard Specific Plan" or "Project") The public is invited to attend a preliminary "scoping meeting" on Wednesday, March 29, 2023 at 7:00 p.m. to comment on environmental issues that should be addressed in the Draft EIR. Members of the public may attend the scoping meeting in person or virtually. Virtual access to the meeting is available through: (i) the video conferencing link, and (ii) the phone access information identified at the top of this notice.

Project Location: The approximately four-acre Specific Plan Area is located south of Wilshire Boulevard, between Bedford Drive to the west and Camden Drive to the east, in the southwestern portion of the City of Beverly Hills. The Specific Plan Area



The Project Site currently contains two existing commercial structures, including the Saks Fifth Avenue Women's Building and the former Barneys New York Building, an ancillary loading facility, and two surface parking lots. The Project Site also contains an approximately 27-footwide alley that runs along the southwestern boundary of the site between South Bedford Drive and South Peck Drive and an additional approximately 20-foot-wide alley in the southeastern portion of the site that connects to South Camden Drive and an existing residential alley to the south of the Specific Plan Area.

 $\textbf{Project Description:} \ The \ 9600 \ Wilshire \ Boulevard \ Specific \ Plan \ would \ facilitate \ the \ rehabilitation$ and adaptive reuse of the Saks Fifth Avenue Women's Building, the retention of the existing commercial building at 9570 Wilshire for continued commercial use, and the development of new residential, retail, office, hospitality, social club, boutique hotel, open space, and related uses throughout the Specific Plan Area.

The Specific Plan Area would be divided into two Districts: a Wilshire Boulevard District fronting Wilshire Boulevard and a Neighborhood District to the south. The Specific Plan would permit a range of commercial and other compatible uses in the Wilshire Boulevard District, including retail, restaurant, boutique hotel, social club, and office uses, with the potential to convert a portion of the buildings to residential units in the future. The Specific Plan would permit a limited range of uses in the Neighborhood District, including multi-family residential and Small Shop/ Boutique Retail uses, as well as publicly accessible open space. In overall compliance with the proposed Specific Plan, the Applicant is proposing a Conceptual Plan (see figure on the following page) that includes:

- · Rehabilitation in accordance with the Secretary of Interior's Standards for the Treatment of Historic Properties, and adaptive reuse of the Saks Women's Building with Retail, Spa, Restaurant, Boutique Hotel, Social Club, and Appurtenant Uses and the construction of a new attached seven-story building with Office and Restaurant uses. These two buildings would cumulatively contain 188,108 square feet (sf) of floor area (9600-9620 Wilshire Boulevard);
- The development of an 84.5-foot (six story), 73,614-sf building with Office and Restaurant uses on Parcel A (9588-9596 Wilshire Boulevard);
- The development of a six-story, approximately 115,905-sf, 30-unit multi-family residential building with small shop/boutique retail uses (128 South Peck Drive);
- The development of a six-story, approximately 116,304-sf, 38-unit multi-family residential building with small shop/boutique retail uses (133 South Peck Drive); and
- Four levels of subterranean parking beneath the Specific Plan Area, containing a total of up to 937 parking spaces.

Construction of the Project would commence in 2024 and would occur in nine phases, which would overlap in their duration. The overall duration of construction is estimated to be approximately 50 months, with 14 months of utility relocation and 36 months of construction.

Based on the Phase I Environmental Site Assessment prepared for the Specific Plan Area, it was determined the site is not included on existing lists of hazardous materials sites compiled pursuant to Government Code Section 65962.5.

Initial Study: The Initial Study prepared for the 9600 Wilshire Boulevard Specific Plan Project

determined that the project would have less than significant impacts to Agriculture and Forestry Resources, Hydrology and Water Quality, Mineral Resources, Public Services, Recreation, and Wildfire and these topics will not be studied further in the Draft EIR. Based on the conclusions of the Initial Study, the following areas of potentially significant environmental impact are anticipated to require analysis in the Draft EIR:



Potential cumulative impacts and potential for growth inducement will also be addressed. Project Alternatives, including the No Project Alternative, will be evaluated.

Purpose of the Scoping Meeting: The purpose of the scoping meeting is to present the 9600 Wilshire Boulevard Specific Plan Project in a public setting and provide an opportunity for input regarding the environmental issues that are important to the community. The meeting will include a presentation of the proposal and the environmental issues to be analyzed in the Draft EIR. Following the presentation, interested agencies, organizations, and members of the public will be encouraged to present views concerning what environmental issues should be included in the Draft EIR. The oral and written comments regarding potential environmental effects of the 9600 Wilshire Boulevard Specific Plan Project made during the scoping meeting will be addressed in the Draft EIR.

30-Day Comment Period: The City invites all interested members of the public to attend the public scoping meeting. The City also invites written comments on issues related to potential environmental impacts during a 30-day comment period, which starts on Thursday, March 9, 2023 and will conclude on Monday, April 10, 2023. # Cultural Heritage Commission Reinstates Master Architect Subcommittee

At their Monday meeting the Cultural Heritage Commission approved the reinstatement of the Master Architect Subcommittee to take on the charge of updating and reviewing the local list of Master Architects.

The document is an official list maintained by the City to help identify works of master architects and potential historic associations.

The list was created to assist in the evaluation of properties of potential historical significance. One of the purposes it serves is to screen development pro-



posals for properties that may possess architectural merit, and institutes a 30-day hold on certain permits to allow for further examination of the subject structure. Additionally, one criterion for local landmark designation takes into account if a property is an "exceptional work by a master architect".

A number of standing subcommittees were established in conjunction with the

creation of the Historic Preservation Ordinance.

The Commission will review the reinstatement of the Master Architect Subcommittee to regularly review and update the Master Architect List.

The current list of standing subcommittees and ad-hoc committees of the Cultural Heritage Commission with their members and their charge are the following: Governmental Relations and Legislative Subcommittee, Landmark Nominations

Advisory Subcommittee, Community Outreach and Education Subcommittee, Historic Resources Survey Subcommittee, Preservation Incentives Subcommittee, Historic Preservation Ordinance Ad Hoc Committee, and Master Architect Subcommittee.

# Bosse Gifted Book on National Registry of Jewish Holocaust Survivors

At last Tuesday's City Council meeting Mayor Lili Bosse announced that she was gifted the National Registry of Jewish Holocaust Survivors book by Beverly Hills residents Carolina Tomkinson and her daughter Alma Ordaz.

Tomkinson has worked for many years on her family genealogy at the Family Research and History Library at the Mormon Temple in West LA. Although she is not Mormon, Tomkinson is well known to the staff and has given classes at the Mormon Temple Library to Spanish speakers who wish to study their genealogy.

Tomkinson was working on a friend's genealogy and came across some books that the library was giving away. One of them was the National Registry of Jewish Holocaust Survivors.

"I grew up with many Survivors. Some Jewish, others not. Most are now deceased. But she immediately recognized what a treasure it would be to someone whose parents or grandparents names were in the book and of course we immediately thought of Lili," Ordaz said.

Bosse's mother, the late Rose Toren, is a survivor of Auschwitz. She is listed in the book.

"Both Mother and I recognize the personal, cultural and historical importance of preserving history. We know that with Lili this book will be in good hands and we are so happy to be able to give it to someone who will cherish it and safeguard the history of those whose names appear in the book of life," Ordaz said.

# Cultural Heritage Commission Approve Golden Shield Award Nominees

The Cultural Heritage Commission approved four Golden Shield award nominees for recommendation to the City Council, at their Tuesday meeting.

The Golden Shield program was established to honor places of cultural or historic merit. The intent of the program is to allow the community to celebrate these places, as marked by a bronze cast plaque with text to serve as an educational and memorial marker.

The first recommendation is for Beverly Hills Nurseries. The Rodeo Land and Water Company established the Beverly Hills Nurseries. Initially, this was located along the south side of Sunset Boulevard between Palm to Alpine drives. The establishment of the nursery was a part of the overall development plan for the City and was mentioned as early as April 1907 in a Los Angeles Times advertisement for the Percy H. Clark Company and the selling of

building sites within Beverly Hills. John J. Reeves, a landscape engineer, became the nursery superintendent in 1908. Reeves and the Beverly Hills Nurseries supervised the development of the City's master tree planting plan and designed and planted a number of parks, hotel grounds, and large estates in Beverly Hills. Reeves Drive was named in honor of him. As residential development occurred in the eastern portion of the City in the mid-1920s, the Beverly Hills Nurseries relocated to a 16-acre site at the corner of Wilshire and Santa Monica boulevards, now the site of the Beverly Hilton Hotel. In 1946, the Beverly Hills Nurseries discontinued business.

The second recommendation is for Beverly Hills Speedway. The original wooden automobile racetrack, located outside the Golden Triangle, was engineered by Arthur C. Pillsbury and built in 1919. The race track had two entrances: a primary entrance through a two-block long, 600-foot-wide, landscaped drive off Wilshire Boulevard and a second entry at the southeast corner of the site. The track had tiered seating for about 70,000 people. The project was financed by a group of racers that called themselves the Beverly Hills Speedway Association. The track was the first in the nation to be designed with banked turns incorporating a track transition curve. The site was bounded by Lasky

# **US Veteran Receives French Legion of Honor**

World War II veteran Sergeant William Simonoff has been awarded the Legion of Honor in the rank of Chevalier (Knight). This award is the highest merit France bestows on its citizens and foreign nationals. The ceremony was held by Consul General of France Julie Duhaut-Bedos. Simonoff was drafted into the U.S. Army in April of 1944 at Fort MacArthur, Calif. and after basic training, was sent to Fort Knox, Ky. for training in tank maintenance and driving. He landed at Le Havre, France in Jan. of 1945 and was assigned as a replacement tank driver for the 3rd Tank Battalion of General Patton's 10th Armored Division. He later became tank commander and participated in the battles of Metz, Thionville, Nancy, Strasbourg, and the Battle of the Bulge. His campaigns included Rhineland, Ardennes, and Central Europe. William was discharged from the Army in Feb. of 1946. His significant decorations include the Bronze Star Medal, the EAME Campaign Medal with three battle stars, the Presidential Unit Citation, and the World War II Victory Medal. Vice Mayor Julian Gold was also in attendance at the ceremony.

Drive, Wilshire Boulevard, South Beverly Drive, and Olympic Boulevard. The track was 1.25 miles in length. The speedway operated for four years before being moved to Culver City in 1924.

The third recommendation is for Warner Brothers-Beverly Hills Theatre. The theatre was originally located at 9404 Wilshire Boulevard and opened in May of 1931. The theatre was commissioned by Jack Warner and the Warner Brothers Studio and designed by Master Architect B. Marcus Priteca, who also designed the Fine Arts Theatre down the street. The building was designed in the Art Deco architectural style and was shaped like a ziggurat with a spire that spelled out the theatre's name in neon. On Oct. 27, 1954, the Warner-Beverly Theatre had the west coast premiere of White Christmas starring Bing Crosby; and on Dec. 16, 1962, the west coast premiere of Lawrence of Arabia was shown. In the late-1960s, it went from being operated by StanleyWarner to Pacific Theatres. The theater was then called The Beverly after Pacific Theatres left, and operated independently, until 1987 when it closed. The building was demolished and is now a parking lot for Rolex.

The final recommendation is for the Rachmaninoff Residence. The composer, symphony conductor, and piano virtuoso Sergei Rachmaninoff resided at

Gohari filed two Legislative Advocate Registration forms, one in 2021 and one in 2023. The former lists Dennis Ferrazano under the client name, the primary Chicago-based North American real estate counsel for Bernard Arnault, LVMH, and all the LVMH brands in the Americas. The latter lists Friends of Cheval Blanc-Anish Melwani under the client name. Melwani is the Chairman and CEO for LVMH for North America.

Ross of Swing Strategies is a strategic advisor to House Republican Speaker Kevin McCarthy (R - Bakersfield). He currently serves as the Political Director to New Majority California and TEAMCAL, the major donor organization within the Republican Party. Swing Strategies website claims they help clients win political and public affairs campaigns, and has a 91% win rate on Calif. statewide props.

Sugerman, a public relations executive and former Los Angeles city official, agreed in 2005 to plead guilty to participating in a scheme at Fleishman-Hillard to bill the city of Los Angeles through phony billings to the Department of Water and Power, according to the LA Times.

Sugerman, who served as director of communications for former Los Angeles Mayor Richard Riordan, also testified against Douglas R. Dowie, his former boss at the international public relations firm. In a criminal charging document and a plea agreement, Sugerman admitted participating in the overbilling scheme "in accordance with Dowie's general directions." Dowie was sentenced to 3 ½ years for defrauding taxpayers.

Sugerman acknowledged he was involved in the overbilling of more than \$120,000 at Fleishman over two years.

Sugerman currently serves as president of Sugerman Communications Group, which he founded in 2002. His mother-in-law is the former Hawthorne Assistant Principal Rochelle Ginsburg.

James is a senior member of Sugerman Communications Group. He was previously a New York-based reporter for TIME magazine.

Urteaga, who is also a convicted felon, pleaded no contest in 1998 to grand theft of personal property totaling \$30,000, according to court documents.

Urteaga was also recalled from the Montebello City Council after voting in 2008 to grant a no-bid, 15-year \$150 million contract to Athens Services to haul all the city's trash.

In 2012 the City of Montebello sued Urteaga along with two other former Councilmembers, accusing them of approving the contract with Athens in exchange for campaign contributions.

The case stems from when Urteaga ran for the Montebello City Council in 2007. Urteaga had initiated contact with Dennis Chiapetta the Vice-President of Athens about the exclusive residential waste contract where Chiapetta told Urteaga that Athens could not secure the commercial waste contract and Urteaga said he thought that Athens should have that contract too, according to Hews Media Group. After that meeting, Athens began contributing to Urteaga's

An appellant court ultimately found that Urteaga and the other councilmember did not break conflict of interest

Urteaga is currently a Senior Associate at The Santa Maria Group, according to his Linkedin. He lists his employer as Upward Solutions LLC on his Legislative Advocate Registration form.

Fischer was retained to represent several local retailers, including Hermes, who voiced concerns at previous public hearings about plans to relocate an alley located on the 400 block between Rodeo and North Beverly Drive.

Sisson was retained by UNITE Here Local 11 with a desired outcome for the project to have "compliance with CEQA and the Beverly Hills Municipal Code." UNITE Here Local 11 was responsible for circulating two successful petitions to overturn the project.

Kelly provided the City with transportation and parking-related feedback on the Cheval Blanc project, according to his Legislative Advocate Registration.

Antonio has filed with the client Gruen Associates, and listed his desired outcome for the project to "meet all Beverly Hills noise and vibration requirements."

"Friends of Cheval Blanc Beverly Hills has engaged with local leaders and other professionals knowledgeable with the referendum process. They provided valuable counsel as the City considered the referenda, and registered in compliance with the City of Beverly Hills legislative advocacy ordinance," LVMH spokesperson Jessica Miller said.

# Cheval Blanc: Why I am **Voting No on Measures**

Last Tuesday the council majority refused to agendize discussion of a resolution condemning antisemitism in digital and traditional advertising, including social media.

It seems crystal clear that the council majority's unwillingness to stand up to Jew-hatred is a result of its desire to

protect the developer of the Cheval Blanc hotel, LVMH, from accusations of working with and coddling Jew-haters.

Yes, I opposed and voted against the Cheval Blanc project. But my opposition to this project was originally based on other factors, including the proposed development agreement.

I think the deal proposed and approved by the Council majority was abysmal. In short, we are getting fleeced.

I also find it offensive when a developer hires a battery of ex-mayor lobbyists in an attempt to influence our residents.

LVMH has put these former leaders in place to do their bidding, forgetting about what's best for our City and its residents. Why should we trust anybody who is being paid by the developer to do anything but push what's good for the developer, not our Community?

But what we would later discover is that the developer has employed Jew-haters, as one can read in the "Algemeiner" article from earlier this year with the headline "Louis Vuitton Slammed for Hiring 'Ardent Antisemite' Bella Hadid for New Campaign." This is yet another compelling reason to oppose this project and vote NO on Ballot Measures B and C come May of this year.

> Notwithstanding this alarming story, my proposal for the resolution, as I made very clear at the meeting, was not intended

to target LVMH specifically, because the problem is larger than just one corporation -- even if LVMH as the largest and wealthiest, luxury goods corporation in the world, owned by the world's wealthiest man, carries a unique responsibility.

When information about antisemitism is brought before us, we can either choose to act or we can choose to ignore it. The unconvincing and weak excuse of the Council majority was that we shouldn't single out specific businesses; at the same time, of course, they claimed to oppose all forms of antisemitism.

LVMH has hired as the face of their campaign a person who has called

openly for the destruction of Israel, who has chanted "from the river to the sea," and who has posted numerous anti-Jewish memes, including those claiming that Israel is a settler colonial and apartheid state, denying the connection of Jews with our ancestral homeland.

In attempting to justify non-action on the resolution Councilmember Lester Friedman asked, "Where does it stop?" The simple answer is: it stops when Jew-hatred is no longer a problem, which sadly probably will never happen, or it doesn't stop at all. Speaking out against Jew-hatred must never stop as long as there are anti-Jewish canards, as long as there is misinformation about Jews and Israel, as long as there are blood libels. and as long as there is anti-Jewish racism, which is the oldest extant form of racism, eliciting threats and hatred from all sides of the political spectrum.

We don't get to pick and choose. We need to fight all forms of Jew-hatred and need to defend Israel against slanderous false narratives now and forever. We must not check our principles at the door for the sake of political expediency.

And while my resolution proposal was not specifically directed at LVMH, since there are other companies doing the same thing, it is nonsensical for the Council majority to suggest that we should not single out specific companies for furthering, promoting, or condoning antisemitism. In fact, the unanimous City Council (consisting of four of the five current Council members) passed a resolution condemning a business decision by a single, named company, Ben and Jerry's, in July of 2021.

In the play "A Man for All Seasons," Sir Thomas More addresses a questionable ethical decision by an accuser, Richard Rich, with the following statement: "For Wales? Why Richard, it profit a man nothing to give his soul for the whole world. . . but for Wales!"

Or maybe for a hotel?

Not condemning Jew-hatred is condoning it.

I call upon my Council colleagues to have a change of heart, and to join me in passing a strong resolution condemning Jew-hatred on social media, in advertising, and by influencers. We must hold corporations accountable, and call upon them to disassociate themselves from those who demonize Israel, and who cause the spread of Jew-hatred.

I call upon you, the voters, to join me and thousands of fellow residents to vote NO on Measures B and C on or before May 23.

In a world marked by rising antisemitism and violence against Jews, LVMH cannot and must not get a pass when it comes to condoning antisemitism. Our opposition to all forms of Jew-hatred cannot and must not be for sale. A NO vote on Measures B and C is also a vote to stand up against antisemitism in all its insidious forms.

It's that simple.

#### **ORDINANCE NO. 23-0-2873**

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AUTHORIZING THE CITY MANAGER TO REMOVE CERTAIN CURBSIDE PICKUP ZONES, READOPTING CITY MANAGER AUTHORITY TO ISSUE PERMITS FOR OUTDOOR DINING, READOPTING WAIVER OF SPECIAL EVENT PERMIT FEES AND REQUIREMENTS FOR OUTDOOR DINING AND ADDING ARTICLE 8 TO CHAPTER 4 OF TITLE 4 OF THE BEVERLY HILLS MUNICIPAL CODE

THE CITY COUNCIL OF THE CITY OF BEVERLY HILLS HEREBY ORDAINS AS FOLLOWS:

WHEREAS, international, national, state and local health and governmental authorities have responded to an outbreak of respiratory disease caused by a novel coronavirus named "SARSCOV-2" and the disease it causes has been named "coronavirus disease 2019," abbreviated COVID-19, ("COVID-19"); and

WHEREAS, on March 15, 2020, the City Manager, in his role as the Director of Emergency Services, proclaimed the existence of a local emergency pursuant to Section 2-4-107 of the Beverly Hills Municipal Code to ensure the availability of mutual aid and an effective City response to the novel coronavirus ("COVID-19") and that state of emergency was ratified by the City Council on March 16, 2020 ("local state of emergency"); and

WHEREAS, restaurants located within the City were prohibited from offering dinein service, limiting restaurants to delivery and takeout offerings only, which placed a sudden and severe financial strain on many restaurants, adding to the financial pressures in the industry that predated the COVID-19 crisis. In response, the City of Beverly Hills adopted measures to try to mitigate the impacts of the pandemic on businesses in the City by waiving

certain fees, and authorizing the use of parking spaces and street closures for temporary outdoor dining spaces and pick-up operations, as well as regulating fees imposed on restaurants by Third-Party Food Delivery services; and

WHEREAS, upon the end of the local state of emergency, these measures shall cease to be effective; and

WHEREAS, the City Council finds that designated curbside pickup zones have benefited both local businesses and their consumers, but some zones have also reduced parking availability and increased traffic congestion in the City, been misused by businesses for purposes other than order pick-ups, and may no longer be necessary to support businesses' pick-up operations; and

WHEREAS, outdoor dining generates business and creates vibrant community spaces in the City. The City Manager's continued ability to issue street closure and other permits, and the waiver of Special Event Permit fees and other requirements, will facilitate outdoor dining and benefit both businesses and consumers alike; and

WHEREAS, the use of third-party applications and websites to place orders with restaurants for delivery and takeout remains popular amongst consumers even after in-person dining has resumed; and

WHEREAS, prior to the City's emergency regulations, third-party platforms often charged restaurants fees ranging from 30% to 40% of the purchase price per order; and

WHEREAS, restaurants, and particularly restaurants that are small businesses, have limiting bargaining power to negotiate lower fees with third-party platforms, given the high market saturation of third-party platforms; and

WHEREAS, permanently capping per-order fees will ensure restaurants in the City receive reasonable revenue from orders placed by consumers, while not unduly burdening third-party platforms that continue to be in high demand.

<u>Section 1.</u> The City Manager is authorized to review existing curbside pickup zones and remove zones that meet one or more of the following conditions:

- 1. the curbside pickup zone is no longer reasonably necessary to accommodate the business needs of the nearby businesses; 2. the demand for parking in the immediate
- area outweighs the demand for a curbside pickup zone;
- 3. the curbside pickup zone significantly impacts traffic in the area; or
- 4. a nearby business has misused the curbside pickup zone.

<u>Section 2.</u> The City Manager is authorized to issue street closure permits and any other permits necessary to allow for temporary outdoor dining.

Section 3. The City shall waive fees associated with a Special Event Permit for temporary outdoor dining and shall waive the minimum ten (10) day period for filing an application for a Special Event Permit for temporary outdoor dining.

Section 4. Article 8 ("Third-Party Food Delivery Services") is hereby added to of Chapter 4 (Other Regulations for Specific Types of Businesses and Activities) of Title 4 (Regulation of Certain Types of Businesses and Activities) of the Beverly Hills Municipal Code to read as follows:

"Article 8.Third-Party Food Delivery Services

#### Section 4-4-801. Definitions.

Delivery Fee: A fee charged by a Third-Party Food Delivery Service for providing a Retail Food Establishment with a service that delivers food and beverages from such establishment to customers. The term does not include any other fee or cost that may be charged by a Third-Party Food Delivery Service to a Retail Food Establishment, such as fees for listing or advertising the Retail Food Establishment on the Third-Party Food Delivery Service platform or fees related to processing the online order including, but not limited to service fees, fees for facilitating Online Orders for pick-up, and credit card processing fees.

Online Order: An order placed by a customer, including a phone order, for delivery or pick-up from a restaurant located within the City.

Retail Food Establishment: A restaurant, delicatessen, bakery, coffee shop, or other eat-in or carry-out service of processed or prepared raw and ready-to-eat food or beverages.

Third-Party Food Delivery Service: Any website, mobile application or other internet service that offers or arranges for the sale of food and beverages prepared by, and the delivery or pick-up of food and beverages from no fewer than twenty (20) separately owned and operated food service establishments.

#### Section 4-4-802. Prohibitions.

It shall be unlawful for a Third-Party Food Delivery Service to do the following:

- A. Charge a Retail Food Establishment a Delivery Fee that totals more than fifteen percent (15%) of the Purchase Price of each Online Order.
- B. Charge a Retail Food Establishment any amount designated as a Delivery Fee for an Online Order that does not involve the delivery of food or beverages.
- C. Charge a Retail Food Establishment any combination of fees, commissions, or costs for the Retail Food Establishment's use of the Third-Party Food Delivery Service that is greater than five percent (5%) of the Purchase Price of each Online Order or to charge any amount of fees, commissions, or costs for the Retail Food Establishment's use of the Third-Party Food Delivery Service unless the contract between the Retail Food Establishment and the Third-Party Food Delivery Service allows for fees, commissions, and costs other than a Delivery Fee. For the purpose of this subsection, fees, commissions, or costs do not include the Delivery Fee, which is capped at fifteen percent (15%).
- D. Charge a Retail Food Establishment any fee, commission, or cost other than as permitted in subsections A through C, above.
- E. Charge a customer any Purchase Price for a food or beverage item that is higher than the price imposed by the Retail Food Establishment on the Third-Party Food Delivery Service or, if no price is imposed by the Retail Food Establishment on the Third-Party Food Delivery Service, the price listed on the Retail Food Establishment's own menu.
- F. Retain any portion of amounts designated as a tip or gratuity. Any tip or gratuity shall be paid by the Third-Party Food Delivery Service, in its entirety, to the person delivering

the food or beverages.

#### Section 4-4-803. Disclosures.

The Third-Party Food Delivery Service shall disclose to the customer an accurate, clearly identified, and itemized cost breakdown of each transaction, including, but not limited to the following:

- A. The Purchase Price of the food and beverages at the cost listed on the Retail Food Establishment's menu.
- B. The Delivery Fee charged to the Retail Food Establishment.
- C. Each fee, commission, or cost, other than a Delivery Fee, charged to the Retail Food Establishment.
- D. Each fee, commission, or cost, other than the Delivery Fee or the Purchase Price of the food, charged to the customer by the Third-Party Food Delivery Service.
- E. Any tip or gratuity that will be paid to the person delivering the food or beverages.

#### Section 4-4-804. Violations.

If a Third-Party Food Delivery Service charges a Retail Food Establishment fees that violate this Section, the Retail Food Establishment shall provide written notice to the Third-Party Food Delivery Service requesting a refund within seven days. If the Third-Party Food Delivery Service does not provide the refund requested after seven days or the Third-Party Food Delivery Service continues to charge fees in violation of this Section after the initial notice and seven-day cure period, a Retail Food Establishment may enforce this Section by means of a civil action seeking damages and injunctive relief. The prevailing party in any such action shall be entitled to an award of reasonable attorney fees."

<u>Section 5.</u> Sections 1 through 3 of this Ordinance shall not be codified.

Section 6. CEQA. This Ordinance is exempt from the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15061(b)(3) which is the general rule that CEQA applies only to projects which have the potential to cause a significant effect on the environment, and CEQA does not apply where it can be seen with certainty that there is no possibility that the activity may have a significant effect on the environment. It can be seen with certainty that granting the City Manager the authority to remove certain curbside pickup zones, and the continued waiver of Special Event Permit fees and requirements and grant of authority to the City Manager to issue permits for temporary outdoor dining, as well as the enactment of regulations on third-party food delivery services will not cause a significant effect on the environment. In addition, these regulations do not constitute a project that is subject to the provisions of CEQA, pursuant to CEQA Guidelines Section 15378(b)(2) and (b)(5).

<u>Section 7. Severability</u>. If any provision of this Ordinance is held invalid by a court of competent jurisdiction, such provision shall be considered a separate, distinct and independent provision and such holding shall not affect the validity and enforceability of the other provisions of this Ordinance.

Section 8. Publication. The City Clerk shall cause this Ordinance to be published at least once in a newspaper of general circulation published and circulated in the city within fifteen (15) days after its passage in accordance with Section 36933 of the Government Code, shall certify to the adoption of this Ordinance and shall cause this Ordinance and the City Clerk's certification, together with proof of publication, to be entered in the Book of Ordinances of the Council of this City.

<u>Section 9.</u> <u>Effective Date.</u> This Ordinance shall go into effect and be in full force and effect at 12:01 a.m. on the thirty-first (31st) day after its passage.

<u>Section 10. Certification</u>. This City Clerk shall certify to the adoption of this Ordinance.
