Beverly Hills International Music Festival Seeks City Co-Sponsorship for Spring 2025 Return

The Beverly Hills International Music Festival (BHIMF), a long-standing event that promotes classical and jazz music while fostering musical education, is poised to make its return to Greystone Mansion in the spring of 2025. Founded in 2004, the non-profit festival last held performances at Greystone in 2019 and now seeks the city's co-sponsorship and in-kind support to facilitate its upcoming concert series.

Two concert dates will be scheduled at Greystone Mansion in spring 2025, with final dates pending further discussions between BHIMF and Community Services staff.

BHIMF plans to sell tickets, with a portion reserved for Beverly Hills residents free of charge. Specific ticket pricing, allocation for residents, and total availability are still being finalized.

To offset production costs, BHIMF has requested:

- Waiver of rental fees for the use of Greystone Mansion (\$3,190).
- Support from Greystone staff for event setup and breakdown, totaling \$1,300 in labor costs.
- Coordination support for logistics

if a piano is required, which BHIMF will supply.

The total projected value of waived fees is approximately \$4,490.

No direct revenue is anticipated for the city. BHIMF will fund its operations primarily through ticket sales.

Heart Hand Sculpture Installed in Beverly Hills

Two locations in Beverly Hills now feature a Heart Hand sculpture: across from the Beverly Hills sign on Santa Monica Boulevard and across from the Beverly Hills Hotel on Sunset Boulevard.

The Heart Hand sculpture is intended to symbolize love and unity. It was commissioned by Jason Aftalion and created by artist Dr. Simon Ourian. The design features the hand-heart gesture, chosen for its universal recognition and ability to transcend language and cultural barriers.

The sculpture was strategically placed in these locations to reflect aspects of Beverly Hills' identity. It aims to represent the city's connection to themes of beauty, inclusivity, and cultural significance. According to its creators, the sculpture is meant to serve as a point of reflection and interaction for both residents and visitors.

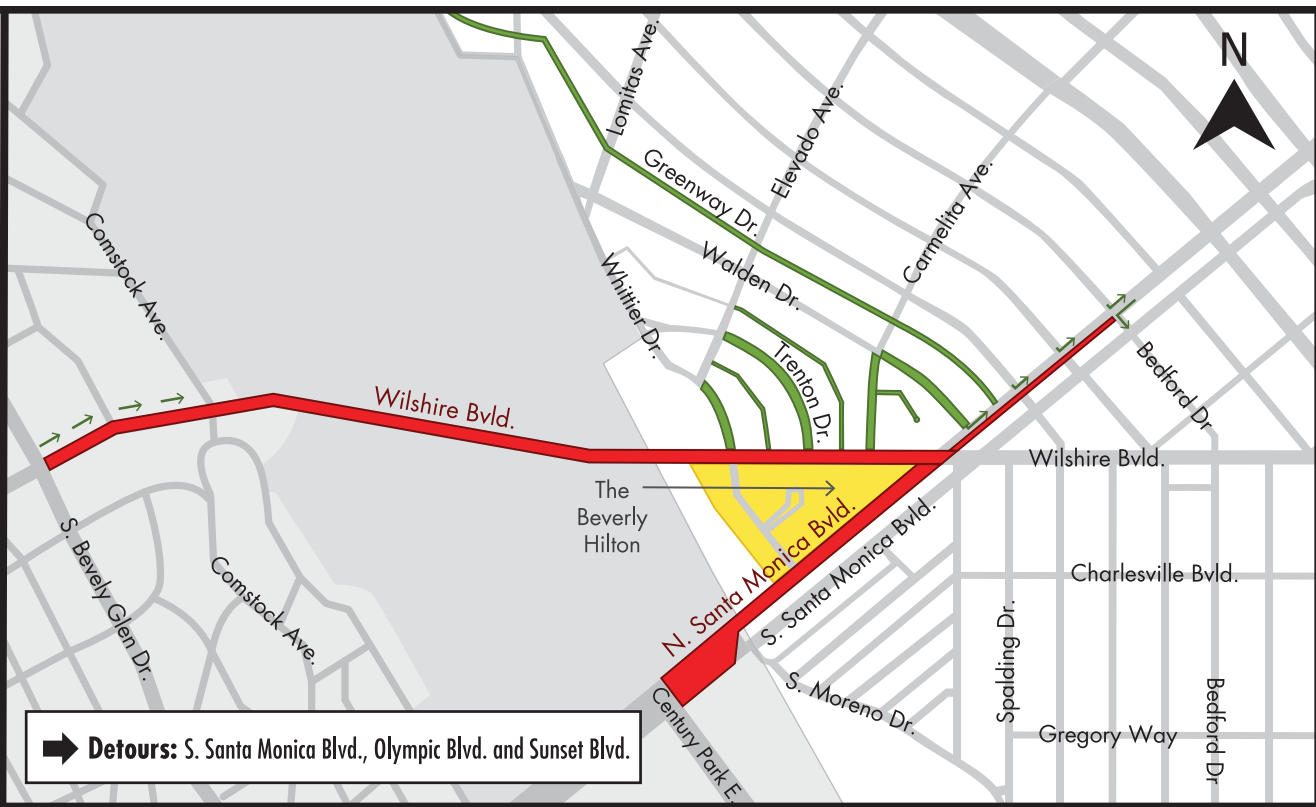

Beverly Hills Piano Teacher Charged With Sexually Abusing Student

Los Angeles County District Attorney Nathan Hochman announced that 41-year-old Beverly Hills music teacher Hovanesh John Jihanyan has been charged with sexually abusing his 13-year-old piano student between August 1 and November 9. The victim turned 14 during the time of the alleged abuse.

“I am appalled by these horrific acts of sexual abuse against a vulnerable child,” Hochman said. “Our office has a long history of aggressively prosecuting child abuse cases, and we are fully committed to seeking justice for the victim and their family. The skilled and dedicated prosecutors in our Sex Crimes Division will ensure any criminal who targets children is held accountable. We believe there may be additional victims, and we encourage anyone with information to come forward and contact the Santa Monica Police Department.”

Jihanyan is charged with one felony count of continuous sexual abuse of a child under 14; one felony count of forcible oral copulation of a minor victim over 14 years; one felony count of sexual penetration of a minor under 16 years; one felony count of unlawful sexual intercourse with a minor under 16 years; one felony count of sodomy of a child under 16 years; and one felony count of a lewd act upon a child age 14 or 15.

According to prosecutors, Jihanyan was the victim’s piano teacher. Between August 1 and November 9, Jihanyan allegedly continuously sexually abused the victim during piano lessons.

Jihanyan was arrested on December 12 and is being held on \$1 million bail.

If convicted as charged, the defendant faces a maximum sentence of 29 years in state prison and will be required to register as a sex offender for life.

BHPD Launches E-Vehicle Safety Education Program

The Beverly Hills Police Department (BHPD) and Beverly Hills Unified School District (BHUSD) have launched a comprehensive education and enforcement program for e-vehicles, in an effort to prioritize the safety of students, residents, and community.

In this joint effort, BHUSD will implement an E-Vehicle Permit Program, where BHUSD students and parents will sign an agreement acknowledging their understanding of the laws and rules of both the California Vehicle Code and BHUSD in order to park on campus.

The BHUSD Board of Education will be formalizing this initiative into board policy at a later date.

Beverly Hills Man Charged in Largest NFT Scheme Prosecuted to Date

A six-count indictment was unsealed in Los Angeles charging two California men with defrauding investors of more than \$22 million in cryptocurrency through a series of digital asset project “rug pulls,” a type of fraud scheme in which the creator of a nonfungible token (NFT) or other digital asset project solicits funds from investors for the project and then abruptly abandons the project and fraudulently retains investors’ funds.

Both men were arrested by Homeland Security Investigations (HSI) in Los Angeles.

According to court documents, from May 2021 to May 2024, Gabriel Hay, 23, of Beverly Hills, and Gavin Mayo, 23, of Thousand Oaks, sponsored several NFT and other digital asset projects and undertook promotional activities in support of those projects. Hay and Mayo allegedly made or caused others to make materially false and misleading statements regarding the digital asset projects being launched and provided false and misleading project “roadmaps” detailing plans for the NFTs or other digital asset projects after their launch that the sponsors never intended to fulfill.

For example, the indictment alleges that in promoting the Vault of Gems NFT project, Hay and Mayo falsely claimed that the project would be the “first NFT project to be pegged to a hard asset.” However, instead of pursuing the Vault of Gems project or others as they had represented they would, Hay and

Aidan Riley Scribbick and Gabriella “GG” Gonzaba, both originally from Alamo Heights, Texas, have announced their engagement. GG currently resides in Beverly Hills.

Mayo allegedly abandoned the projects after collecting millions in funds from investors.

“Gabriel Hay and Gavin Mayo allegedly defrauded investors in digital asset projects of tens of millions of dollars and threatened an individual who attempted to expose their roles in these fraudulent schemes,” said Principal Deputy Attorney General Nicole M. Argentieri, head of the Justice Department’s Criminal Division. “Fraudsters take advantage of new technologies and financial products to steal investors’ hard-earned money. The department is committed to protecting investors and will continue to work with our law enforcement partners to root out fraud involving cryptocurrency and other digital assets and bring offenders to justice.”

Hay, Mayo, and others allegedly used these tactics with a variety of digital asset projects, including Vault of Gems, Faceless, Sinful Souls, Clout Coin, Dirty Dogs, Uncovered, MoonPortal, Squiggles, and Roost Coin. Hay and Mayo also allegedly used a variety of means to conceal their involvement in the fraudulent projects by falsely identifying other individuals or causing other individuals to be falsely identified as owners of the projects. When one project manager on the Faceless NFT project exposed Hay and Mayo as being behind that project, Hay and Mayo allegedly embarked on a harassment campaign against the project manager, sending or causing the sending of messages to the project manager and his parents for the purpose of intimidating him and his family and causing them great emotional distress.

Hay and Mayo are each charged with one count of conspiracy to commit wire fraud, two counts of wire fraud, and one

Fond Memories of December 25

While I have always identified as Jewish, I have fond memories of some of the eighty-two December 25ths of my life.

This is notwithstanding the fact that I have serious resentments of the fact that my December 15th birthday always falls in close proximity with Christmas Day and Chanukah. There have been just too many combined presents. But I digress.

My father was raised in an orthodox Jewish home but my mother, who was the monarch of our home, was raised by agnostic parents. While I have no memories of my first few December 25ths, I recall one that came shortly after my 4th birthday. We then lived in a small one-bedroom apartment on 14th Street near Military Road in North West Washington, DC. "We" included my mother, my father and my agnostic maternal grandmother, **Ernestine Littman**, who had immigrated to the US from Bucharest, Romania in around 1900.

My mother decided that I would miss something if we did not celebrate Christmas so she decorated a small 3' pine tree

and placed a small pile of presents which greeted me when I woke up on the morning of December 25. And I was told that a person named Santa Claus had left them for me because I had been a very good boy. (I have never been accused of that again.) After that occasion, my father must have decided that Christmas trees sent the wrong message to a young boy who was about to start Hebrew School so there were no more trees.

I do not believe that my younger brothers had the thrill of finding presents under a tree on Christmas morning. But there may have been one or two Hanukkah bushes.

When I was seven or eight or so, I started my compulsory music career with flute lessons from our neighbor, Dominic Iascone. The lessons were in his kitchen. Shortly after that, I was "enlisted" in the Washington, DC Metropolitan Police Boys' Club Band which was modeled after the United States Marine Corp Band. We had dashing red coats, navy blue pants with a red stripe and a blue hat. Our conductor was a retired Marine Corps band leader, Col. **Leon Brusiloff**. As a flute player, I was always positioned directly in front of him. I know

that I was his favorite because of the numerous times he would hit me on the top of my head with his whip like baton. Presumably because I had hit the wrong note but I am not certain of that. If this tactic was employed to correct me, it was not effective.

Why do I mention this in a column about Christmas? Because every Christmas Day, starting around 5am, we would put on our

marching uniforms, including capes for warmth, and visit hospitals and homes for the aged and play Christmas carol concerts on their lawns. The last stop was the White House lawn where we would serenade the President and his family. I do not recall that the President ever made an appearance. I do recall, however, that it was always very cold and there is nothing like the feel of a frozen piccolo on your lips while trying to get through the solo of the Stars and Stripes Forever.

It is important to note that, while I learned to play a number of instruments apart from flute and piccolo, my lack of enthusiasm for any of them was matched only by my lack of talent.

This career ended when I went off to Washington University in St. Louis. For the Christmas holiday during my first year, I took a train home. The journey was scheduled to last about thirty hours. But then it snowed and snowed and snowed. As a result, the windows by my seat (not a sleeper cabin) frosted over. Of course, the heaters were ineffective. And the ride went on and on with some interruptions to clear the tracks. Seventy-two hours later,

we arrived at DC's Union Station. And Christmas Day had passed. I never tried that again.

In 1968, Christmas Day to me was just weird. I had spent the year teaching tort and contract law at Monash University in Melbourne, Australia. I was preparing to return to the US but not before experiencing Christmas Day downunder. The end of December there marks the end of the academic year and the start of summer vacations. The weather is sunny and hot, very hot. Nonetheless, as in the northern hemisphere, depictions of Santa and his red winter coat and his reindeer drawn sleigh are everywhere. How weird is that!

My first wife, Carol, was not Jewish and Christmas Day was taken very seriously by her family in Shreveport, La. There were always piles of presents under a magnificently decorated tree and the main event of the holiday was on Christmas morning and was called "doing the tree." This meant that a family member Santa would distribute the presents one by one. The process took at least an hour and left everyone happy with their new toys or ugly neckties.

Years later, we generally spent the school December holidays in Maui. Overtime, I learned to be comfortable with sleigh bells ringing in the tropics. And learned to say: "Meli Kalikimata" or "Merry Christmas" in the Hawaiian language.

The best part of this time of year is the widespread holiday spirit of family and friends and the whole community which can be shared by all whether you believe in Santa Claus or not.
