Media Teacher's Leave **Sparks Debate Over** Censorship

The indefinite administrative leave of Romeo Carey, a long-time media teacher and director of the KBEV broadcasting program at Beverly High, has ignited discussion within the school district and the community about free speech rights versus the concerns of the administration. Carey, who

The controversy stems from an incident involving a segment produced by Carey's students that criticized the behavior of a district administrator. The segment, aired on the district's KBEV YouTube channel, alleged inappropriate and aggressive behavior by Director of Safety Mark Mead, who had reportedly faced previous complaints from staff. Shortly after the segment aired, Carey was placed on administrative

Students expressed concern and outrage over the incident, where they claim Mead allegedly used excessive force by choking a student during election demonstrations at Beverly High.

His supporters argue that his administrative leave, which has now extended beyond six weeks, is a response to his refusal to compromise journalistic integrity and his defense of students' free expression under Educational Code 48907, which was intended to protect student journalists from

"I agree that this is a violation of Education Code section 48907. I don't see anything in the video that was obscene, libelous, slanderous, or that would constitute incitement to a clear or present dangerthose being the only exceptions to the free speech rights of public school students. Any employee disciplined for upholding the propriety of that video would seem to have a valid claim against the school district for violating that education code section," First Amendment Attorney Douglas Mirell said.


WIZO Holds Screening Of Beyond October 7th **Documentary**

"If this discipline is being imposed solely for posting the YouTube video, that constitutes a violation of Education Code section 48907. The section states that an employee shall not be dismissed, suspended, disciplined, reassigned, transferred, or otherwise retaliated against solely for protecting a student engaged in conduct authorized under the section, which in this case is simply students speaking their minds," Mirell said.

Beverly Hills AYSO Community Field Unveiled at El Rodeo Elementary School

The sign which officially names "The Beverly Hills AYSO Community Field" at El Rodeo Elementary School was unveiled last week. Present were members of the Beverly Hills City Council, City Staff, BHUSD Board of Education, AYSO 76 Board, and Beverly Hills Education Foundation (BHEF) Board. In August, 2024, AYSO 76 presented a \$350,000 check to BHEF targeted specifically for this field, which is available to the community after school and on weekends as part of the Joint Powers Agreement between the City and BHUSD.

by SkillsUSA in California for over a decade and earning second place nationally last year under his guidance.

During a Board of Education meeting on Oct. 8, Carey also spoke out against what he described as attempts to censor the school's journalism class and accused the district of engaging in censorship over a situation involving a student attempting to record a PTA and CTE meeting on Sept. 26.

According to his public comment at that meeting, the student was questioned for recording the PTA meeting but asserted their right to do so, citing public access and transparency. The student's camera, left recording at the CTE meeting, was confiscated. Carey noted that the camera was returned, but the memory cards had been erased-which sparked his concern over the deletion of footage.

Carey said that the student was reportedly interrogated by school officials the next day and expressed concern over the treatment of the student, calling it inappropriate and wrong to "interrogate" someone simply for engaging in journalism.

"Reinstate Romeo Carey immediately. The outpouring of support, the stories current and former students shared about his impact on their lives, plus the admiration and love for Romeo Carey at the Board meeting on Jan. 28 should be enough to end the farce. Anything less is an attack on journalistic integrity, academic freedom, and basic fairness," parent spokesperson Robbie Curtis said.

Preferential Parking Zone "G" for North Maple Drive

The Beverly Hills City Council has approved the establishment of Preferential Parking Permit Zone "G" for the 200 and 300 blocks of North Maple Drive, between Burton Way and Clifton Way. The new regulation, which enforces "No Parking Anytime, Permit 'G' Exempt," aims to address concerns from residents over commuter parking in the area.

The decision follows a unanimous recommendation by the Traffic and Parking Commission, which reviewed resident-initiated petitions during its December 5, 2024, meeting. The move is expected to address challenges caused by employee parking from nearby businesses and restaurants, which residents reported as leading to limited parking availability, noise disturbances, and littering.

Prior to the change, the 200 and 300 blocks of North Maple Drive operated under a "2-Hour Parking, 8 a.m. to 6 p.m., Except Sunday" regulation, with additional overnight and street sweeping restrictions. However, residents petitioned for stricter controls, citing the ongoing impact of commuter parking on their quality of life.

During the December commission meeting, staff initially proposed a compromise regulation mirroring the existing Zone "G" rules on North Elm Drive, which would have allowed flexible daytime parking for service workers and visitors. However, following public input, the commission supported the petitioners' request for a stricter "No Parking Anytime" rule, aligning with other streets in the area already operating under similar regulations.

Residents spoke at the commission meeting, sharing their concerns and support for the proposed regulation.

The City will install 14 new "No Parking Anytime, Permit 'G' Exempt" signs on the affected blocks, with an estimated cost of \$2,800 for materials and labor.

Beverly Hills City Council Postpones Decision on Permanent Short-Term Rental Regulations

At Tuesday's meeting, the Beverly Hills City Council postponed its review of proposed amendments to the permanent short-term rental regulations to an unspecified future date. This decision follows the adoption of an urgency ordinance on January 16, temporarily suspending the existing short-

term rental rules for 90 days to provide emergency housing for those displaced by the Los Angeles County wildfires earlier this month.

The urgency ordinance allows single-family homes in Beverly Hills to be utilized as short-term rentals without restriction through April 16, 2025. The measure was enacted to offer immediate relief for wildfire victims in neighboring jurisdictions

Before the emergency situation, the City Council had been addressing ongoing concerns about the impact of short-term rentals on residential neighborhoods. These concerns included increased noise, traffic, and the potential loss of long-term housing options in Beverly Hills. Following City Council direction, the Planning Commission conducted an in-depth review of short-term rental regulations during meetings in August and November of 2024, ultimately recommending several amendments for consideration.

Until the extension is lifted, short-term rentals will need to comply with both state law and the Beverly Hills Municipal Code prohibiting price gouging in which rental rates cannot exceed 10% above the most recently charged rate. If a property is being used as a short-term rental for the first time, a price limit will also be established.

The ordinance will also exempt both emergency short-term rental units and hotel rooms subject to provisions of the ordinance from Transient Occupancy Tax (TOT) and will exempt short-term property owners from paying business tax when not already otherwise required for their rental properties.

The City Council also previously extended the delinquency date for payment of the 2025 business tax for two months for businesses offering personal services such as hair and nail salons.

City Council Explores Ministerial Permit Process for Builder's Remedy Projects

On January 28, the City Council discussed the potential establishment of an alternative ministerial permit process for housing development projects subject to the "Builder's Remedy" provisions. This proposal aims to incentivize developers to modify projects to meet objective criteria, in an effort to better align new developments with the city's existing standards.

The Builder's Remedy allows qualifying housing projects that meet affordability requirements to bypass local zoning regulations in jurisdictions without a certified housing element, limiting cities' ability to deny such developments. Beverly Hills adopted its Housing Element in March 2024, which was certified by the state in May 2024. However, prior to certification, 19 preliminary applications were submitted under Builder's Remedy, vesting these projects under pre-certification rules.

Of the 19 applications, three have been withdrawn, and two were disqualified for exceeding the scope of their preliminary applications. The city is currently reviewing 14 Builder's Remedy projects, according to a city staff report, and many of these projects exceed existing development standards in height and density.

Local Surgery Center Receives "Award for ASC Excellence"

Linden Surgical Center received the "Award for ASC Excellence" by the California Ambulatory Surgery Association (CASA). Linden Surgical Center is a multi-specialty surgery center serving both adult and pediatric patients.

To address these concerns, the City Council discussed creating a ministerial permit process that would streamline project approvals for developers willing to scale down their projects. Ministerial permits are non-discretionary, providing clear standards for approval without the need for public hearings or certain evaluations by city officials.

According to a city staff report, this process could reduce barriers for developers, including time and costs associated with environmental reviews, which are not required for ministerial approvals. However, this approach would limit public input and eliminate appeal options.

The City Council expressed concern over the increasing number of Builders Remedy projects.

One benefit discussed about exploring a ministerial permit process is that it could be seen as a potential compromise, allowing the city to impose reasonable conditions while avoiding excessive litigation or the risk of losing housing element certification.

Additionally, concerns were also raised about high-rise buildings altering the city's character, and council members discussed strategies to mitigate these developments within legal constraints.

Though no final decision was made, the matter will be brought to the Planning Commission to study the topic and provide suggestions to the City Council.

Beverly Hills City Council Approves Extension and Update to Price Gouging Prohibitions

On January 28, the City Council extended the price gouging prohibitions and approved measures to align its regulations more closely with California state law.

The decision came after the Governor's declaration of a state of emergency for Los Angeles County on January 7 due to the wildfires.

The vote to extend Beverly Hills' price gouging prohibitions was originally set to expire on February 6.

These changes are expected to ensure that Beverly Hills' price gouging laws cover a broader range of goods and services, as well as housing protections, including limits on evictions and subsequent rent increases during emergencies.

City Council Approves Plan to Convert Parking Garage Space to Retail on North Roxbury Drive

At its January 28 meeting, the City Council approved a resolution and ordinance to amend the city's General Plan and Municipal Code, which will enable the conversion of 6,797 square feet of parking garage space at 450 North Roxbury Drive into four retail tenant spaces.

Additionally, the City Council approved an ordinance to amend the Beverly Hills Municipal Code, increasing the maximum allowable floor area ratio for certain buildings in C-3 commercial zones.

The project involves converting a portion of the ground-floor parking area of an existing five-story parking garage into retail spaces. The parking garage is part of a larger development that includes a 10-story office building. While the property's current floor area ratio of 2.65 already exceeds the city's 2.0 floor area ratio limit for the C-3 zone, the ordinance allows an increase in floor area ratio to 2.84 for specific properties within the Business Triangle to facilitate the conversion of ground-level parking into retail.

The change only applies to buildings in the Business Triangle with similar characteristics to the project site, such as multi-story office buildings with street-facing parking garages. A review identified one additional property within the Business Triangle that may qualify under the amended ordinance, located at 462 Linden Drive/9780 South Santa Monica Boulevard.

The Planning Commission first reviewed the project in November 2024. One point of discussion included improving the pedestrian experience along North Roxbury

Beverly Hills City Council Officially Recognizes January 27 as International Holocaust Remembrance Day

The Beverly Hills City Council has officially adopted a resolution recognizing January 27 as International Holocaust Remembrance Day. The resolution was approved during the January 28 meeting.

International Holocaust Remembrance Day, established by the United Nations General Assembly in 2005, marks the anniversary of the liberation of Auschwitz-Birkenau concentration camp. What made you want to join the commission?

I am a financial advisor, and I help people make decisions with finite resources—namely their money and their

time. And similarly, as a commissioner, that's what we're enabling the city council to do: Make tough decisions with finite resources.

And I've always been drawn to civic servitude. It's in my DNA. My grandfather was the state senator for Beverly Hills when I was growing up. He worked closely with Mayor Les Friedman. My other grandpa was a physician. So health and safety is kind of an organic passion of mine.

Prior to finance, I was in public health for about ten years. So anytime I can help people—community members-make an informed decision, that's always very exciting to

Professionally, running a wealth management firm, we define here. From our worldwealth holistically. We believe that somebody's wealth is a function of their health, their money, and how they spend their time.

As a Beverly Hills resident, a small business owner, and a parent in our city, I understand and am empathetic to

the myriad concerns and competing resources involved in these decisions.

I think Beverly Hills is the best community in the world. I spent about a decade in Hanover, New Hampshire, for college and graduate school at Dartmouth. Hanover is a small town of 10,000 people, but Beverly Hills has that same small-town feel. So that's where I'm coming from.

Tell us more about your grandfather, the late State Senator Herschel Rosen-

He was in the state legislature for the majority of my childhood. He graduated from UCLA and opened the first printing press in Los Angeles.

He ran his business with such business acumen, with such compassion and heart. He provided health insurance for all of his employees, which was a very novel concept back then.

Now, we sort of take it for granted you know, starting a new job and often getting health insurance benefits on your first day of onboarding. But small business owners take on that liability and expense, and that's what he did-well before it was a normalized part of employment.

Within his business, he gained notoriety, got involved politically with local government, and was eventually asked to run for Assembly. He was elected to the California State Senate in 1982.

You are a Wealth Management Advisor. Tell us more about your career.

passionate ľm about helping people make challenging decisions. That's what gives me purpose. That's what fulfills me. It was certainly a non-linear path to get here. I majored in English Literature at Dart-

mouth, and I've always been intrigued by the nuances of people, their stories, and human thought.

Running a wealth management team allows me to indulge in both the art and the science. There are evidence-based gold standards in financial planning and financial security. We have foundational principles that strengthen financial portfolios and accelerate net worth. But financial planning also flexes an artistic muscle. I think the best strategies are bespoke, creative, and designed to truly improve lives.

Given my grandfather's legacy, my background in healthcare, and my experience in wealth management, I truly believe wealth and health are the heartbeat of society. Professionally, as a financial advisor and fiduciary, I get to help people make data-informed decisions that are financially prudent.

Like everyone else, no two days are the same, and no two clients are the same. We help people navigate both the macro volatilities of the stock market and the micro volatilities of day-to-day life. Financial pictures can change on a dime. Something could adversely affect their health, or, as we've seen in LA with the wildfires.

What are some things the Commission is currently working on?

Like the chairs before me, we definitely want our commission's scope to be iterative, based on community needs and what City Council requests of us. It's important to me, as the leader of the commission, that we remain nimble.

For this year's themes, we are focusing on the social determinants of health. These are essentially the non-medical factors that impact health and longevity. Think about the conditions or environments where people are born, live, learn, work, play, and worship. This year, we're asking ourselves: What can we operationalize? What can we, individually or collectively as a community, do to optimize the health and safety outcomes of our city?

How do we keep our community resilient and adaptable? For example, considering the wildfires in LA, how can we be good, supportive neighbors? How do we ensure Beverly Hills remains a global beacon of health and safety? We know people around the world look to us to see how we tackle certain issues, so how can we stay at the forefront of those initiatives and trends?

Since I've been a commissioner, we've implemented so many wonderful initiatives. For example, we've improved emergency preparedness by helping residents access emergency water supplies and making it easy for people to get fire extinguishers—not just for personal use, but with training on how to use them effectively at home. Vice Chair Erica Felsenthal worked hard on expanding access to mental health resources, and I want to continue building on those efforts and deepening their impact.

I also want to honor the work we've done on social media safety. Last year, the Council announced a Social Media Safety Day, and we're looking forward to expanding initiatives around keeping children and adults safe online. While social media use is on the rise, so is social isolation. Studies show people are feeling less connected to others and their communities, despite all the "networking" and scrolling we do online.

So, how do we optimize for joy? How do we get people off their screens, moving more, enjoying our parks, and dining at our wonderful restaurants? These are questions I think about a lot.

I truly believe Beverly Hills is the wealthiest city in the world-not just financially, but in terms of quality of life, access to resources, the expertise of our first responders, and the vibrancy of our daily lives. As we've discussed, I want our commission to empower people to make informed decisions.

I hope Beverly Hills residents will tune in to what we're learning and sharing. My goal is for our community to take away something new and meaningful—and then implement it.

Tell us about your family.

My family—well, I often talk about my grandfather, Senator Herschel Rosenthal, because he's my role model. Oh, how lucky I am to have had a grandfather like that. And my children are my North Star. They're not only kind and intelligent, but I love their company. My little boy, Jack Herschel Rosenthal, he's four, and my daughter, Lily, just turned two.

Life is busy, no doubt about it, but I have a wonderful team at work that helps me stay present and productive. At home, we make it a point to have family dinner together every night—no phones at the

We love hiking in the mountains of LA. We're an active, adventurous family. I took my four-year-old, Jack, surfing in Malibu for his birthday last year, and it was awesome

As it relates to health, safety, and my passion for advocating for these types of initiatives, I know firsthand how isolating and challenging it can be, especially as a parent. I became a mom during the pandemic, having two babies in such a difficult time globally. Seeing how resourceful and supportive our city was during that period was validating.

The only commission meeting I've ever missed was for Lily's birthday two years ago. I've seen first-hand that raising children takes a village, and I'm so fortunate that my parents live in Beverly Hills. They graduated from the Beverly Hills Citizens Academy last year, which is such a fantastic program run through the police department—they absolutely loved it.

Our family roots here run deep. Four of my great-grandparents lived in Beverly Hills. I truly believe Beverly Hills is the best city in the world.





OBITUARIES Jerrold S. Felsenthal June 4, 1945 – January 17, 2025

Jerrold "Jerry" S. Felsenthal (June 4, 1945 – January 17, 2025) was a beloved husband, father, and grandfather, who lived a dignified life, replete with service to his community and dedication to his family. Born in Los Angeles to Irma and Leo Felsenthal, who had both escaped Nazi Germany, Jerry grew up in Huntington Park. His father was a cattle dealer and his grandfather, Gustav, who had survived Dachau, was his first babysitter. His first language was German. He was a member of the Huntington Park Hebrew Congregation, where many of the congregants were refugees. The fact of the Holocaust never left his consciousness. Deeply proud of his



Jewish heritage, he maintained the traditions throughout his life. He was the valedictorian at Huntington Park High School (Class of '63). While serving in the Army Reserve, his education continued at Cal State Long Beach, before he attended the University of Southern California and the London School of Economics. His father died when he was a teenager and his uncle, Alfred Stern, became his mentor, taking him around to construction sites, teaching him to read plans, and igniting a passion in Jerry for real estate, which became his vocation. He met his wife, Judy, on a blind date; and during their fifty-four years together, they travelled the world and raised three children and three grandchildren.

A well-respected developer, Jerry had a keen eye for aesthetics and beautified the properties that he managed, often creating intricate, drought-resistant landscaping and incorporating authentic restoration. A principal example is the much-loved El Paseo building in Westwood Village, which features an eight-pointed star fountain, alongside Spanish ceramic tiles, hand-painted frescoes, and blue-and-gold-stenciled wooden beams. With a lifetime of knowledge about industrial real estate and a distinctive vision, Jerry changed the landscape of Los Angeles and mentored countless young professionals along the way.

A voracious reader, Jerry always had a book recommendation ready. He loved literature and was a prolific letter writer, who believed that correspondence was good for the soul. He was a quintessential Renaissance man whose interests included flower arrangement, gardening, painting, photography, poetry, sculpture, and travel

He was deeply involved in community service. He served on the Board of Sinai Temple and helped secure the land for Mount Sinai Memorial Park in Simi Valley, where his funeral service was held. He was Commission Chairman of both the Beverly Hills Planning Commission and the Public Works Commission. In December, 2024, Jerry was officially recognized by the Health and Safety Commission, the Mayor of Beverly Hills, and the City Council. He was celebrated by fellow commissioners as well as members of the public for his contributions to emergency preparedness and community resiliency. During his tenure, he championed the development of new local water supplies; increased water storage; created an integrated water resource master plan; and supported the move forward by joining the Clean Power Alliance for Renewable Energy. A strong advocate of the Beverly Hills community, his involvement in various projects bettered the city. These projects included the reconstruction of North Santa Monica Boulevard, safe plugging of former Venoco oil wells at Beverly Hills High School, major water main replacements on Loma Vista Drive, and water treatment plant rehabilitation and expansion. Without needing recognition, he also played a crucial role behind-the-scenes, providing pro-bono support, for many non-profit organizations.

He served as a Board Member and past President of Hillcrest Country Club. In recognition of their community service and philanthropy, Jerry and Judy were both presented with Lifetime Achievement Awards from the Hillcrest Country Club and the Jewish Vocational Service of Southern California (JVS SoCal). A lover of music, especially opera, he became a benefactor of The Music Center and Disney Hall.

He is survived by his wife, Judy; his eldest son, Leland (Erica) Felsenthal, and their children, Violet and Zoey; his daughter, Lisa (David) Neipris, and their daughter, Daisy; and his youngest son, Alan (Will) Felsenthal.
