#### **BHUSD Superintendent** Resigns


The BHUSD announced the resignation of Superintendent Michael Bregy, effective February 24. Jason Hasty, Assistant Superintendent of Business Services, will assume the role of Acting Superintendent.

Bregy was first hired in 2017. He had previously served as principal of Jacobs High School in Algonquin, ILL., and then was superintendent in two school districts in Highland Park, Ill., prior to coming to Beverly Hills.

During his tenure at BHUSD, he led initiatives, including the district's reconfiguration in 2019, which was intended to

expand elective offerings enhance student learning experiences.

Under Bregy's leadership, BHUSD established the NormanAid and BulldogAid Wellness Centers. He also oversaw infra-



structure projects, including the grand reopening of El Rodeo Elementary School and the completion of Buildings B1 and B2 at Beverly High.

"We respect Superintendent Bregy's decision and appreciate the hard work and dedication he brought to our District," said Board of Education President Rachelle Marcus. "As we move forward, we are committed to ensuring a seamless transition that supports our students, staff, and community.'

The Board of Education has indicated it will conduct a search for a new superinten-

#### **State Senator Ben Allen Urges BHUSD to Enroll More Displaced Pali High Students**

California State Senator Ben Allen (D-Santa Monica) is urging the BHUSD to enroll more students from Palisades Charter High School, which was severely damaged in the Palisades Fire last month.

The fire, which erupted on January 7, destroyed approximately 40% of the high school campus, forcing students and families to seek alternative educational options. While BHUSD initially enrolled nearly 50 displaced students across all four high

school grades, the district has since paused further enrollments, citing capacity concerns and staffing limitations.

Allen has indicated that he would like to assure BHU-SD that financial concerns

should not prevent the district from accepting additional students. He stated that legislative leaders and the governor's office have committed to reimbursing schools that take in displaced students.

'Pali High students have had their lives turned upside down, and there are ways that community leaders can step up right now to provide meaningful relief for these families and their kids," Allen said.

During a special board meeting, BHU-SD officials discussed the challenges of admitting additional students. According to district officials, 151 more students have expressed interest in enrolling, but further admissions would require hiring additional staff. Former Superintendent Michael Bregy noted that each applicant's transcripts must be individually reviewed to determine class placement and teacher availability, adding to the logistical challenges.

"BHUSD cited financial concerns as their main reason for declining enrollment for a number of displaced students. In that respect, I have only been trying to relay the message to them that there is commitment from Legislative leadership and the Governor's Office for the State to provide financial reimbursement to schools that take in displaced students. They aren't being asked to pick up these burdens alone; we will be with them through this effort every step of the way," Allen said.

According to district officials, none of the students enrolled so far have lost their homes in the fire.

Under updated enrollment guidelines, new applicants from fire-affected areas must provide proof of displacement, such as a FEMA card or insurance claim documentation. Residency checks will also be conducted throughout the school year.

Several parents of Palisades High students voiced frustration during a previous board meeting, stating they had been led to believe their children could enroll, only to later be denied. One parent emphasized that her children had already endured significant trauma from the fire and that inconsistent communication had worsened the situation.

Beverly High has approximately 1,200 students but can accommodate up to 2,500. While BHUSD has provided support for some displaced students, other districts, including Manhattan Beach Unified and Las Virgenes Unified, have also accepted students affected by the fire.

Palisades Charter High School had nearly 3,000 students before the fire. While the school has transitioned to online learning, many families have sought in-person options.

#### **Commission to Review Proposed Cartier Building on** Rodeo Drive

The Beverly Hills Planning Commission is set to review a proposed development at 370 North Rodeo Drive, the future site of a new three-story commercial building for luxury retailer Cartier, at its Thursday meet-

Richemont North America Inc., the parent company of Cartier, has submitted a request for a Development Plan Review to

construct a new three-story, 45-foot-tall retail building on the property. The proposed structure will feature a basement level and an outdoor terrace on a portion of the third floor. The building's design includes materials such as metal canopies, glazed awnings, and bronze, white, and light grey façade panels.

The location was previously occupied by a two-story commercial building, which was demolished in early 2024.

A similar project for Cartier was initially approved in 2018, allowing for the demolition of the prior building and construction of a three-story structure. However, the project's approvals expired following two extensions in 2021 and 2022, according to a city staff report. The current proposal closely mirrors the previous plan but does not require in-lieu parking under Assembly Bill 2097, which restricts cities from enforcing minimum parking requirements for developments near major transit stops.

The new building will not include on-site parking, as the project site is approximately 0.36 miles from the upcoming Wilshire/Rodeo Metro Station. The city previously determined that nearby public parking structures could accommodate parking demands, according to a city staff report. A transportation assessment estimates that the project will generate an additional 20 morning peak-hour trips, 50 evening peak-hour trips on weekdays, and 65 peak-hour trips on Saturdays. However, the analysis concludes that these increases will not significantly impact traffic flow at nearby intersections.

A setback of 25 feet and 8 inches at the rear of the first floor is expected to provide space for valet and loading operations, while the second and third floors will extend to the property line. The project also includes a basement-level transformer room that will require a permanent encroachment into the public right-of-way on Brighton Way.

The Beverly Hills Planning Commission will review the project on February 27.

#### **Beverly Hills Police Officer Runs for Office in Texas**

Alexander Duncan, a Beverly Hills Police Department (BHPD) officer, has announced his candidacy for public office in Texas in an effort to replace Sen. John Cornyn. The City of Beverly Hills has reached an agreement with the Los Angeles County Metropolitan Transportation Authority (Metro), to close Wilshire Boulevard between El Camino Drive and Crescent Drive for three weeks, from March 17 to April 7.

This full closure will allow for the expedited removal of deck panels and full road-way restoration as part of the Wilshire/Rodeo Metro Station construction.

Metro had originally planned on 18-weekend road closures for removal of deck panels and roadway restoration of Wilshire Boulevard as the city and Metro had previ-

ously agreed to in the 2019 Memorandum of Agreement (MOA). In late 2024, Metro proposed an alternative three-week closure option to expedite the project and shorten the overall disruption to the community.

Prior to the decision being made, the city conducted community outreach, presenting both construction timeline options to residents and businesses near the street closures. The City Council reviewed the proposed deck removal alternative with a three-week closure option during meetings on January 28 and February 5.

In addition, South Reeves Drive at Wilshire Boulevard will be fully closed for approximately three weeks prior to the Wilshire Boulevard closure, starting February 24. A 16-foot sound barrier will be installed along the south side of the South Reeves Drive closure area to minimize construction noise. Access to the adjacent alley and building driveways will be maintained at all times.

#### BHUSD Shocker/Homeless Count

Late in the day on Friday February 21, I was very surprised to receive a copy of a letter signed by all five members of the Board of Education (the Board) announcing that Superintendent Dr. Michael Bregy had "resigned" effective on Monday February 24.

(See brief on page 3).

I was very surprised for several reasons. In August, 2024, the School Board had unanimously approved a three year extension of Dr. Bregy's contract even though his then existing contract ran until mid-2025. Although I stay informed about BHUSD, I had no inkling that Dr. Bregy's eight year tenure was possibly coming to an early end. Finally, the departure of a Superintendent in the middle of the academic year is always an unusual event.

Naturally, I wanted to find out what had happened and made numerous inquiries and learned nothing useful. Those who know aren't talking and those who are talking don't know.

Ultimately, I concluded that it did not matter. What matters now is expressing appreciation to Dr. Bregy for his many years of service in a very challenging position and, most importantly, finding the very best candidate to fill this position going forward.

I am hopeful that the Board will leave no stone unturned and get the best possible advice and assistance to identify the right person. And move expeditiously so that the new superintendent will be on board well in advance of the 2025-6 academic year.

While I understand the Board's silence about just what happened, some explaining will have to be done. This is because the first question that any qualified candidate will ask during the interview process will be the following:

"Dr. Bregy resigned in the middle of the academic year after eight years of service just six months after you had given him a generous contract extension. What happened?"

And the Board or its representatives will have to answer that question. A statement to the effect that we don't discuss personnel issues will not satisfy anyone that we should consider hiring. They have to know what they are

getting into.

I am hopeful that the Board has prepared an answer but, as I have stated above, I don't know what it is. However, I am prepared to offer my suggestion:

"Dr. Bregy served BHUSD well for a number of years. Nonetheless, academic performance of the District was not improving.

"In recent months, several specific issues arose.

"In the wake of the Presidential election, racial tensions among groups of students became heightened and some felt that this situation was not handled well.

"In a somewhat related incident, popular BHHS media teacher Romeo Carey who supervised the student run broadcasting service KBEV was suspended pending an investigation. This highly controversial situation (more than 900 members of the BHUSD community signed a petition demanding his reinstatement) was not concluded in a timely fashion.

"Most recently, in the wake of the horrendous Palisades fire, the District's handling of the potential enrollment of Palisades High students in BHHS managed to alienate all concerned.

"The Board and Dr. Bregy concluded that their communication had deteriorated, their views were not aligned and this led to his resignation."

Whatever the actual backstory may be, this explanation is not an unfair one and should serve to highlight both the importance of improving academics, some current issues and the reason for the mid-year departure.

My conclusion is that the details of the departure are not important. The identification of an educator as Superintendent who will restore BHUSD to the level of academic excellence that we properly demand is all that matters.

Every year, the Los Angeles Homeless Service Authority (LAHSA) conducts the "Greater Los Angeles Homeless Count" to survey the number of the unhoused in the region. The expressed objective, among other things, is to improve LAHSA's ability to serve and assist the homeless population. It is not at all clear to me how this objective is accomplished.

LAHSA is, according to its website, "the lead agency in the Los Angeles Continuum of Care, which is the regional planning body that coordinates housing and services for homeless families and individuals in Los Angeles County. LAHSA coordinates and manages Federal, State, County and City funds for programs that provide shelter, housing and services to

homeless persons in Los Angeles City and County."

Tremendous public resources are provided to and distributed by LAH-SA. The agency was established in 1993 and last year distributed more than \$800M mostly to non-profit organizations. Typically, these organizations are dedicated to finding pathways to permanent housing. LAHSA covers the entirety of Los Angeles County other than the cities of Long Beach, Pasadena and Glendale which have their own homeless agencies.

The Homeless Count is conducted annually by hundreds of volunteers and provides a point in time snapshot of the number of individuals who are unhoused. The results of the count show that the number of unhoused individuals has decreased over recent years while the shelter count has increased.

This year the count occurred from February 18 through 20. When I learned of the opportunity to volunteer, I signed up because I wanted to experience first hand just what is being done and was assigned to Los Angeles Mid-City West.

The entire process from start to finish was very professionally managed. Prior to the Count, the volunteers watch two training videos that explain just what to count and what not to count and how to record observations through an app for data collection.

However, it was apparent from the outset that this we were engaged in a process that could not be considered scientific by any measure.

The timing of the Count is the same each year, early evening at approximately 8p during weekdays to accomplish apples to apples comparisons from one year to the next. But most of the stores and restaurants in our area were open and the streets were full of people going about their business. It would have been impossible to determine which of them were homeless.

After watching videos, I was directed to come to the volunteer assembly site at the CBS Television parking lot at 200 N. Fairfax Ave in Los Angeles at 8:00p on Tuesday February 18. The volunteers are assigned to three person teams to conduct the count in a specific area. The teams include a driver, a

navigator and a counter who would record our observations on the app.

My team included Mike, an employee of the City of Los Angeles, and Adrienne, a young psychiatrist. Both were veterans of the Homeless Count. Mike had participated in three or four in this Mid-City area and Adrienne had participated in several while completing her medical training in New York City. As I was the rookie, I was assigned the easiest job of driver. All I had to do was follow navigator Mike's direction while Adrienne handled the challenging data entry job using the app.

We were assigned a zone of the district, roughly one square mile partly in the City of Los Angeles, partly in the City of West Hollywood, from Beverly Blvd on the south, Santa Monica Blvd on the north, La Cienega Blvd on the west and Kilkea Ave on the east. Our job was to drive up and down each street and alley and count the unhoused that we observed. We were firmly instructed that we should not engage with or disturb any individual in any way.

At around 8:15p we were sent on our way driving north on Fairfax and then west on Beverly. As we were getting started, I asked my veteran teammates for their estimates on the over/under as to how many unhoused we would observe. Neither would venture a guess but I thought that the number would be between ten and fifteen.

For the next ninety minutes, we drove slowly approximately fifteen miles and covered every street and alley in our zone including, unavoidably, some more than once as we sought to cover the entirety of the territory.

Bottom line – my estimate of ten to fifteen unhoused persons was wildly off the mark. We saw exactly ONE unhoused person who was camping in the space in an alley between an apartment building and the trash container. He smiled and waved as we passed. To bolster our count, we also identified one camper van that was a possible shelter.

When we returned to the assembly point to submit our results, we learned that our experience was typical as other teams reported seeing either no unhoused or, at most, one or two. I draw no conclusions except to note that our area was generally well lit, streets and alleys alike, and involved commercial areas that were lively in the early evening. There were no tents or encampments and no freeway underpasses which often serve as shelters.

And then my reward: I was presented with a LAHSA Certificate of Appreciation "for [my] commitment to improving our communities by assisting the homeless."

I will be there next year!!

> Our hotel in New Orleans was a much group-based hotel. Our staple busi-

ness consisted of larger corporate conventions.

Beverly Hills, on the other hand, is a much more luxurious marketplace. The travelers who come here are looking for ultra-luxury [experiences], which this hotel provides. The biggest difference between the two hotels is that in New Orleans, we primarily booked large groups, whereas in Beverly Hills, every guest is an individual booking. One of the things that differentiates us significantly is that we have unbelievable outdoor areas. Our balconies are huge, offering great views from all rooms. It is just the finest hotel in Beverly Hills.

The package here is amazing. We have a destination rooftop restaurant-something not all hotels can offer at the level we do. Along with that, our spa experience adds a true luxury experience that you would want to come and spend a

#### What inspired you to pursue a career in hospitality?

A long time ago, after finishing my master's degree, I was looking for a job, and the first one I found was as an activities director at an old-school resort in New Hampshire. I'm originally from Boston. I have an MBA, but that was the first opportunity I was able to find. Quite frankly, I just fell in love with the business. That's when I decided to take my education in this direction.


