Alex Cherniss Appointed as BHUSD Superintendent

The BHUSD has announced the appointment of Dr. Alex Cherniss as its next superintendent, following the resignation of former Superintendent Michael Bregy. The board approved the decision with a 3-2 vote, with Board President Rachelle Marcus and Board Member Mandy Stern dissenting.

“Dr. Cherniss is a proven, visionary leader whose deep connection to BHUSD and track record of success in high-performing districts make him the ideal choice to lead our schools into the future,” said Vice President Judy Manouchehri. “Our community values academic excellence, transparency, and strong communication—and Dr. Cherniss brings the leadership and experience to deliver on those priorities.”

Cherniss returned to BHUSD, where he began his career as a middle school math teacher at Beverly Vista, K-8 principal at Hawthorne, Director of Human Resources, and Assistant Superintendent of Business Services. He has since held superintendent roles at San Marino, Palos Verdes Peninsula, and Placentia-Yorba Linda Unified School Districts.

As superintendent in various districts, Cherniss dealt with different controversies.

After the November election, a new Board majority took office at PYLUSD. In December 2024, the PYLUSD Board of Education placed Cherniss on paid administrative leave.

Ahead of his return to Beverly Hills, a Change.org petition calling for Cherniss' resignation from PYLUSD garnered 871 signatures. The petition raised concerns

Beverly High Performs *Mary Poppins* at Saban Theatre in Spring Musical Production

Last week, Beverly High's Performing Arts Department staged *Mary Poppins* for the first time.

“This production of *Mary Poppins* was not only technically and artistically impressive, it was deeply meaningful for our school community,” said Drew Stewart, Principal of Beverly High. “It brought together so many students, on stage, behind the scenes, and in the orchestra, and reminded us all what can be achieved through dedication, teamwork, and the arts.”

Opening night also featured a visit from 1986 Beverly High graduate Robbie Sherman, whose father, Robert B. Sherman and uncle, Richard M. Sherman, were the songwriters for *Mary Poppins*.

about his employment history, including two construction projects: one in San Marino that reportedly grew from \$4 million to \$16 million, and another in Palos Verdes Peninsula that was never completed. It also cited a settled lawsuit from a former assistant superintendent who claimed retaliation after reporting alleged misconduct.

During his time at San Marino Unified, Cherniss was involved in a legal dispute with board member Chris Norgaard. According to the *Pasadena Star-News*,

Cherniss submitted declarations stating two employees had reported inappropriate behavior by Norgaard, prompting an internal investigation. Norgaard later sued the district for defamation, denying the allegations.

The Board of Education approved Cherniss' contract on Tuesday, which includes an annual base salary of \$350,000 and benefits such as health coverage and a \$700 monthly stipend.

The trip, which ran from March 26 to April 4, took students through cities such as Tokyo and Tsukuba. They visited science and technology institutions including the National Museum of Emerging Science and Innovation and the Japan Aerospace Exploration Agency.

“This program is a powerful example of how BHUSD brings learning to life beyond the classroom,” said BHUSD Director Mike Sherman. “Our students not only expanded their STEM knowledge, but also developed the global perspective and cultural literacy essential for thriving in the world ahead.”

Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider adoption of:

RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY HILLS AMENDING THE COMPREHENSIVE SCHEDULE OF TAXES, FEES AND CHARGES FOR THE FISCAL YEAR 2025-2026

The City Council will consider a resolution which will increase certain fees and service charges that are charged to the public for the various activities and services as set forth in the schedule for fiscal year 2025-2026. In some cases, fees are proposed for an adjustment by 3.2% based on the Consumer Price Index (CPI) for November 2024 to reflect the increase in the City's costs. In other cases, new fees are proposed to be established or existing fees to be adjusted to reflect a more equitable distribution of costs, or a change in service level. Most fees would become effective on July 1, 2025.

At the public hearing, the City Council will hear and consider all comments. All interested persons are invited to attend and speak or provide written comments on this matter.

The Planning Commission of the City of Beverly Hills, at a **SPECIAL** meeting on **Monday, May 5, 2025** will hold a public hearing beginning at **2:30 PM**, or as soon thereafter as the matter may be heard to consider:

DRAFT ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE BEVERLY HILLS MUNICIPAL CODE TO ESTABLISH AN ALTERNATIVE MINISTERIAL APPROVAL HOUSING DEVELOPMENT OVERLAY ZONE FOR PROJECTS SUBJECT TO GOVERNMENT CODE SECTION 65589.5, AND ADOPTING AN ADDENDUM TO THE MITIGATED NEGATIVE DECLARATION PREPARED FOR THE 2021-2029 CITY OF BEVERLY HILLS HOUSING ELEMENT.

The Planning Commission will be discussing the potential establishment of a housing development overlay zone that would allow for a ministerial permit process for projects that are subject to Government Code Section 65589.5, generally referred to as "Builder's Remedy" projects. Staff recommends that the Planning Commission adopt a resolution recommending the draft ordinance to the City Council for adoption.

Environmental Review

The zoning amendments were assessed in accordance with the authority and criteria contained in the CEQA, the State CEQA Guidelines, and the environmental regulations of the City. The Planning Commission recommends that the City Council find and determine that the ordinance is within the scope of and consistent with the Mitigated Negative Declaration (MND) for the Amendments to the Adopted 2021-2029 City of Beverly Hills Housing Element (State Clearinghouse No. 2021090102), which was adopted by the City Council on March 18, 2024 and certified by the State Department of Housing and Community Development on May 1, 2024 and consider an addendum. Staff has determined that there are no substantial changes to the circumstances under which the proposed project will be undertaken that will require major revisions to the previous MND. Therefore, the previously adopted MND is adequate upon the preparation of an addendum.

Open Letter to Superintendent Dr. Alex Cherniss

Welcome **Dr. Alex Cherniss** as the new Superintendent of the fabled Beverly Hills Unified School District.

From your past teaching and administrative experience with BHUSD, you are well acquainted with the community and the District. You know that the community is deeply involved with and committed to the success of our public schools. As a result, our schools are extremely well-financed. For the next academic year, we will spend approximately \$37,000 per student and have a student/teacher ratio reported by U.S. News & World Report in its public schools high school rankings as 15/1. The amount spent per student rivals the best private schools and the student/teacher ratio is far better than even the highest performing California public high schools.

Our facilities, including the brand new El Rodeo campus and the improvements completed and underway at Beverly High, are spectacular.

From your background both here and from your career as the Superintendents of the San Marino, Palos Verdes/Peninsula and Placentia/Yorba Linda Unified School Districts, a total of nearly nine years as a Superintendent, you know that the education of our children is important for many reasons. Well educated students are better citizens and better prepared to lead productive lives.

Once our schools were among the

best in the nation. This is no longer the case.

Notably, of the eight high schools in the Districts in which you served as Superintendent, **every one was ranked substantially higher than Beverly High** in the most recent U.S. News and World Report rankings – and Beverly High had substantially better student/teacher ratios than any of those.

While there are many issues confronting the District, the highest priority is improving the academic standards. The tools are there. The community is supportive and the resources are ample. The question is how to employ them.

Here are some thoughts.

High academic standards are lacking. The quality of teachers, an immensely important factor, is uneven. The morale of the educators is not good. You must find a way to reward high performing teachers and, easier said than done, remove those who are not high performing.

Recruiting the best teachers from around the area should be given high priority.

Political considerations such as who is “woke” and who is “MAGA” must be ignored. They have no place in education. You know from the fact that you were selected on a 3-2 vote and from your experience at Placentia/Yorba Linda that perceptions about such issues and resulting expectations lead to a precarious existence for any superintendent.

It is critical that you be and be perceived as the superintendent for all members of the community. From the fact that you were well-liked by teach-

ers with whom you served at BHUSD, I know that you can achieve this.

The improvement of academic standards must be given highest priority above all else.

The District administration and Board of Education have demonstrated a tendency to become distracted by other issues.

These include reconfiguration of elementary and middle schools, security, construction, accommodating Palisades High School students displaced by the recent fires or suspension of a popular teacher. While not unimportant, we must resolve these issues quickly without undue hand-wringing and move on. Otherwise, the focus on academics is lost. In addition to distraction, we certainly cannot re-visit reconfiguration because of expense and disruption issues as well.

The deterioration of academic standing is not a new issue. This has occurred over a number of years but we have not found the Superintendent who can even tread water let alone improve things.

We have lacked assigned responsibility, transparency and accountability for our academic performance.. We must set specific goals for improvement (such as performance on state proficiency tests) at the outset of each school year, publicly report results and hold those responsible accountable for achievement before moving on to the next year. For example, in the most recently reported results, **only 38% of Beverly High students met state proficiency exam standards in science and a bit higher in English and math. Only 41% of our students passed at least one AP exam.** We should assign responsibility for a reasonable annual improvement of these results publish those results promptly and hold those responsible, including you, accountable.

One aspect of improving academic performance of our student community is to recruit students with high po-

tential. Those students are already in Beverly Hills. But increasingly, they are attending private schools. Please give attention to trying to persuade those students to stay or attract them to return. Another aspect of recruitment of students with potential is to expand the Permit program beyond grandchildren of residents and to facilitate enrollment of eligible students who have a real connection to the City.

Another aspect of modern education that should be given priority is the digitalization of education and the constructive use of artificial intelligence. With our resources, we should be able to stay abreast of cutting edge, developments, and employment of technology to improve our students’ performance.

Given that in today’s educational environment, a superintendent’s term of office is not lengthy, it is not too soon to identify and groom a successor. No one can be a success without a successor.

On a more personal level, I understand that you were raised and still live in Los Alamitos [in Orange County] and fully appreciate the connection that you and your family must have to that community. However, as I write this in the early afternoon on a weekday, Google Maps reports that it would take one hour and thirteen minutes to drive from your home to your office on the Hawthorne School Campus.

I respectfully request that you move your residence to or near Beverly Hills. Your job will be a very demanding one. It will be important for you to be visible and present at all times: evenings, weekends and holidays. This is not a 9 to 5 job. It cannot be done in Los Alamitos or while en route to or from your home. Adding a minimum of 2.5 hours of drive time every day on top of the demands of doing this job will be unsustainable. **Please don’t try to do it.**

I wish you well, hope for great success and look forward to meeting you in person.

struck the rear of a vehicle that had slowed due to traffic. The collision caused Wenker, riding an Indian Scout motorcycle, to crash into a Tesla Model 3. The impact ejected Wenker from his motorcycle.

Board Reviews Measures E and BH Performance Audit by Moss Adams

A recent performance audit conducted by Moss Adams LLP for BHUSD reviewed the expenditures of the Measure E and Measure BH Construction Bond

programs for the fiscal year ending June 30, 2024.

Moss Adams conducted the audit to verify that the bond proceeds were used only for the projects specified in the bond measures. The audit also aimed to assess the efficiency of internal controls.

The audit concluded that for the fiscal year bond funds were used for the intended projects. However, the audit also highlighted areas where the BHUSD could improve.

One issue involved contractor billing, where invoices didn’t always include the backup required by “open-book accounting” standards. The report also encouraged BHUSD to bring together key financial planning tools, like cash flow projections and sources of funding, into a single master plan to improve oversight.

TAKING THE HELM

Newly Appointed Superintendent Alex Cherniss on Going Back to His Roots in the BHUSD

You started at BHUSD as a middle school math teacher at Beverly Vista. How does it feel to return to the district where your educational career first began?

It feels amazing. It's so surreal. I [remember] interviewing in a portable because they had not moved back into the building at Beverly Vista since the [1994] Northridge earthquake. I interviewed with [the late] Principal Irene Stern and Mark Frenn. It feels just like it was yesterday.

I came on board, and there were just some incredible teachers there—Merle Bauer and so many fabulous educators that I learned from.

I was there for two years, and then I became the assistant principal at Hawthorne School. I was assistant principal for two years, and then I became principal for three years.

There were so many great teachers—like Janet Lambert, Bob Bailey, Stephanie Lehrer, Linda Noble, and Marion Harvey—that I got to meet.

And incredible parents. The PTA really brought me under their arms. Jeny Melamed was very instrumental, and so was Robin Berlin. We learned so much together.

One of the biggest accomplishments during my time as assistant principal was starting the middle school sports program with BHEF. Dev Hankin was the president of BHEF at the time, so I met with her, Mike McAllister, Jonathan Prince, Steven Fenton, and some others. We kind of restored what they had when they were kids growing up in Beverly Hills—so all the schools competed against each other, and it was amazing.

Then I got the opportunity to move to the district office as the Assistant Superintendent of Business Services. We actually went into basic aid at that time, which meant the whole funding model changed. I was able to create a district finance committee—which I understand they still have. I worked with Mel Spitz and Herb Young to develop the committee. We had community members involved and really tried to be transparent about how the district would spend its resources.

There were some incredible board members I had a chance to work with—like Lisa Korbato, Steven Fenton, Jake Manaster, Nooshin Meshkaty, Myra Demeter, Myra Lurie and also Alissa Roston. It was a time to learn, a time to grow. I was here for ten years, I learned a great deal—and I couldn't be happier to be back.

You are coming from a larger school district of 22,000 students to one with 3,000 students. What's drawing you back to Beverly Hills?

It's a small district. It's actually half the size it was when I left—it was 6,000, and now we're down to 3,000. But what draws me back is the community. Whether you're a current parent or a former parent, if you're in Beverly Hills, the schools are the gem of the community, and everybody cares about them.

That's why the city council members are always interested in what's best for the district. I got to work with people like [former Mayors] Barry Bruck-

er, Lili Bosse, and John Mirisch, and they just wanted what's best for the schools. [Councilmember] Lester Friedman and his wife Simone ran the PTA Council, and so everybody had a hand in working to make this district amazing.

That's why I wanted to come back. People like Lili Bosse have always been leaders—not just in the city, but in the schools. And it's very rare to see that. In most school districts, you're a parent, and then your kids graduate, and you're not really connected to the schools anymore. I want to be here because this is the true meaning of a school community.

What did you learn from the late Beverly Vista principal Irene Stern?

Well, Irene Stern—her name says it all. She came from New York, and she meant business. I think what I learned most from her was the honor of working in Beverly Hills. It's an honor and a privilege, and your job is to educate the students above all else.

When she came into the classroom, you knew she was looking at one thing: *Are the students learning?* And if they weren't, she would ask you why. That level of rigor that she taught all of us—

and that she led by example—is something I take with me to work every day.

Tell us about some of your other mentors in the BHUSD.

So, [former Superintendent] Gwen Gross hired me here. My first teaching job was actually in Ojai, California, and Gwen was the superintendent. She later moved to Beverly Hills [in 2000], and when I moved to Los Angeles to do my student teaching, I reached out to her. She said, "Actually, we have a Math position open." So if it weren't for Dr. Gross, I wouldn't be here.

Another mentor I had was [retired Beverly Vista English teacher] Merle Bauer—I got to observe her as a teacher, and she had this way of teaching where every student in her class was always on their A-game, attentive and listening. Because they knew she cared about them, and they knew she took her job seriously. She was just a fabulous mentor.

When I got to Hawthorne, Janet Lambert taught eighth-grade social studies, and she was very similar—soft-spoken, but every student had such respect for her because she took her profession seriously and truly cared about the students.

One of my takeaways from that is: we want to hire teachers who really care about kids and take their profession seriously. And if we hire those kinds of teachers, then the sky's the limit.

I also got to meet some other amazing teachers district-wide, like Cheryl Katz and Steve Kessler—really more than I can even name. But all of them truly cared about the students and were very much tied into the community.

What makes Beverly Hills different from some of the other districts you have worked at?

The expectations. Parents make a lot of sacrifices to move to Beverly Hills, and the expectation is that their kids are going to get the best possible education. And

if that isn't happening, then we're not doing our job.

With that expectation comes a great amount of responsibility on our part to make sure that we are the best. I think we're a very good school district—but my goal is to make us the best school district in the country. And I think we can get there.

There's no reason why we shouldn't with all of the community resources that make up this great city. It's not like any other school district in the country. We're a small, unified school district with amazing private industry around us and amazing community stakeholders—second, third, even fourth-generation—who still live in this community.

There's a sense of history with our school district that you won't find anywhere else.

BHUSD has experienced a slight decline in its rankings in recent years. What are some ways the district should address this?

Well, that's one of my top priorities. First of all, we need to make sure that what we're teaching is aligned with what students are being assessed on. We want to ensure all of our schools are teaching a similar curriculum. We want the curriculum to be rigorous. And we want our teachers to be highly trained and highly effective in delivering it.

Ultimately, we need to build a sense of pride—our students need to really want

to do well, not just for themselves and their families, but because of the district they represent. It's a culture change that I think we need.

And I'll be honest—I'm not going to sugarcoat it. This district has declined in academic achievement over the last eight years, on average, year after year.

We are going to turn that around. And it's not going to be one little thing that does it—it's going to be a multi-step approach.

We need to identify the kids who aren't at grade level, understand why, and give them the extra support they need to get there. That's going to be one of our top priorities, as I said.

Tell us more about some of your goals as Superintendent.

One of my goals is to make sure that we are forward-thinking—that we're on the cutting edge. If you look at the top ten jobs in today's economy, many of them didn't even exist ten years ago. So if you translate that to our students ten years from now, they'll be competing in an economy with jobs that haven't even been created yet.

My goal is to provide them with the

proper skills that will translate and make them successful in the future—no matter what that job is.

So what does that look like? They’re going to have to be strong communicators. They’re going to need to be critical thinkers. They’re going to have to be able to engage with and facilitate learning through AI and other emerging technologies.

That’s what we need to focus on in order to truly prepare our kids for the future.

Your wife Liz is a former BHUSD teacher. How did you meet?

That’s another reason I wanted to come back—it’s a family here. My wife was a special ed preschool teacher at Horace Mann for over 15 years. I think we met when I was attending various meetings. We were introduced by a friend who was also a special ed preschool teacher originally.

And then we ended up having three kids—I have a first-grade daughter, Harper, a fourth-grade son, Leo, and a sixth-grade son, Finn. We know a lot

of teachers. Some board members even went to our wedding—that was a long time ago.

It all just reinforces [what I’ve been saying]: this is like a big family. And that’s one of the main reasons I wanted to be back.

What do you believe is the biggest challenge taking on this role?

Creating an urgency to improve what we’re doing here. Sometimes it’s hard to create urgency, especially in communities like ours, where a lot of the kids already think that their future is secure. These are not, for the most part, first-generation kids trying to get to college.

[So the question becomes]: how do we create urgency? How do we help our kids understand that their future is very much uncertain?

The work we do here to prepare them for that future will be critical to their success.

Is there anything else you would like readers to know?

In closing, I would just say that I’m happy to be home.
