Development Proposal for Saks Project to be **Reviewed by Planning** Commission

The Beverly Hills Planning Commission is expected to review a large-scale



View of Southwest from Wilshire Boulevard toward South Peck Drive

development known as the Saks Project, which spans several parcels along Wilshire Boulevard and nearby streets, at its Thursday meeting.

The project site covers addresses at 9570, 9588-9596, 9600-9610, and 9620 Wilshire Boulevard, as well as 128 South Bedford Drive, 120 and 121 South Peck Drive, and 125-133 South Camden Drive.

Key elements of the proposed project



•Rehabilitation and adaptive reuse of the Saks Fifth Avenue Women's Building.

•Retention of the existing 9570 Wilshire commercial building. •Construction of new residential, re-

tail, office, hospitality, social club, and boutique hotel spaces.

•Creation of new open spaces and related uses across the site.

Currently, the project site consists of: •Three existing commercial structures

> •An ancillary loading facility.

•Three surface parking lots. •Portions of two al-

leys: one approximately 27 feet wide along the southwestern boundary and another approximately 20 feet wide in the southeastern portion of the site.

The proposed Specific Plan divides the site into two distinct districts:

•The Wilshire Boulevard District, facing Wilshire Boulevard, would allow up to 400,000 square feet of commercial space, with a maximum height of 98 feet. Proposed uses include retail, dining, a boutique hotel (up to 50 guest suites), a social club, and some residential units.

•The Neighborhood District, locat-

ed south of Wilshire, would focus on multi-family residential development and boutique retail, featuring two new six-story buildings, each up to 78 feet tall, providing up to 70 residential units combined. At least 2,000 square feet of retail space would be required to maintain the environment.

The project would eliminate surface parking lots and replace them with a four-level subterranean parking garage, providing 744 automobile spaces, including 501 spaces for commercial uses and 243 for residential uses. The parking structure would span beneath South Peck Drive via a subterranean connection. Up to 50 of the commercial spaces would be available to nearby residents for evening and weekend use as a proposed public benefit. Bicycle parking equal to five percent of the new vehicle spaces would also be provided.

Demolition of the existing Saks Shoe Building would be required to allow for the new construction.

A Draft EIR was released for public review in April 2024. The Final EIR, including responses to public comments, was released on April 24, 2025.

The Planning Commission's Thursday meeting will provide an opportunity for comment from the public and commission discussion before any final recommendations are made regarding the project

Construction is projected to begin in late 2025 and continue through 2029.

Residents Concerned About Landline Termination in California

California residents are being urged to submit comments to the California Public Utilities Commission (CPUC) by May 13, in response to a potential move that could affect landline services across the state.

AT&T's plans to phase out traditional landline phone services have raised concerns among some residents, particularly in regard to the potential impact on emergency services, the elderly, and other vulnerable groups.

The company, which is aiming to eliminate its copper-based landline infrastructure across much of the nation by 2029, is once again seeking to terminate landline service in certain areas of California. The proposal has led to concerns that eliminating this service could limit access to reliable communication during emergencies.

This is not the first time AT&T has attempted to discontinue landline service in California.


About a year and a half ago, the company proposed terminating landlines, a move that was met with opposition from residents and advocacy groups. Concerns were raised that this decision would disproportionately affect elderly residents who rely on landlines, as well as others who may not have access to mobile or internet-based services. Due to extensive public input, AT&T's proposal was ultimately rejected by state regulators.

While AT&T is seeking to phase out its traditional landline infrastructure, the company maintains that newer technologies offer more efficient service. The company also asserts that maintaining its copper wire infrastructure is increasingly costly.

The deadline for submitting comments is May 13, and individuals can share their views on the proposal through the CPUC's online portal at apps.cpuc.ca.gov/apex-/f?p=401:65:0::NO:RP,57,RIR:P5_ PROCEEDING_SELECT:R2406012.

Public forums are also being held to allow for further community input.

Black Teachers File Lawsuit Against BHUSD Alleging Racial Harassment and Discrimination

Two Black teachers from Beverly High have filed a lawsuit against the district, alleging racial discrimination, harassment, and retaliation during their employment.

The plaintiffs, Bella Ivory and Jarvis Turner, claim they experienced a hostile work environment, unequal treatment compared to colleagues, and a lack of corrective action by administrators despite multiple complaints. The lawsuit names BHUSD and several unnamed individuals in managerial roles as defendants.

"Schools are a place for learning. Hopefully, schools will teach our students and young adults equality, diversity and tolerance for one another. We all benefit as a society when everyone is treated equally. Unfortunately, in this case, there are allegations of racial slurs against Black people, inappropriate comments about Latin Americans and other discriminatory comments. There are Black students who claim that they have been victims of violence because of racism. No civilized society should tolerate this kind of behavior," said attorney Brad Gage.

Gage previously represented several litigants who received large settlements from the City of Beverly Hills pertaining to former BHPD Chief Sandra Spagnoli.

Turner, who began working at Beverly High in 2010 as a basketball coach and teacher, alleges a series of racially charged incidents over several years.

According to the complaint, he received a racial slur via email in 2019, was subjected to derogatory remarks, and reported that administrators failed to act on his concerns. He also claims he was denied pay and benefits given to other employees and that school funds were improperly used to pay non-Black staff.

Ivory, hired in 2020 to teach fashion courses, describes repeated episodes of verbal abuse and discriminatory treatment by coworkers and administrators. She alleges her teaching responsibilities were unfairly reassigned, her pay was inconsistent with other similarly qualified teachers, and requests for meetings were ignored. Ivory states she later went on medical leave and ultimately resigned, citing an unsafe work environment.

The complaint includes five causes

exam, we would give them an F-. Hopefully, by bringing the darkness of the allegations into the light, we can see a positive change for the future," Gage said

The BHUSD Public Information Officer stated that the district could not comment on matters related to litigation.

Patrick McKillen Files Lawsuit Against Qatari **Royals Over Maybourne Beverly Hills Hotel**

Patrick McKillen has filed a civil racketeering lawsuit in California against members of the Qatari royal family, accusing them of defrauding him of millions of dollars for work completed on several luxury properties, including the Maybourne Beverlv Hills hotel.

The complaint, filed on April 22, claims McKillen's company, Hume Street Management Consultants Limited, was not compensated for redevelopment work done over a twoyear period on the hotel, according to



the Los Angeles Times.

McKillen alleges that in 2019, he was promised compensation for his management and redevelopment efforts on the hotel, which was known as the Montage Beverly Hills then, but that the payment was never made. The lawsuit also extends to other projects McKillen worked on for the royals, including a Manhattan mansion and a Parisian hotel.

The Maybourne Hotel Group, which owns the Beverly Hills property, has denied the claims, calling them "vacuous" and stating they plan to contest the lawsuit, as they have done with previous legal actions brought by McKillen. This is part of a broader legal dispute between McKillen and the Qatari royals, which includes ongoing cases in the U.S., the U.K., and France.

The Council of the City of Beverly Hills, at its regular meeting to be held on Tuesday, May 20, 2025, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, will hold a public hearing to consider:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING THE SIGN REGULATIONS OF THE BEVERLY HILLS MUNICIPAL CODE TO ALLOW PORTABLE SIGNAGE AND BLADE SIGNAGE SUBJECT TO CERTAIN CRITERIA ON COMMERCIALLY ZONED PROPERTIES AND FINDING THE ORDINANCE EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

The City Council will consider adoption of an ordinance to amend signage regulations applicable to commercial zones, as codified in Title 10 (Planning and Zoning), Chapter 4 (Zoning, Signs), Articles 1-9 of the Beverly Hills Municipal Code (BHMC), to allow certain businesses to use portable signs (including a-frame signs) and blade signs (projecting signs) upon meeting certain criteria. The Planning Commission and Architectural and Design Review Commission previously reviewed this topic at study sessions during their May 9, 2024 and June 17, 2024 meetings, respectively, and formed a joint ad hoc committee that met in September and November 2024 to work further on portable signage regulations. Staff presented the draft regulations to the Architectural and Design Review Commission at its March 19, 2025 meeting, and to the Planning Commission at its April 10, 2025 meeting. The Planning Commission unanimously recommended the ordinance for adoption to the City Council. The regulations in the draft ordinance include but are not limited to the following:

- •Allows ground floor restaurants, retail uses, and exercise clubs/private training centers the use of one portable sign with limitations on size, type and location;
- •Allow one blade sign on certain streets in additional to signage otherwise allowed;
- ·Make clarifying changes to the existing blade sign and menu board regulations; and
- •Create a pilot program for businesses to use these signs, with a requirement for an approximate one-year check-in after program commencement.

Staff recommends that the City Council waive the full reading of the draft ordinance, introduce it by title only, and conduct the first reading for the adoption of the ordinance.

This summary of the ordinance is prepared and published in accordance with the requirements of Government Code §36933. Pursuant to the requirements of Government Code §36933, a certified copy of the entirety of the text of the proposed ordinance will be available for review during normal business hours at the Office of the City Clerk Office located at City Hall, 455 N. Rexford Drive, Second Floor, Beverly Hills, CA 90210 at least five days before the City Council will consider adoption of the ordinance.

ENVIRONMENTAL REVIEW

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA), the State CEQA Guidelines, and the environmental regulations of the City. Since the project does not authorize construction, there is no possibility that it may have a significant effect on the environment. In addition, the project reflects minor changes in land use limitations, by allowing the installation of signs within previously developed commercially zoned areas of the city and do not result in changes to land use or density. Accordingly, the City Council will consider a recommendation to find the project categorically exempt from CEQA pursuant to

Sections 15061(b)(3) and 15305 of Title 14 of the California Code of Regulations.

Thus, Beverly Hills resolved to implement a nurse practitioner program to work in conjunction with the paramedics. The intention was to bridge the gap between the most serious medical problems, and the very minor. One of the purposes of this program is to provide proactive care to the most vulnerable in our population. in addition, the the nurse practitioners can connect their patients to various social services. Now, Cedars Sinai Medical Center has opened its records so that in appropriate cases, the nurse practitioners can access records.

The Beverly Hills Fire Department nurse practitioners' responsibilities include: functioning as a clinician providing direct patient care to the ill and injured in the field; conducting and interpreting diagnostic tests, performing basic routine procedures; and prescribing and administering medication.

This is the way that the program works. Once a Beverly Hills resident patient has called 911 and receives a visit from Beverly Hills Fire Department paramedics, the patient is either visited initially by a nurse practitioner who accompanies the paramedics or will receive a follow up contact from the nurse practitioners to determine whether any follow up is needed. If so, the patient will receive a home visit from a nurse practitioner, and in effect will become a patient of that nurse practitioner.

There is no charge for the service and the city bears the entire expense of this program. The City employsfive full-time nurse practitioners who are supervised by a physician medical director. They are available seven days a week (excluding holidays) from 8 AM to 6 PM. As you might expect, this program has resulted in a substantial reduction in 911 calls. The nurse practitioners average around 250 patient encounters (in person or by telephone) per month and make house calls every day.

The program is managed by BHFD

emergency medical services (EMS) Division Chief Sean Stokes and BHFD Chief Greg Barton. Mr. Stokes takes great pride in this program and explains: "The treasure of this program is that it addresses the disconnect between hospitalization and what the patient can do for himself or herself at home. It provides a greater continuum of care."

Nurse Practitioner Alea Foster said: "We do not replace emergency calls to paramedics who will transport patients to the hospital. We assess the gap between what the paramedics and the hospitals do. We assess the patient's needs and mobilize to see patients where they are and provide needed treatment. We do not want Beverly Hills residents to feel alone."

As far as I can tell, the Beverly Hills nurse practitioner program is unique. This is because at present, neither Medicare, nor Medicaid, nor any other third-party payer will reimburse for the cost of this service.

The Beverly Hills nurse practitioner program was implemented in 2019. At the time, stated "we are thrilled bring this innovated life-saving program to Beverly Hills. With a focus on improving patient outcomes and specific needs, the program is part of the future of Mobile medical integrated healthcare."

Now, other cities around the country are watching as the City of Beverly Hills takes the lead in trying to persuade Medicare and then others to reimburse cities for some or all of the costs of the nurse practitioner program. In the meantime, they City bears all of the costs of this program and does not charge or bill the patients. I am informed that the total costs exceed \$1M annually.

Whether reimbursed or not, this program is a great benefit for our residents.

Beverly Wilshire General Manager Reed Kandalaft on the Beverly Hills Hotel Industry

By Danielle Berjikian

You are the Regional Vice President and General Manager of the Beverly Wilshire. Tell us about that.

I'm a general manager and regional vice president, so I support other properties in the area as well. But my role

is mainly to manage this hotel as a general manager. Four Seasons is a management company. We don't own the assets, similar to many luxury hotels. I manage the asset on behalf of Four Seasons for the owners here.

With that, I support the three big pillars: people, product, and profit. When we look at people, it's [all about] hiring the best talent, training, and retaining the best to support the hotel. Then, when it comes to product, it's really about both the employee experience and the guest

experience. This includes everything from our food and beverage offerings to the spa, events and meetings, and guest rooms-anything that touches the guest experience.

And profitability — it's about ensuring the business delivers a profit for the asset owners of the Beverly Wilshire. I have the responsibility [to ensure] we run the hotel according to Four Seasons standards.

What originally drew you to the hospitality industry?

I've been in the hospitality business for 32 years now, since I was 18. I think the biggest draw for me was that when you work in hotels, your day is unpredictable. That really brings a lot of excitement throughout the day. Yes, we have a routine and things to do every single day, but because you're working with

> - a business that's open 24 hours a day, 365 days a year, and you're working with people, it makes everything more dynamic and exciting. That really attracted me. So, it's definitely not a boring job.

You've held leadership positions at several Four Seasons properties, most recently in Boston. What makes the Beverly Hills hotel market unique?

I think, when you look at Beverly Hills itself, it's a brand. You can't really say that about a lot of other cities in the U.S. I think that's what makes it stand out and makes it unique. It's a smaller.

high-end luxury market. You're not in New York, which can be huge. But Beverly Hills has carved out its own [identity] in LA County as a brand. That brings a lot of dynamics to the area. It's also a very residential area. We're not in a big city with massive infrastructure. It's a smaller space as well.

You are a CVB Board Member. What sets the Beverly Wilshire apart from other luxury hotels in the area?

Definitely the location. We feel that we are in the heart of Beverly Hills. We're on Wilshire, and of course, you could say we're at the end of Rodeo, but we sort of start there, if you will. I think that's a big plus for the hotel. But more than just Wilshire, it's the history of Beverly Hills. Yes, it's iconic and historic. But I think [the fact] that we've been a hotel for almost 100 years-since 1927-and have been here on Wilshire since then, really [plays a big role]. We've welcomed so many celebrities, dignitaries, and influential people from all around the world. They've all been able to enjoy this hotel as guests. So, I think the history itself says a lot about this place.

Former Beverly Wilshire General Manager Peter Humig said, "Tourism is back, but isn't back in full force." How is the tourism market today?

Yeah, it's definitely coming back. I think we have a new trend. It's not fully back to pre-COVID levels, and I don't think that will ever happen because some segments of the travel industry have just vanished in a way. People can work from home now. So, the leisure guest is back and even stronger than before, and groups are returning. But I think people are traveling less for business than they did before. So, are we back at 75-80% occupancy? No, I don't think you'll see that again in a lot of hotels around the country, not just here. But we're back to really great levels, and we feel good about it.

In 2023, the Beverly Wilshire, along with several other hotels in the region, experienced labor disputes involving Unite Here Local 11. Now that a tentative agreement has been reached, how would you describe the current relationship between the hotel and the union?

It's a great relationship, honestly, and it has been for many, many years. We hope to continue it that way. Aside from the union, we have some of the most tenured employees at any Four Seasons hotel. It's very common to find employees here who have worked for 40-plus years. So, the employees here truly feel that they belong to the Beverly Wilshire and the Four Seasons. That really helps with our relationship with the union. The staff loves the hotel and genuinely enjoys working here, being part of both the Four Seasons brand and the Beverly Wilshire brand. We've never really had major issues. Yes, we've had some picketing and strikes in the past, but overall, we're in great shape when it comes to working with Unite Here.

Tell us about your family.

My wife and I have three daughters: a 14-year-old, an 11-year-old, and a 7-yearold. Each of my daughters was born in a city where I worked with Four Seasons. One was born in LA, one in Miami, and one in Boston. So really, my life outside of work revolves around my kids, their interests, their activities, their education, and everything we do to support them as a couple. They keep me very busy.

What are some goals you have for the hotel under your leadership in the coming months?

We're happy to say that we renovated all the guestrooms, and that finished in 2022. We also renovated our spa and all our meeting spaces. So, we feel that we have a brand-new look for the hotel. Not much has changed in the lobby or the boulevard because those are just iconic.

But one of our goals is really to continue attracting top talent to work with us and retain them, as that is always a challenge in the industry. We're always trying to find ways to achieve that. At the same time, employee satisfaction is important to us, and I'm happy to say that we do well in that area. However, it's always a goal for us to improve employee satisfaction.

We're big believers that if you have the best employees and you train them and invest in them, they will turn around and provide exceptional guest experiences. It takes a lot of work, though. We're very selective in who we hire, typically hiring less than 10% of applicants. They go through a rigorous interview process, usually four to five interviews before they're selected.

We put a lot of investment, time, effort, and money into hiring the best people. Once we hire them, we have dedicated training professionals on-site to train them. Of course, with our culture, we hope to retain them for the long term as much as we can. So, that's both a shortterm and long-term goal for us in how we handle talent.

Another goal is to continue to protect the guest experience and what we're known for. It's a big job because there are so many details that go into creating a luxury experience for our guests. So, we always try to stay fresh and innovative with ideas, whether it's beverage programs, food items on the menu, or treatments we offer in the spa, and keep everything up to date and exciting for our guests. Those are two big priorities and goals for us.
