Dear Mayor Nazarian and Councilmembers:

I understand that questions have been raised in Beverly Hills about the establishment of a Community Facilities District in your City. I want to take this opportunity to provide you with facts.

I was a principal co-author of what is now commonly called the Mello-Roos Community Facilities Act of 1982. It passed with overwhelming support in the State Legislature.

When Senator Henry Mello and I crafted this legislation, our goal was to provide California's local governments with a flexible and robust mechanism to finance public infrastructure and services in a post-Proposition 13 era. We envisioned a tool that could support growth and enhance quality of life without burdening existing taxpayers and cities.

The beauty of Mello-Roos, and its enduring relevance, lies in its broad applicability. It allows for the funding of a vast array of public improvements like parks, roads, water, and sewer systems and other important services whether built by cities or developers.

Crucially, and this is a point I cannot stress enough, the Mello-Roos mechanism is designed to be entirely risk-free to the city's general fund, its existing property owners, and its residents. When a Community Facilities District (CFD) is formed, the special tax is levied only on the properties within that newly designated district – in your case, only within the boundaries of the One Beverly Hills development. This means:

- No Impact on Existing Residents: Your current property owners will not see this special tax on their bills. The financial responsibility for the new infrastructure rests solely with the properties that are in the district.
- No Risk to the City's General Fund: The bonds are repaid directly by the special taxes collected within the CFD. They do not rely on the city's general revenue, nor do they create a liability for the broader city budget. This allows the city to maintain its fiscal health while still facilitating community improvements.

This is precisely how Mello-Roos was intended to function: as a responsible, self-funding pathway to progress. It empowers communities to invest in their future, enhance their amenities, and accommodate growth, all while safeguarding the financial interests of their long-standing residents.

I commend your City Council for considering this prudent and effective financial tool. Your approach is entirely consistent with the intent and protective nature of Mello-Roos and it reflects a commitment to smart growth and fiscal responsibility that will benefit your community for generations to come.

"OneBh Wants Financing— **Should It Come From Us?" Issue 1347**

I have read Larry Green's guest column and Mike Roos's letter in last week's issue, both favoring issuance of \$500 million of tax-exempt bonds by the City of Beverly Hills to assist real estate developer Cain Development in financing its One Beverly Hills project adjacent the Beverly Hilton currently underway.

Mr. Green, the managing director of Cain development, addresses his company's request of \$500 million in City issued bond proceeds with less than accurate statements about the City's resultant liability, limitation on future bond issuances, and inadequacy of financial incentive. He fails to mention the enormous financial benefit to his company.

In his letter former Assemblymember Roos offers an impassioned justification of the Mello-Roos Community Facilities Act of 1980 which he co-authored, and under which the proposed City bonds would be issued; but he does not address incompatibility of this proposed bond issuance with the objectives of the Mello-Roos Act.

I urge the City Council to reject this proposal by Cain Development to increase its profitability or perhaps bail it out.

Regarding the Mello-Roos Community Facilities Act of 1982, which its co-author, former Assemblymember Mike Roos, explained would allow the city to issue bonds for private development with absolutely no risk to the city's general fund, existing property owners, and residents, I remain unconvinced about its application to the One Beverly Hills project and its developer's request, well after the start of construction, that the city issue \$550 million in bonds to help finance it.

Mr. Roos states that the Act allows the boundaries of One Beverly Hills to become a Community Facilities District (CFD). A special tax would be levied only on the property within the CFD. Apparently this means that this tax would be paid ultimately by the rarefied purchasers of units in the ultra luxury development at even higher prices than originally considered. This still doesn't answer the question I raised in my letter published in the July 31 issue of the Weekly: what happens if the developer goes bankrupt? Moreover, what happens if unit sales slow down during a period of economic instability, when tariffs will also raise prices for all consumers, discouraging foreign investment in U.S. properties? If sales of One Beverly Hills units are slow, will the developer be able to carry the unsold units and pay its share of the special tax levy, assuming the developer is still in business?

When Mello-Roos was adopted in 1982, no one was questioning the future viability of American democracy. Additionally, the current administration's heavy-handedness when vetting visitors to the United States has already discouraged tourism. Will wealthy foreigners want to deal with ICE when entering the country? If they do want to park their money in American real estate, there are established, i.e., safer, properties elsewhere in which to invest.

"Short Term Rental Ordinance"

TO THE BEVERLY HILLS CITY COUNCIL:

I was alarmed when I read your quotes in the SFGATE article, which prompted me to respond with a letter and attend your August 5 City Council meeting.

After making that effort to speak during public comment, it was especially discouraging because the Council moved straight to a vote on Short Term Rentals (STRs) with no meaningful discussion.

None of the concerns raised by Attorney Frank Angel or myself were addressed. Let me respond directly to the quotes attributed to you in SFGATE:

Councilmember Craig Corman: "We thought if people had a chance to rent their homes out twice a year... it would sufficiently guard against abuse. Obviously, we were wrong. And we've seen... a proliferation of party houses."

If there has been a proliferation of party houses, why is there still no distinction made between responsible operators and bad actors?

I lived in a "sea of STRs" (16 of them within 100 yards of my front door) for five years and never had a problem. Currently in Hermosa Beach, the worst party issue on my block came from the unsupervised 18-year-old son of a second homeowner whose unit sat empty most of the year and was only used on weekends. That was not an STR. It was a vacant second home being misused by its owner.

Better Neighbors LA, funded by the hotel lobby, and the hotel industry have spent years pushing the narrative that STRs equal parties.

That does not reflect what is happening on the ground.

These assumptions are being repeated without question while residents like me are being ignored

Councilmember Corman: "I think this ordinance does deal with it by eliminating the short-term rentals in the city. And I think that's a good thing."

Eliminating STRs entirely does not solve the problem, it just drives it underground. Bans do not make people disappear. They make enforcement harder and TOT revenue

A well-regulated permit system with noise enforcement is a real solution. But instead of regulating, the City adopted a blanket 12-month minimum lease mandate. That is not balance, it is a draconian overreach that punishes responsible residents alongside the worst offenders.

Councilmember Les Friedman: "It's really important that we create the stock of availability for people to either, you know, get into a home or get into an apartment."

If that is the goal, why is the City failing to build affordable housing?

Your Housing Element was flagged by the State for noncompliance. STRs are not the reason people can't find apartments in Beverly Hills.

Most STRs are in guest units, second homes, or temporarily vacant properties that were never part of the long-term rental supply.

Banning STRs does not magically convert them into affordable housing. It just removes options for visiting families, displaced residents, and working professionals.

Councilmember Friedman: "[This ban is] part of that puzzle... in making their apartments available or living spaces available."

That may be the narrative pushed by Better Neighbors LA, funded by the hotel lobby. but it is not supported by any evidence specific to Beverly Hills.

The McGill study was commissioned by the hotel lobby and reflects broad numbers from Los Angeles, not this city.

Yet that report was presented without rebuttal and adopted wholesale to justify a sweeping STR crackdown.

Attorney Frank Angel's letter warned that the proposed ordinance could expose Beverly Hills to legal action over due process violations, regulatory takings, and equal protection claims.

I submitted public comment at the same meeting and raised similar concerns.

Neither of us received any response. Not even a summary of his letter was read aloud. But the hotel-backed letter from Better Neighbors LA was given full attention.

So, I have to ask: Is this issue closed in your minds?

Please don't mistake criticism of this policy as support for party houses or bad actors. I'm asking you to reconsider whether a one-size-fits-all ban, built on hotel industry talking points, is truly in the public interest of Beverly Hills residents.

Just last week, Ocean City residents voted to reject stricter short-term rental rules, reversing a proposed ban.

That outcome reflects a growing recognition that STRs can be compatible with neighborhoods when regulated fairly.

I believe many Beverly Hills residents quietly share that view, especially those who use STRs themselves when traveling and would prefer fair rules over blanket pro-

"Pickleball Court Conversion"

The recent Beverly Hills City Council discussion on converting tennis courts at La Cienega and Roxbury parks for pickleball overlooked the fundamental science of the noise this sport produces. Staff suggestions that traffic will "mask" the sound are scientifically false. Pickleball creates a high-frequency, impulsive "POP," a sound profile similar to a backup alarm, which is entirely different from the ambient noise of traffic or the soft low-frequency thwack of a tennis ball.

The city's sound report is critically flawed

because it fails to apply the scientifically required 5- to 12-decibel "penalty" for impulsive sounds, thus misrepresenting the true noise impact on residents and other park users. As The Washington Post noted a few years ago, noise is the new second-hand smoke. Published research confirms the adverse health effects of noise exposure, including those from exposure to pickleball noise.

Pickleball and tennis are incompatible sports. Forcing them to coexist sacrifices the peaceful environment tennis players and neighbors have long enjoyed. Furthermore, with more than 50 court cases nationwide related to pickleball noise, rushing this decision without a full CEQA environmental review invites costly and avoidable litigation.

The City Council approved resurfacing of the City's tennis courts with conversion of some to pickleball play. We predict costly litigation and revocation of this ill-advised decision by injunctive relief for those who will be affected by pickleball noise.

Planning Commission Continues Review of Saks Project

The Planning Commission is scheduled to hold its fourth public hearing on the proposed 9600 Wilshire Boulevard Specific Plan project on August 14. Previous hearings took place on May 1, June 10, and July 24.

Two draft resolutions have been prepared: one recommending certification of the Final Environmental Impact Report (EIR) and another recommending City Council approval of a General Plan amendment, adoption of the Specific Plan, related zone text and map amendments, changes to the Master Plan of Streets, Alleys, and Highways, and approvals for a Conceptual Plan, Vesting Tentative Tract Map, and Encroachment Permits.

Public comments during prior hearings addressed topics including labor and workforce practices, environmental review, construction and traffic impacts, and community engagement. Commissioners discussed project design, operational impacts, land use flexibility, traffic analysis, compliance measures, and conditions of approval.

Revisions since the July 24 hearing include:

- Addition of an 18-month operational report requirement.
- A 15,088 square-foot limit on restaurant floor area.
- Requirement to seek historic designation for the Saks Women's Building.
- Updated pool depth limits.
- Prohibition of amplified sound in certain outdoor areas.
- Large event traffic control requirements.
- Coordinated roadway and alley closure procedures.
- Revised enforcement and penalty provisions for construction violations.
- Expanded review for partial street closures.

Other updates include clarifications to construction noise mitigation requirements, southbound turn restrictions, and a supplemental traffic analysis comparing trip generation estimates.

OBH Closing Argument

Dear Mayor Nazarian and Members of the Beverly Hills City Council:

As I will be unable to attend the City Council meeting on August 19 when you will consider the One Beverly Hills developer's request for issuance of not to exceed \$550 million of tax exempt bonds to reimburse the developer's costs for public facilities improvements on its private property (OBH), I want to convey these final thoughts.

First, we should take a step back and look at the big picture.

In 2021, OBH came to the City seeking unprecedented and extremely valuable entitlements. OBH wanted permission to build two condominium towers more than twice as tall as any other buildings in the City and a hotel/time share building that, while not as tall as the towers, was itself taller than zoning rules permitted. Notably, condominium units on a 23rd floor sell for prices far higher than the units on a third floor

Never once did OBH suggest that it would require financial help from the City with Mello-Roos bonds or anything else to pay for parts of this development that OBH promised to provide.

Now, OBH has asked the City for financial help in the form of City issued tax exempt bonds in an amount that is far greater than the City's operating budget and would swamp the City financially in the event that something goes wrong.

Some might call that a classic Bait and Switch.

This request raises numerous existential problems for the City and its future viability and, therefore, has stimulated widespread resident outrage.

OBH Developer **Larry Green** purported to answer some of these questions in a Guest Editorial that appeared in last week's issue.

He completely ignored the "bait and switch" aspect of his proposal.

The "answers" that he did provide are so misleading and incomplete that they reveal conclusively that the financial risks to the City are very very substantial.

Let's take a look at Mr. Green's statements and my comments:

Larry Green: "Is this a giveaway of public funds? No. These are <u>not</u> general

obligation bonds of the City; they are <u>not</u> secured by any general funds of the City. The bonds are repaid solely from special taxes paid by property owners in the district. Taxpayers are not providing a subsidy or any public funding. The City's credit rating is not involved."

Peter Ivan Ostroff Commentary: The proposal is for the City to sell tax exempt lower interest bonds. The amounts paid by the bond buyers to the City for the bonds are **public funds**. The proposal is that the City pay those funds to "reimburse" OBH for construction of things that OBH agreed to provide at its own expense in exchange for the magnificent entitlements that it received from the City. If that's not a "giveaway" of public funds, I don't know what is.

Green: What public infrastructure is proposed to be funded by the CFD and how are they public? The CFD will finance public infrastructure including street and sidewalk improvements on Wilshire and Santa Monica Blvds, new and upgraded traffic signals, utility improvements, street trees, landscape, and the realignment of Merv Griffin Way.

PIO Commentary: Certainly that is OBH's proposal – that funds raised by City issued bonds pay for things that OBH is unconditionally obligated to pay for with its own funds. Further, it is difficult to imagine that those items will cost \$550 million so the City would have to watch carefully to make certain that its funds are not misused. The City has no experience or capability to fulfill that watchdog role and could be held responsible for its own mistakes

Green: How does the CFD benefit the residents of Beverly Hills beyond the project? The One Beverly Hills CFD will provide an additional revenue stream for public infrastructure and ongoing maintenance instead of relying on city general funds or raising taxes on existing property owners.

PIO Commentary: Mr. Green seems to be arguing that some Merv Griffin Way street cleaning and watering the project's lawns somehow justifies \$550 million of city issued bonds. Seriously?

Green: Is there liability for the City if the project goes bankrupt? No. The City has no financial liability, as the bonds are land secured and the purchasers of the bonds understand that (i) these are non-recourse

to the City, and (ii) the only collateral for these bonds is the property within the CFD district (sic) (in this case the One Beverly Hills project.)

PIO Commentary: What the future purchasers may or may not "understand" will be based on the City issued securities offering statement (the bonds are securities) for which the City will be subject to state and federal securities laws.

Importantly, what the City will or won't say about the gift of public funds issue will be a very challenging legal issue. Further, there are many scenarios beyond whether "the project goes bankrupt" (whatever that means) which will give rise to liability or other injury to the City and its reputation including but not limited to whether the project is completed or its condominium units are not sold in a timely manner.

OBH could completely address these issues by providing an opinion letter from experienced counsel with a large malpractice policy that the City could rely upon that states unequivocally that:

The proposed transaction does not involve an unlawful gift of public funds; and

There are no circumstances in which the City or its resources or residents could sustain any financial liability or other injury.

OBH did provide a letter on August 5 which did not even mention those issues, said little, cautioned that the City could not rely on its statements and could have been written by ChatGPT.

Mr. Green's letter does not address whether the City is receiving adequate compensation for paying for up to \$550 million in costs to reimburse OBH for performing its obligations. This is understandable given that OBH's proposal is limited to paying some undefined "infrastructure" costs directly or indirectly out of the bond proceeds.

Assuming for a moment that all of these questions can be answered to your satisfaction, one paramount issue remains for your consideration.

The prospect that this transaction goes forward is immensely unpopular with our residents.

I have spoken with dozens of residents. Without exception, other than those directly or indirectly on the developer's payroll, these have expressed strong opposition. My sense is that even for people like me who really like this project as presented, the outrage is because of the bait and switch nature and the substantial risks presented.

City Treasurer Howard Fisher told me: "From what I've learned from staff, I am convinced that this matter has not been properly analyzed. Since taking office, I've received more calls about this issue than anything else, and everyone I've spoken to about it is outraged."

Is it wise to proceed headlong into this when the City Treasurer advises that **more analysis is needed**? Disregarding that advice seems, at best, reckless.

Undoubtedly, you have heard similar expressions of opposition from residents. And this is notwithstanding that several have told me that they have refrained from speaking out because of fear or retaliation from the developer or from City officials.

Don't we need, at a minimum, proper analysis and assurances from experienced counsel that we can rely upon (not just Latham & Watkins' word salad that tells us only that we cannot rely on them)?

The issue of whether the bond issuance is a gift of public funds has been specifically brought to your attention. Do you have reliable assurance based on sound authority that it is not? If you guess wrong about this, you will subject the City and yourselves personally to substantial potential liability.

What you have not been told and do not know about why these bond funds are being sought, why they are needed, whether they will be sufficient to ensure timely completion of the project or the value of these bonds to OBH far exceeds the limited information that has been shared.

You have been democratically elected to represent our City's residents. You have also been elected because the residents respect your good judgment.

I do not suggest for a moment that you must conduct a plebiscite on every issue. I do suggest, respectfully, that where, as here, there are more questions than answers and public sentiment of opposition is so strong, it would be imprudent and inappropriate to rush to a conclusion or disregard the widespread sentiment. If you do, it will send the unmistakable message that you are exalting the interests of the developer over the interests of the City or its residents .

I wish you well as you wrestle with the challenge of saying "no" to a developer who had previously promised an outstanding project or to the residents who believe that "no" is the only principled answer. But if it were easy, we wouldn't need you.

I quickly discovered that these two accounts of her life conflicted with each other [and were about two pages each in length.] As a novelist, I had to make some decisions about what I was going to use and not use. I got to imagine my own version of her life, and there was a lot of space to do so. Which was challenging in some ways but also an opportunity.

The other research I did was about her world. The voyage that she went on followed Cartier's third voyage to Canada. There was more documentation of his voyages, so I studied that.

And then I looked at the smaller things: what kind of music they listened to, what kind of clothes they wore and looking at what kind of paintings and instruments they used. All of this was done to give the story that antiquated feel.

With the challenges that Marguerite faces in the book, her character changes quite a bit. How would you say her character changed with these experiences?

One of the things that drew me to her story was thinking about how an experience broke her, but also remade her. She is tested in every way—physically, emotionally and spiritually-especially when she is alone on the island. She starts as a noblewoman, surrounded by

servants, and has probably never done anything for herself. She always had people helping her and was never by herself in that aspect.

To then be on an island where she has to do everything for herself, carry her own water, kill anything she wants to eat, or defend herself, it was about as far from her previous experiences as you can imagine. When she returns from the island, she looks at the whole world differently and with new eyes. On the island, it's a period of hardship but also of freedom for her.

Because of these challenges, Marguerite doubts her faith in God, but her servant Damienne keeps her faith in God. How does this difference influence Marguerite on the island?

Damienne has this rock-solid faith that Marguerite almost envies. Growing up, Marguerite has doubts about Catholicism, and then when she gets to the island, it becomes even harder for her to imagine that God is watching out for her.

I think the heart of her story is her finding a way to believe in something. She still looks at the world in terms that she was educated in, but she has to find her own way into that. There are moments when she is afraid that she believes in nothing and wants to give up, but then she comes out the other end of that. I think that with her time on the island, she finds a way to connect with God and nature

You also mention that you tried to understand Marguerite for who she was as a person. How did you approach this when writing her?

It started by figuring out how I would tell her story. I spent a lot of time thinking about her voice. I decided early on that



would be in the first person. The question was how she would speak. She doesn't talk in Shakespearean English, but she is slightly archaic and would be

thinking and speaking in French. So I always considered [the novel] to be a translation from French.

Once I figured out how I thought she would sound, I felt like I could hear her speaking to me. I allowed the story to unfold once I could hear her voice. It was almost like she answered a lot of my questions once I could hear her. And then I was able to imagine what I thought had happened to her.

Goodman is able to put the reader in Marguerite's place to truly understand what living in exile could have meant for her. The story is not just about survival, but offers inspiration and a lesson in resilience.


