Court Rules Against Beverly Hills in Housing Project

A Los Angeles Superior Court judge has ruled that the City of Beverly Hills acted unlawfully when it refused to process an application for a proposed 19-story mixed-use development at 125–129 South Linden Drive.

The ruling came in response to petitions filed by Californians for Homeownership, Inc. and 9300 Wilshire, LLC, the project's applicant. The court granted the petitions and ordered the city to process the development plan review application under the state's Housing Accountability Act (HAA) and the Permit Streamlining Act (PSA).

"We are vindicated by the Court's ruling and look forward to proceeding with a project compliant with the updated Builder's Remedy statutes on Linden in Beverly Hills very shortly. We believe this will bring much needed housing, at various income levels, to the City and

will be sharing a big announcement next week," devolper Leo Pustilnikov said.

The project was initially proposed in October 2022 as a 16-story residential building with 200 units, 40 of them designated for lower-income households. In April 2023, the applicant submitted a revised application for a 19-story building with 165 residential units and 73 hotel rooms, including 33 affordable units.

Beverly Hills deemed the revised application incomplete, arguing that the addition of hotel and restaurant space substantially changed the project and invalidated the preliminary application that secured protections under the HAA's "Builder's Remedy." The City Council upheld that position in June 2024.

The court rejected the city's interpretation, finding that state law allows preliminary application rights to lapse only if the number of housing units or the overall square footage changes by 20 percent or more. The court determined that the revisions to the project did not exceed that threshold and that the project remained eligible for Builder's Remedy protections.

The ruling also found that Beverly Hills violated the Permit Streamlining

Act by failing to process the application within required timelines. The California Department of Housing and Community Development previously issued violation notices to the city over its handling of the project.

"This decision is a major win for housing," said C.A.R. President Heather Ozur. "Cities are increasingly putting up illegal procedural hurdles for housing applications, from simple ADUs all the way up to large mixed-use projects. Today's decision makes it clear that cities must accept housing development applications and consider them on their merits and in com-

pliance with state and local law."

Separate judgments will be issued in the related cases filed by the petitioners.

A request for a **Zone Text Amendment** and **Rooftop Dining Use Permit** associated with the existing commercial building and rooftop use for the property located at **257 North Cañon Drive**.

Zone Text Amendment. Pursuant to Beverly Hills Municipal Code (BHMC) §10-3-3901, the applicant has requested to amend BHMC §10-3-3107 to allow commercial office use as a permitted rooftop use provided that



the commercial tenant concurrently occupies a separate tenant space within the same building, with the approval of a Development Plan Review by the Planning Commission.

Rooftop Dining Use Permit. Pursuant to BHMC §10-3-3107.5, a Rooftop Dining Use Permit is required to allow rooftop dining and rooftop open air dining uses. The proposed project also includes a request to allow the construction of tenant improvements on an existing rooftop for a future restaurant with rooftop open air dining.

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Upon review, the

project appears to qualify for a Class 5 Categorical Exemption (Minor Alterations to Land Use Limitations) and a Class 3 Categorical Exemption (New Construction or Conversion of Small Structures) in accordance with the requirements of Sections 15305 and 15303 of the State CEQA Guidelines. Accordingly, the Planning Commission will consider a recommendation to find the project categorically exempt from further environmental review under CEQA.

has appointed Ryan Gohlich as the city's next City Manager. Gohlich, who currently serves as Assistant City Manager, will take over from Nancy Hunt-Coffey, who is scheduled to retire in July 2026.

Gohlich has been with the City of Beverly Hills since 2007, beginning as an Assistant Planner. He has held several roles over the years, including Senior Planner, Assistant Director of Community Development/City Planner, and Director of Community Development, a position he assumed in 2021. He was appointed Assistant City Manager in 2023.

The City Council will formally approve Gohlich's contract at a future meeting. He is set to assume the role of City Manager on July 4, 2026.

"It is truly the privilege of my career to be selected as City Manager of Beverly Hills," said Gohlich. "I am thankful to the City Council for the trust they have placed in me and look forward to leading the incredibly dedicated and talented staff of this organization into the future."

Beverly Hills Police Arrest Suspect in Elder Fraud Scam

Beverly Hills police have arrested a suspect in connection with an organized crime scheme that defrauded an elderly resident of \$59,000.

According to the Beverly Hills Police Department (BHPD), the incident occurred on July 1 when suspects posing as financial institution employees and federal agents told the victim his money was unsafe due to a supposed "virus" or "hack" on his devices. The suspects instructed the victim to withdraw cash and hand it over to individuals posing as federal agents for "safekeeping."

Police said the suspects collected money from the victim on two separate occasions and used spoofed caller ID information to make it appear that calls came from the victim's financial institution.

The victim later reported the fraud to BHPD. Investigators used surveillance footage, security cameras, and license plate readers to identify two suspects and their vehicles. In collaboration with the Simi Valley Police Department, officers conducted a traffic stop in Simi Valley and arrested one suspect, identified as 22-year-old Hsinfu Lin of Richmond, California. Police said Lin was in possession of U.S. currency at the time of his arrest

City Honors Youth Empowerment Programs

Last week, the City of Beverly Hills honored Dr. Rita Ali, founder of We2Matter, and the Mike Tyson Cares Foundation for their programs supporting youth empowerment and personal development.

The Los Angeles County District Attorney's Office has filed charges against Lin, including grand theft, theft by false pretense, and financial elder abuse. Authorities believe Lin may have been involved in similar scams across Southern and Northern California.

One additional suspect remains at large, and the investigation is ongoing.

BHUSD Launches Redesigned Websites

The Beverly Hills Unified School District (BHUSD) has introduced redesigned websites for the district and its schools, completing updates to seven sites over a two-month period.

According to the district, the redesign includes a new appearance, streamlined navigation, and features intended to im-

prove access for students, families, staff, alumni, and community members.

Among the changes is a unified district calendar that consolidates all external school events in one location. The district has also launched a virtual Beverly Hills High School Alumni Hall of Fame in partnership with the Alumni Association, moving the existing on-campus display online for broader accessibility. A unified menu now allows users to move between individual school sites more easily.

Superintendent Alex Cherniss said: "Our schools deserve a digital presence that reflects the quality of education and opportunity we provide. This launch is a major step forward in making sure our communication tools match the exceptional work happening every day in BHUSD."

The City Council of Beverly Hills, at its regular meeting held on **Tuesday, August 5, 2024**, at 7:00 p.m., in the Council Chamber of the City Hall, 455 N. Rexford Drive, Beverly Hills, CA 90210, adopted Ordinance No. 25-O-2918 entitled:

AN ORDINANCE OF THE CITY OF BEVERLY HILLS AMENDING SHORT TERM RENTAL REGULATIONS (TRANSIENT USES) FOR SINGLE FAMILY AND MULTIFAMILY RESIDENTIAL ZONES, AND MAKING A DETERMINATION OF EXEMPTION UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

Summary of Ordinance No. 25-O-2918

This is a summary of the above entitled ordinance of the City of Beverly Hills. This summary has been prepared and published in accordance with the requirements of Government Code Section 36933.

The City Council adopted an ordinance to amend the short term rental regulations applicable to single-family and multifamily residential zones, which are referred to as "single-family and multifamily transient uses" in the Beverly Hills Municipal Code (BHMC). The amendments in the ordinance includes but are not limited to the following changes:

- A prohibition on short term rental uses (defined as a rental of less than 12 consecutive months) in any residential zone of the City, including the use of accessory dwelling units (ADUs), and accessory features such as pools or tennis courts;
- The short term rental prohibition does not apply to an in-home caregiving use
 or to housing that is separately regulated per state law (transitional housing,
 emergency shelters, congregate care facilities, or supportive housing);
- A requirement for a minimum initial lease term of one year for the rental, lease, or sublease of units in single-family residential zones and multi-family

- units in the City, with the ability to revert to a month-to-month lease thereafter; and
- Changes to other sections of the BHMC related to short term rentals, such as the addition of a penalty fee structure specific to short term rentals, and allowing additional enforcement mechanisms for violations of the short term rental regulations.

ENVIRONMENTAL REVIEW

The City Council determined the project is exempt from the California Environmental Quality Act (CEQA) pursuant to Section 15061(b)(3), which applies the 'general rule' that CEQA does not extend to projects with no significant environmental effect. In addition, the project is exempt pursuant to Section 15305 of Title 14 of the California Code of Regulations since the project does not authorize construction and actually imposes greater use restrictions on certain properties to protect the public health, safety and general welfare, there is no possibility that it may have a significant effect on the environment.

It is important that you know about the Beverly Hills Conference & Visitors Bureau (CVB), the city's official destination marketing organization and what it does.

The CVB is responsible for promoting **Beverly Hills** as the premier visitor destination — encouraging people to stay, shop, dine, and explore local attractions. Its mission is to boost economic and social vitality by driving visitor traffic to hotels, restaurants, shops, and events in the city. It is funded by a portion of the City's **Transient Occupancy Tax (TOT)** which is specifically allocated for marketing and tourism efforts

The CVB serves as the city's dedicated marketing engine—funded through a segment of the hotel occupancy tax—to attract and assist visitors, media, and planners. It combines visitor services, travel-trade engagement, and creative promotional content to position Beverly Hills as a world-class travel destination.

The CEO of the CVB is **Julie Wagner**, who has great experience in domestic and international marketing in the hospitality industry. After UCLA, she spent 18 years with Hilton Hotels, first marketing the Hilton Honors program and then helped launch the Waldorf-Astoria brand for Hilton. Julie joined the CVB in 2010 as Director of Marketing and became CEO in 2011.

Julie summarizes the work of the

CVB as follows:

"In addition to marketing the City of Beverly Hills globally through advertising, social media and ecommunications, The Beverly Hills Conference & Visitors Bureau will be increasing its focus on sales efforts by adding another Group Sales Director who will be responsible for developing more meeting and incentive business from planners and companies located in the western region of the United States. Additionally, the CVB works in close conjunction with the city, Chamber of Commerce and Rodeo Drive Committee by supporting Council and Mayoral initiatives as well as making sure our city is ready for the upcoming major sporting events coming to the Los Angeles Region including, NBA All-Star game in February 2026, FIFA World Cup quarter finals in June and July 2026, Super Bowl in early 2027 and, of course, the Summer Olympics and Paralympics in 2028."

The CVB is overseen by its Board of Directors which is comprised of the leaders of the major hotels and business and community leaders. The Chair for the 2025-6 year is **Sam Jagger**, the Managing Director of the Maybourne Hotel. Other hotel representatives on the board are **Tod Chambers**, General Manager of the Waldorf-Astoria, **David Ecija**, General Manager of the Beverly Hilton, **Reid Kandalaft**, General Manager of the Beverly Wilshire, **Offer Nissenbaum**, Managing Director of the Peninsula Hotel, **John Scanlon**, General Manager of the Beverly

Hills Hotel and Frederick Zenmour, General Manager of the L'Ermitage. Other members of the board include Bill Wiley, General Manager of Two Rodeo, Gaby Alexander, John Bendheim, Publisher of the Beverly Hills Courier, former Beverly Hills Mayor Linda Briskman, former Beverly Hills City Treasurer Eliot Finkel, Keinan Gill,

and **Kathy Gohari**, the head of the Rodeo Drive Committee.

Important Disclosure: I am a member of the CVB's Board of Directors and an unabashed supporter.

It maintains a Visitor Center (located at 9400 S. Santa Monica Blvd) which offers visitors concierge services—tour reservations, travel guides, and branded merchandise. It's staffed by multilingual ambassadors to assist travelers.

In addition to Julie Wagner, there are eight full-time CVB employees and one part time employee working in various marketing capacities including communications and partnerships, group sales, leisure sales, digital marketing and visitor services and concierge services at the Visitor Center.

The purpose of the CVB is to generate funds for the City that can be used to support and enhance services to the residents. This is principally through hotel occupancy taxes and sales taxes from restaurants and shops.

More specifically, the CVB employees work to generate group sales, market the City as a destination to consumers through digital platforms, advertising and an e-newsletter. They attempt to build global awareness internationally by contracting with travel, trade and public relations agencies that drive media stories and awareness among luxury travel agents. Domestically they work with public relations agencies to raise awareness of the Beverly Hills brand and what is going on in the City. They also work with leisure travel agents to influence them to

encourage their clients to visit Beverly Hills.

This is a challenging and highly competitive market. In 2023, it is estimated that the City had nearly 5M visitors denied as persons visiting the City who live at least 50 miles away. This is a substantial reduction in visitors from over 7.5M in pre-COVID years. The reduction is primarily due to the COVID shutdowns and slow recovery from those and due to the current difficulties that visitors from some foreign countries face in obtaining visas necessary to visit.

New chairman of the board, Sam Jagger, Managing Director of the Maybourne said:

"It is a true honor to serve our community and the Beverly Hills Conference & Visitors Bureau as this year's Board Chair. The CVB serves as the principal artery of the City, promoting our destination and driving visitation to support the vitality of our business community.

"My immediate priorities are to provide guidance and counsel to our President and team, while working in close partnership with my fellow board members. Strategically promoting Beverly Hills and thoughtfully allocating our resources to maximize return on investment are essential to our shared success—and to ensuring continued prosperity "for both our residents and businesses."

Frederick Zenmour of L'Ermitage explains that the CVB is of particular importance to L'Ermitage which is an independent hotel, not part of a large group. He explains "We do not have an international or even national marketing organization. We do not have dedicated group sales or leisure sales personnel. For our marketing we rely heavily on what the CVB does and their help is invaluable."

Personally, I consider it a great privilege to work with an outstanding board and to promote my favorite city.

The updated websites are currently available at bhusd.org. Each site includes an online form where visitors can provide feedback.

"We designed this website refresh with our community in mind," said Colby Gilardian, BHUSD Public Information Officer. "From a unified calendar to an interactive alumni hall of fame, these features make it easier to find what you need while showcasing the pride and excellence of our district."

COVERSTORY CITY COUNCIL APPROVES **MELLO-ROOS DISTRICT** FOR ONE BEVERLY HILLS

The Beverly Hills City Council voted Tuesday to establish a Community Facilities District for the One Beverly Hills project, paving the way for up to \$550 million in potential bond financing. The City Council approved the creation of the district in a 4-0 vote, with Councilmember Craig Corman recusing himself because he is a member of the neighboring Los Angeles Country Club.

Under the plan, properties within two designated improvement areas will be sub-





Ryan Levi Dubin of Beverly Hills, California, passed away on August 11, 2025 after battling colorectal cancer and its many complications for over two and a half years. He was just 23 years old.

Ryan was adored by his parents, three siblings, and sister-in-law-and by his many extended family members and friends-the moment he entered this world and throughout a life that was tragically cut short. Ryan's sweet and caring soul, humility, intellect, wit, and drive were known far and wide.

Ryan was born in Santa Monica on June 21, 2002 to Dr. Mark and Cindy (Zimmerman) Dubin and older siblings Alex, Josh, and Ellie. He grew up in Beverly Hills, attending El Rodeo School (K-8). He attended Beverly Hills High School and graduated in May 2020. At Bev-

Ryan attended the Iovine and Young Design Academy (IYA) at the University of Southern California, pursuing his ambitions in business, innovation, en-

trepreneurship, and design. At USC, he was a member of Pi Kappa Alpha (Pike) and served as President of TAMID, a program that connects U.S. college students with Israeli companies. He lived in Tel Aviv the summer of 2022, interning at a consulting firm.

In December 2022, Ryan was diagnosed with stage IV colorectal cancer. Despite undergoing surgeries and treatment, Ryan never let his disease define him, and it didn't. In the summer of 2023, he interned at a major tech company in Los Angeles. He graduated from USC in May 2024 with a B.S. from IYA and a business minor from Marshall. He completed a strategic consulting internship in New York in summer 2024 and received an offer to return for a full-time position.

Ryan had a deep passion for music, attending rock concerts since the age of four, and his musical tastes spanned five decades from the Grateful Dead to the Red Hot Chili Peppers to Tame Impala. He had a strong appreciation for listening to vinyls from start to finish, a metaphor for his emotional intelligence and his desire to listen to everyone's story all the way

through. During the pandemic, he taught himself guitar and later helped form a band at USC. He traveled the world, hiked mountains, and spent hours talking about emerging technologies, politics, and sports with his family and friends. He had a deep connection to his Jewish identity and to Israel, a special place he visited many times.

Ryan is survived by his parents, Mark and Cindy, and his three older siblings, Alex, Josh (Lauren), and Ellie.

BHHS Boys' Basketball **Coach Steps Down**

Longtime Beverly High boys' basketball coach Jarvis Turner announced Tuesday he has stepped down.

Turner was hired as the athletic coordinator of the Santa Monica-Malibu Unified School District in early August.

"While I had every intention of con-

tinuing to coach at Beverly Hills, the district has determined that my new role is incompatible with my coaching assignment," Turner said in a statement released Tuesday. "As a result, my time as varsity basketball coach has come to an end.

"Though this was not the way I hoped to close this chapter, I want the focus to remain on the positive: the relationships formed, the lessons learned and the accomplishments we shared. I am forever grateful to my players for their trust, dedication and commitment to excellence, to their families for their support and to the community for always standing behind our program.

"This transition is bittersweet but it does not erase the memories or the legacy we built together. I will always be proud to have been part of the Beverly Hills tradition and I will continue cheering for the program and its future success."

Turner coached the Normans for 16

seasons, including guiding them to the 2014-15 Southern Section Division 3A championship.

"Coach Turner has made a lasting impact on countless student-athletes during his time at Beverly Hills High School," Beverly High athletic director Steve Lawson said in a statement.

"His mentorship, energy, and commitment to our students have been deeply appreciated and will not be forgotten."

Turner is at least the third person with a tie to Beverly High to join the Santa Monica-Malibu Unified School district in an athletic position

Carter Paysinger has been Santa Monica High's football coach since 2022 after being a longtime coach and administrator at Beverly High, including being its principal from 2010-15.

Colleen Davenport, a former Beverly High athletic trainer, is Santa Monica High's athletic director. She is married to Vonzie Paysinger, a brother of Carter

The Beverly Hills Unified School District "is currently conducting a comprehensive search," for Turner's successor, Lawson said.

The new coach will receive a \$6,450 stipend for the 2025-26 school year, according to a posting from the district on EDJOIN, which bills itself as the nation's leading educational jobsite in the nation.

Turner and former fashion teacher Bella Ivory, who are both Black, sued the district and several unnamed individuals in managerial roles on April 25, alleging racial discrimination, harassment, and retaliation during their employment.

The district has not comment on the lawsuit, citing its policy on not commenting on matters related to litigation.






