Vote Counting Nearing an End

Over 10,000 ballots have been counted in the City Council election, with vote counting nearing an end.

As of press time, Sharona Nazarian had 6,550 votes. Les Friedman had 3,582 votes and Rebecca Pynoos kept her third place lead with 3,483 votes. Andy Licht came in fourth place with 3,263 votes and Russell Stuart followed with 2,462 votes. Ariel Rofeim received 2,444 votes and Roger Tanenbaum followed with 949. Barry Axelrod received a total of 496 votes and Andrew Kole followed with 404. Jonathan Mariande received 363 votes and Clayton Saunders followed with 265.

City in Phase 3 of Metro Homeless Response

The city has taken a phased approach in its response to address quality-of-life concerns and monitor operational impacts associated with being the end of life station.

“It is anticipated that Beverly Hills will remain an end-of-line station for approximately one year. In preparation for and response to station opening, the Fire Department’s Human Services Division has been leading coordinated efforts among the Beverly Hills Outreach

Team and City partners to proactively address quality-of-life concerns and monitor operational impacts associated with end-of-line activity,” according to a June 10 staff report.

According to a City Council report for its June 10 special Study Session, which occurred after the Weekly’s deadline, a phased approach allows city staff to deploy resources, monitor real-time conditions, and adjust operations as needed.

The Pre-Opening Preparation is complete. This included finalizing interdepartmental response protocols, continuing coordination with Metro and outreach partners, outreach to residents and schools, data-tracking frameworks, and more.

The second phase occurred during the first 30 days of operations, which included deploying coordinated outreach and monitoring during peak end-of-line hours, field presence and business check-ins, monitoring offloading frequency and operational conditions in real time, and weekly collaboration meetings.

“Staff have been actively collecting data and coordinating in real time with our Beverly Hills Outreach Team, public safety personnel, and operational partners to monitor activity surrounding the Wilshire/La Cienega Station. Staff have continued proactive outreach efforts, overnight monitoring, business outreach, and interdepartmental coordination to ensure rapid response to quality-of-life concerns and emerging operational trends,” the report indicated.

City Council Honors Haley Scholer with Burton E. Green Scholarship Award

At Tuesday night’s City Council Meeting, the City Council recognized Haley Scholer, a top-performing student at Beverly High with the Burton E. Green Scholarship Award for her academic achievement, leadership, and service.

The award, named after Burton E. Green, an oilman and real estate developer who played a key role in the founding and development of Beverly Hills, honors students annually for their outstanding leadership and commitment to public service.

The current phase is the stabilization and adjustment phase, which is for the period of 30-90 days post opening. This will include refining deployment strategies based on collected data, identifying service-resistant individuals requiring heightened intervention, adjusting out-

reach, and returning to the City Council with updates.

The City Council was expected to provide feedback and direction at its Wednesday meeting.

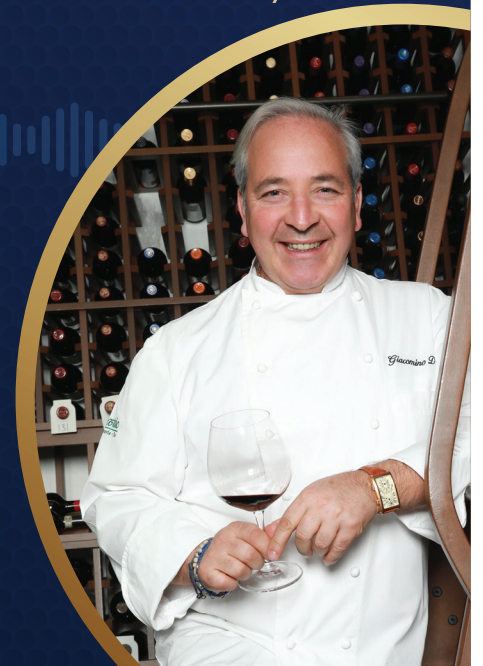

City Council Approves Street Closures for "Paris Paramount" Filming

At its Tuesday meeting, the City Council approved a request from Warner Bros for filming of "Paris Paramount" for the street closure of 500 N. Alta Drive on Wednesday, July 7 and Thursday, July 8. The item was presented on the City Council's consent calendar.

In addition to the proposed street closure, Warners Bros requested overnight parking for residents whose driveways will be occupied by film props. Overnight parking would be necessary every evening from Monday, July 6 – Friday, July 10.

Normal filming hours in residential areas are Monday – Saturday from 8am – 9pm. Warner Bros requested to begin filming one hour earlier at 7am on Wednesday, July 8 and Thursday, July 9.

There was also a request for set props to remain in place overnight on Alta Drive such as film trucks, dumpsters, and bathrooms.

Local access to residents will be maintained at all times.

Former Beverly Hills Resident Found Guilty of Scheming to Manipulate Stock Market

A stock analyst and frequent guest on business television news channels was found guilty by a jury for using his public platform to illicitly profit by manipulating stock market activity and trading opposite to the position he presented to the public.

Andrew Left, 55, formerly of Beverly Hills but who now resides in Boca Raton, Florida, was found guilty of one count of securities fraud scheme and 12 counts of securities fraud.

"Left used his TV appearances to disguise his intentions, manipulate the stock market, and pad his pockets," said First Assistant United States Attorney Bill Essayli. "A fair and transparent securities market is a foundation of our nation's financial system. We will continue to bring to justice individuals who abuse the public trust placed in financial advisors."

According to evidence presented at a 15-day trial, Left was a securities analyst, trader, and frequent guest commentator on business cable news channels such as CNBC, Fox Business, and Bloomberg Television. He also published under the name "Citron Research," an online moniker he created

for his platform to publish investment recommendations. Citron's online presence included a website and a social media account on X, formerly known as Twitter.

Using Citron's online platform, Left commented on publicly traded companies and asserted that the market incorrectly valued the companies' stock, advocating that the current price was too high or too low.

Left's recommendations often included an explicit or implicit representation about Citron's trading position and a "target price," which he represented as his own view of the security's true future value.

Left used his social media following and public platform to earn at least \$21 million in quick profits by fraudulently manipulating the stock market from at least March 2018 to October 2023.

Beverly Hills City Council 2026-2028

The City Council is now set after a somewhat extended and contentious campaign: Mayor **Craig Corman**, Vice Mayor **Mary Wells**, **Sharona Nazarian**, **Lester Friedman** and **Rebecca Pynoos**.

The net result is substantial stability as the only new face is Rebecca Pynoos as a replacement for **John Mirisch** who has been termed out.

Our voters have chosen an “if it ain’t broke don’t fix it” path rather than a “move fast and break things” path. It is my perception and belief that while the government of the Beverly Hills bubble is not perfect, it is far better than most and a glass that is 90% full should not be mindlessly shattered. The voters agreed.

Before we get to the City Council race, it is important to note that the highest vote getter was City Treasurer **Howard Fisher** who was re-elected to a third term. As Treasurer Fisher was unopposed, he was able to score almost as will.

So let’s take stock of the Council race. The gold medal performance was that of Sharona. Her support was astonishingly and deservedly twice that of her closest rival. Sharona had just completed a very successful and high profile term as Mayor. And as the rotation of the job of Mayor currently stands, Sharona will be Mayor again during the 2028-9 year when Greater Los Angeles will be hosting the Olympic Games. Sharona is the perfect person who combines charisma and an important personal history as a refuge from religious prosecution to welcome the world to our City.

Lester, who embodies steadfast calm under fire, ran a somewhat reserved campaign under the guidance of **Tiffany Davis**, and deserved to be re-elected for a final term.

Pynoos, a longtime commissioner who has maintained a low profile as she has steeped herself with knowledge of the myriad nooks and crannies of our City government, was the surprise of the campaign. It appears as of this writing that she will win the third seat. Simply put, Rebecca worked the hardest to get to know as many people as possible and managed to impress everyone that she met. As a newcomer to our City’s hardball local politics, Rebecca will have to develop a thick skin and learn that personal attacks, often nasty and defamatory, must be ignored.

Interestingly, with Rebecca serving with Nazarian and Mary Wells, this may be the first time that we have had three elected female City Council Members serving together. I am told that when **Kathy Reims** was appointed to finish the remaining months in **Willie Brien**’s term, she served for a time with **Lili Bosse** and **Nancy Krasne**. But this may be the first time that we have elected three members of the Council.

Andy Licht made a very strong run for the third available seat. Andy has lived in the City most of his life, raised three children here and is devoted to the City. Andy is now serving on his third commission, Cultural Heritage, after Traffic and Parking and Planning, and was making his second try for a City Council in an effort to continue to serve the City. No one wanted the City Council

seat more than Andy and this campaign was truly a family affair. Andy’s accomplished wife **Lisa Licht** played a central role in his campaign. Andy and Lisa ran a strong campaign with the help from a multitude of friends and really did nothing wrong. His desire to serve remains strong and I am hopeful that he can find a role with the City so that we do not lose the benefit of his knowledge and many talents.

The distant fifth place and sixth place finishers were **Russell Stuart** and **Ariel Rofeim**. I have explained in detail the reasons that I could not support or recommend Mr. Stuart for City Council. Now I will comment only on the very unusual campaign that he ran. He relied heavily on social media posts using artificial intelligence (which is no substitute for the real thing) to the exclusion of efforts to actually meet and engage with other candidates or, more importantly, the voters. His postings suggested that he was supported by the extraordinarily popular Nazarian. Sharona told me on more than one occasion that she did not support or endorse any other candidate. Beyond this, Stuart’s approach was a corollary of the saying “you can run but you can’t hide”. If you run for office, you cannot hide. But Mr. Stuart attempted to run virtually and otherwise hide. Nevertheless, voters had observed enough to conclude that he would not be a good choice. It was particularly gratifying to observe that one strident social media poster who supported Mr. Stuart and viciously attacked one of his opponents not only was ineffective but also likely backfired in her efforts to help him.

I have been informed that Mr. Stuart has posted on social media that since he was not elected to the City Council, he will remain committed to the rest of his term on the school board. Whether or not he remains, I am hopeful that Mr. Stuart will learn from this experience.

Two younger candidates, Ariel Ro-

feim, who finished closely behind Stuart, and **Roger Tanenbaum** made positive contributions during the campaign. Both would benefit from more active formal involvement with the City through Team Beverly Hills and/or service on one of the Commissions and then try again to be involved in the future.

Other candidates brought forth good subjects for consideration including the proposal from **Jonathan Mariande** that we explore the possibility of becoming a charter city.

There were interesting results in other elections that affected us.

Our state senator **Ben Allen** who is termed out, made the runoff in his race for California Insurance Commissioner. He finished second in the primary to **Jane Kim**, a former San Francisco Supervisor and progressive activist. Kim is endorsed by Senator **Bernie Sanders** and Ben Allen will be facing a challenging campaign in the November general election. My sense is that Senator Allen will attract sufficient moderate voters to win this important office.

Brian Goldsmith, running to succeed Senator Allen in District 24, finished second in this strongly Democratic District. **John Erickson** of West Hollywood, a YIMBY who, inexplicably to me, had the backing of former Mayor **Julian Gold**, came in first.

Two other local Democrats, **Jake Levine** and **Zach Sokoloff**, did not fare well in their first attempts at public office. Mr. Levine finished third in his effort to defeat long-time U.S. Congressman Brad Sherman. Mr. Sokoloff lost in his effort to defeat Los Angeles City Controller **Kenneth Mejia**.

Finally, I was pleased to see that “controversial” Los Angeles City Attorney **Hydee Feldstein Soto** appears to have gone down to defeat. Progressive **Marrissa Roy** and Deputy District Attorney **John McKinney** finished first and second in this race. I much prefer Mr. McKinney, a moderate and well thought of prosecutor for this job.

WHAT'S NEXT FOR THE SOUTHEAST?

City Council Considers Concerns Raised by Southeast Residents at Community Meeting

The City Council discussed issues raised during a March 23 Southeast area community meeting, at its Tuesday meeting.

"I think this was a wakeup call," Councilmember Les Friedman said. "There really has been a hesitation by commercial developers in that area. People were hesitant to rent space in that area and rejuvenate it because there would have been so much down time until the metro station opened."

In March, the City Council attended an outside meeting hosted by residents at La Cienega Community Center with the intent of listening to their concerns.

"On Tuesday, the City Council reviewed feedback from the Southeast Area Community Meeting held on March 23. I appreciate the City creating an opportunity for residents to share their concerns and priorities, and I am encouraged that the Council is

continuing the conversation," organizer Noelle Batista said. "The Southeast is an important part of Beverly Hills, and ongoing communication between residents, City staff, and the Council will be critical to addressing community needs. I am particularly encouraged by the focus on public safety and the long-standing desire for a police substation in the Southeast."

Over 100 residents attended the meeting in March to discuss the quality of life of the area, public safety, affordable housing, parking, and problems with edison and power outages. Residents said they believe that area of the city has been neglected.

When it comes to traffic, residents feel that the area has had an increase in speeding drivers and a lack of compliance with local street rules. To address this issue, the city indicated traffic and motorcycle units have been performing



additional speed and stop sign enforcement operations in the area of Carson from Wilshire to Gregory.

There was also a desire for family friendly businesses and investment in the area, including walkable streets. The report indicated that the Clock Market property may be leased to a future business that will help to activate the area, once the existing lease expires. The report also mentions the city's Mixed Use ordinance, which "could promote walkable and inviting streets by allowing both residential and commercial uses on several streets in the Southeast Area including Wilshire, La Cienega, Robertson, and Olympic," according to the report.

When it came to public safety, residents have previously raised the last stop concern, which included the potential for loitering after the last trains.

When it comes to city actions, two additional police officers on a daily basis have been assigned to the area surrounding La Cienega station. The city is also adding Beverly Hills Outreach Team resources and private security specifically for response at La Cienega Station and surrounding areas.

"As our city moves forward following this recent election, Southeast residents are optimistic. Throughout the campaign, candidates shared numerous ideas, commitments, and plans for improving our neighborhood. Residents have paid close attention, saved that campaign literature, and are eager to see those promises translated into action. The June 9th discussion was an encouraging sign that there is a growing recognition of the importance of Southeast Beverly Hills, and we look forward to working with our elected leaders to ensure this area remains a priority in the years ahead," Batista said.

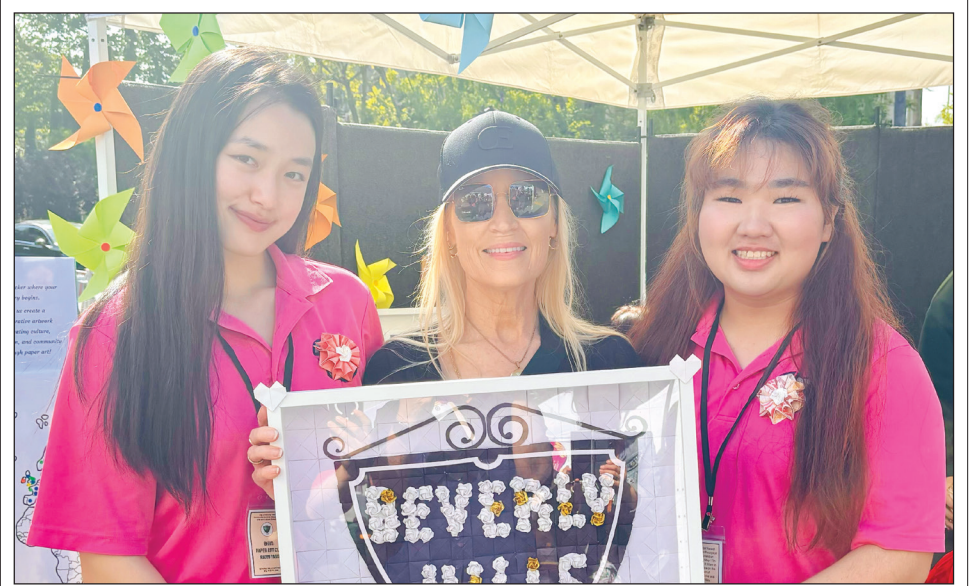

STANDARD FAMILY LAW RESTRAINING ORDERS

Starting immediately, you and your spouse or domestic partner are restrained from:

- removing the minor children of the parties from the state or applying for a new or replacement passport for those minor children without the prior written consent of the other party or an order of the court;
