## Hilton Carried Beverly Hills

According to the June 9th statement of votes cast published by the Los Angeles Registrar-Recorder, Steve Hilton carried Beverly Hills for Gov., with 5,109 votes. Xavier Becerra received 2,022 votes in Beverly Hills, Tom Steyer received 1,667 and Chad Bianco received 283 votes.

## BHUSD Executive Director Files \$3M Discrimination Lawsuit Against Former Employer

Issaic Gates, BHUSD's Executive Director of Personnel Services, has filed a \$3 million lawsuit against the Placentia-Yorba Linda Unified School District (PYLUSD), according to a June report published by *Orange Juice Blog*.

The report states the lawsuit stems from Gates' prior employment with PYLUSD and includes allegations of discrimination and harassment during his time at the district.

Gates previously served in a senior administrative role in PYLUSD under then-Superintendent Alex Cherniss, who is now superintendent of BHUSD. The report states Cherniss was involved in bringing Gates into PYLUSD.

BHUSD announced the appointment of Gates as the District's new Executive Director of Personnel Services on Nov. 5.

BHUSD declined to comment.

## BHUSD Bond Oversight Committee Reports Financial Audit

The Citizens' Bond Oversight Committee (CBOC) released its annual report on Measure E and Measure BH bond programs for the fiscal year ending June 30, 2025.

An independent financial audit by Christy White reported \$51.3 million in bond expenditures and a \$113.9 million ending fund balance. No material weaknesses or internal control deficiencies were found.

The committee reported continued construction progress at Beverly High. It also cited \$22.9 million in value engineering savings during the year.

"The CBOC remains highly satisfied with the transparency, fiscal discipline, and operational excellence of BHUSD staff and Fonder-Salari. They have transformed the program from a projected shortfall of more than \$100 million in July 2022 to a balanced position with a prospective surplus," according to CBOC comments on the report.

The CBOC recommends "a closeout construction audit and full reconciliation of ProWest job costs at project completion, and present results to the CBOC and the public to definitively close the open-book accounting documentation gap."

The schedule is as follows:

- North of Santa Monica Boulevard —Monday and Friday
- South of Santa Monica Boulevard —Tuesday and Saturday
- No watering on Wednesday, Thursday or Sunday

There is no water run-off on the sidewalk or street. There is no watering, sprinklers or hose, after 9am or before 6pm. Supplemental watering for trees is allowed. Violations will be issued for non-compliance.

### Free Shredding, E-Waste and Compost Event to Take Place

On June 28, the city will be hosting a free shredding, e-waste and compost event from 8AM – 12PM at Civic Center Drive and 3rd Street.

The City partnered with Shred Source, a NAID AAA Certified company, to offer free shredding services. All paper is recycled at a recycling center and sent out to be pulped and used for other paper products.

This will be a contactless drop-off event and city staff will be there to assist with unloading. The city recommends residents box paper material to be shredded, remove all paper clips,

binding clips, rubber bands, and staples when boxing paper. Acceptable material includes medical records, financial records, utility bills, tax documents, pay stubs, and all sensitive paper documents, and more.

Hard drives, books, e-waste, binders, cardboard, x-rays, cd's, tapes, VHS, and hanging folders will not be accepted.

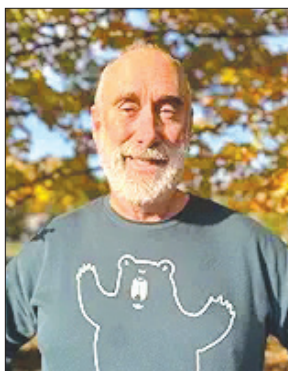

## New City Manager Ryan Gohlich

Ryan Gohlich takes office as our new City Manager on July 1, and I thought that we should get to know him better.

I first got to know Ryan in 2016-7 when he was a leader of the planning group in the Community Development Department and I was among a group of residents opposing some hillside developments. I found Ryan to be an affable and formidable adversary with an encyclopedic knowledge of land use laws, rules and practices. In the years since, Ryan has enhanced his scope of understanding and responsibility. I think that he is an excellent choice for the increasingly challenging job of City Manager.

First, his background. Ryan is from southern California and graduated from Hart H.S. in Valencia. He holds a Bachelor of Science degree in City and Regional Planning from California Polytechnic State University at San Luis Obispo and a Master of Arts in Organizational Leadership from Woodbury University.

He is also professionally certified through the American Institute of Certified Planners and is a member of the American Planning Association.

Before coming to the City, Ryan worked for a planning consulting firm in SLO. He decided that he wanted to work for the City because it was, in his view, a world renowned City with lots of interesting aspects and prospects. He joined the City in 2007 as an Assistant Planner and has served successively as an Associate Plan-

ner, City Planner, then Assistant Director of Community Development and was named Director of Community Development in 2021. Ryan has done everything about land use in the City except windows. He was appointed Assistant City Manager in 2023.

A youthful 43, the City recently announced that Ryan would become City Manager. No City Manager in recent memory has had a planning background as extensive as Ryan's. It is also fair to observe that no one can match Ryan's institutional knowledge about the development and planning of the City.

Ryan described the job of City Manager as responsible for the overall operations of the City and the implementation of the City Council's policies and objectives. His personal priorities are ensuring that the City performs its core services, safety, security and infrastructure at the highest level.

We discussed land use issues at some length. He explained that the current Regional Housing Needs Assessment which resulted in an allocation to the City of 3100 housing units presented challenges for the City and every other City that were unprecedented. The challenges were particularly acute for cities like Beverly Hills that do not have vacant space. For Cities with substantial vacant land, certification of a new General Plan Housing Element was relatively easy. For our City, it was not. He pointed out that we hired the best consultants and involved very talented City planners. I agree with that. My principal criticisms of the City's approach are

that there was no individual person who was responsible the Certification and that the Council did not receive regular (i.e. every six weeks or so) status reports from that person. This may not have made a difference but it is essential for sound management of an important project.

Looking forward to the next RHNA cycle commencing in 2029, we both agreed that the City and others push for a change in current law to provide that the results of increased units due to use of Density Bonuses and other rules count toward satisfaction of our allocation. Currently, while almost all multifamily projects include additional units through use of density bonuses, only the number of units provided for by current zoning without such bonuses "count."

I recommended that we have more active Council management and hire someone to be in charge with a record of success in achieving certification in a City comparable to Beverly Hills in terms of little, if any, open space. Ryan was non-committal about this. He pointed out that we won't know the magnitude of our task until new allocations are announced and the effects of new laws and rules are clear. For example, he said that it is possible that the application of SB79 providing for increased density around the Metro stations will result in sites for 15,000 dwelling units.

He repeated what other City leaders have said about public safety, that BHPD is doing a great job and can confidently state that if someone commits a crime in the City, that person will be apprehended and prosecuted. He pointed out that the Real Time Watch system and drones are great tools.

BUT City leaders have for a number of months touted the fact that the Council has authorized the hiring of eight new sworn police officers. This is true but not the whole truth. The current BHPD authorized force is 154 sworn officers after

the addition of the eight new positions. And the City budget provides sufficient increased expenses to allow for that number.

However, the actual number of BHPD sworn officers is approximately 135 and has generally been at or around that number for several years perhaps with occasional brief spikes.

And that includes officers who are on disability due to injuries, officers in training (who cannot go on patrol without supervision) and officers who have been hired but are at the Police Academy. Ryan argued that we actually budget for the authorized number and have increased the budget to reflect the newly authorized eight officers, but "virtual" additional officers are not officers on the street. He said that we make up for the staff shortfall by adding overtime shifts.

Actually, the City does benefit from authorizing more officers and budgeting for hires that are not accomplished. At the end of the year, because the City does not expend budgeted funds for officers who were not hired, we have a surplus of unexpended funds that help to achieve a balanced budget.

I take no comfort from authorizing additional unfilled positions. Increasing the number of open positions from ten to fifteen or so does not put more police officers on patrol. I fully appreciate that it is very difficult to hire additional police officers at a time when everyone else is trying to do the same. I am hopeful that somehow we can be more successful in hiring officers than we have in the recent past. In the meantime, it would enhance the credibility of our elected officials if they would state only that we have budgeted for additional officers rather than prematurely claim that we have actually hired more officers.

On the subject of a new police chief, Ryan would say only that there will be an announcement shortly.

Ryan Gohlich, you have taken on a very challenging position. I wish you great success.

## BHAAA TURNS 20

### Beverly Hills Athletic Alumni Association on Two Decades of Giving Back

Twenty years after its founding, the Beverly Hills Athletic Alumni Association continues to draw support from former student-athletes.

For Founder Steven Fenton, who also served on the Board of Education from 2007 to 2011, it started with a visit back to Beverly High, where he met with then-coach Carter Paysinger and took a walk through the athletic department.

"I went down to the athletic department, and I remember feeling so upset with what I saw," Fenton said. "Everything was dilapidated, nothing was new. Everything was run down. Everywhere you turned, morale was really low."

That visit led to the creation of the Beverly Hills Athletic Alumni Association, or BHAAA, in 2006.

The organization was created to support Beverly High athletics through fundraising, facility improvements, equipment purchases and scholarships. Since then, it has contributed to projects across nearly every athletic program on campus.

One of the organization's earliest turning points came shortly after its founding, when Fenton approached alumnus and former wrestler Lyn Konheim about supporting the vision.

Fenton said the two met for breakfast before heading to the football field, where they met with Paysinger.

"We were standing on the 50-yard line looking at the building," Fenton recalled. "I had this vision and I was so excited, so I just came out with it and pitched him the idea."

Konheim told Fenton he wanted to speak with his brother before making a commitment.

"He called me that afternoon and said the Konheim family was in," Fenton said.

The family's support helped launch the organization and ultimately led to the nam-

ing of the Konheim Athletic Building.

"Their generosity not only put us on the map, it gave us legitimacy," Fenton said. "It was an announcement to the community that the Konheims backed BHAAA and all that we stand for."

Today, the Konheim endowment remains one of the primary sources that drives the entire organization.

"There would be no BHAAA without the Konheims," Fenton said.

David Corwin, a former BHAAA president, said the organization was structured differently than a traditional booster club.

"There are other schools that have booster clubs," Corwin said. "Steven and Carter's idea was to have an independent organization where people could support a specific sport if they wanted to, but it would go through a third party and not involve the coaches directly. I think that was an important feature of the way it was set up."

Over the years, BHAAA's support has included uniforms, scoreboards, locker room improvements, athletic equipment and facility upgrades.

"For much of the last 20 years, we've been the primary provider of uniforms for every sport at every level," Corwin said. "Whether it's scoreboards, tackling sleds, water polo goals [or other equipment], you can look across almost every sport and see where [BHAAA] has contributed."

The organization also awards annual scholarships to graduating student-athletes, including the Don Reynolds Spirit of Life Award, the Founder's Award and the Lessie Paysinger Award.

In 2007, BHAAA also established the Beverly Hills High School Athletic Alumni Hall of Fame, which recognizes those who have made significant impacts on athletics.

"When we started, I knew we needed

an anchor, so we created a Hall of Fame," Fenton said. "The Hall of Fame has been so meaningful for so many people, but our organization is so much bigger now than just our Hall of Fame and the lives that we're able to touch, and the people that we're able to help has far exceeded my expectations. I think I knew people loved playing sports at Beverly, but I guess I underestimated how deep that love really went."

Joey Behrstock said the Hall of Fame event has become one of the highlights of BHAAA's calendar.

"Seeing so many people you went to high school with has always been so much fun," Behrstock said. "The Hall of Fame has always been a real highlight of the year."

BHAAA has also expanded through BHAAA Assist, which is designed to support alumni facing financial hardship.

"Now we're able to support the student-athletes at Beverly as they transition to college and into adulthood," Fenton said. "That through line will always be there for them."

Many board members no longer have direct ties to the school, some don't even have children in the district, but they continue to volunteer their time and raise money for athletics.

For Michael Nourmand, athletics played a significant role in his experience as a student.

"I don't have kids in the Beverly Hills school district, but I enjoyed going to Beverly and the education I received there. Even though I don't have kids there, I still feel I should be willing to pay it forward," Nourmand said.

Nourmand said one of the biggest rewards is seeing the improvements made over the years.

"You can see the facilities are better," he

said. "The football field looks better. There are new tennis nets. You can see the work that we're doing."

Gregg Silver said athletics created friendships that have existed after graduation.

"I think all of us — the reason we got into sports to begin with was the camaraderie and the brotherhood, and in a lot of cases sisterhood,

too," Silver said.

Several founding board members remain active with BHAAA today.

"There are seven of us who have been board members for 20 consecutive years," Fenton said.

This includes Bob Kay, Tony Behrstock, Joey Behrstock, Nourmand, Fenton, Silver, and Corwin,

Looking ahead, Fenton said one of BHAAA's goals is to help strengthen middle school athletics.

"We've been asked to really help cultivate the middle school sports athletic program, the next generation of Beverly athletes," Fenton said. "We're very much engaged with the school district in figuring out how we can best support the middle school sports program."

Fenton said BHAAA is also working with the district on future athletic facility projects and donor opportunities tied to new campus improvements.

"A big goal of ours is to continue to provide opportunities for our alumni and donors who want to engage on that level and be a part of the exciting things that are happening at Beverly," he said. "People are really excited about the new facilities and we are so grateful for the school district, the board and Superintendent Alex Cherniss giving us this opportunity to go out there and find great matches for all these new buildings and fields."

For Corwin, the organization's staying power is measured by the relationships that have endured.

"Bringing people back together who otherwise have fallen out of touch but still have such a strong bond with the time they shared at the high school," Corwin said, "is the most special part of it."


