Transit to the Subway – ONLY

This is an open letter to the City Council addressing an item that I anticipate will be on the agenda for the study session on July 21 – a "MicroTransit Pilot Project".

I respectfully request that you take the following action:

- 1) Use the restricted Prop A funds to pay for the station plaza security building;
- 2) Create a much more modest and sensible microtransit pilot project that will be **limited** to taking people to and from locations in the City to and from the Metro Subway stations in the City; and
- 3) Put someone – **a named individual City employee**, not a department head, not generic "staff", who will be responsible and accountable, in charge; and report regularly to the Council.

This proposal is made in the following context.

The Station Plaza Security Building

The City has available funds restricted exclusively for public transit use created through a county wide permanent half-cent sales tax. [Prop A funds.] Currently, the City has available more than \$3 million in Prop A funds.

The City has committed to Metro to fund the entire cost of a security building

on the Plaza of the Wilshire/LaCienega subway station. Although initial estimates for the cost were approximately \$500,000, the City did not negotiate a cap on its obligation and the costs are currently estimated at \$3 million. (In exchange for paying the cost of construction, the City has only the right to use the building for five years.)

I note that the temporary security building immediately to the east of the Plaza is working well and would be sufficient for security purposes. Unfortunately, it appears that we are committed to spending whatever Metro claims the plaza building costs so this option is not available to us.

The staff report recommending an elaborate but largely unneeded microtransit project does not disclose that Prop A funds could be used for construction of the security building (or even mention the security building for that matter), I am informed that construction costs of this building are a permissible use of Prop A funds.

Important Note: This matter was on the June 23 Study Session Agenda and I am referencing the staff report prepared for that occasion. I was told that the staff report would not change for the upcoming meeting. It is of course possible that a staff member may change that report after reading this column or for other reasons. However, the point remains the same: Prop A funds should be used

for the security station and we should go back to the drawing boards for a scaled down microtransit system that does no more than serve the subway stations.

Given where we are, we'd best use these funds first to discharge our obligation to pay for the security building. And note that we really have no control over what the ultimate cost will be (those are already 6x what we thought and the final tab could be higher) and we should try to protect the general fund.

The MicroTransit Pilot Project

Given that Metro has invested Billions of dollars to bring us a subway, which offers a dramatic improvement in travel times to LACMA/DTLA and other points east, reasonable measures to encourage our residents to use it are long overdue. But that is all that is necessary or desirable.

For at least five years, the City has talked about providing imprecisely named "first mile/last mile" service to facilitate access to and from the subway station.

The background provided in the staff report is more notable for what it does not say than for what it does say. In short, there have been several ill-conceived (but expensive given the cost of outside consultants and staff time that no one keeps track of) proposals that have been expressly rejected or quietly dumped.

Virtually nothing was done for two or three years – nothing.

The current proposal was the result of a Request for Proposals issued in November 2024. This RFP was transmitted with no prior public discussion and contemplated commencement of service in the summer of 2025 in advance of the opening of the Wilshire/LaCienega station. Responses from proposed vendors

to supply this service were received in January 2025 and nothing was done for more than a year before it was presented to Council.

Here we are after several years and we have a proposal that makes no sense and is very expensive. The main problem with the current proposal is that it is **not limited** to taking people to and from the Metro station(s). It should be.

Nothing more is needed and extension beyond that would distract from and make transportation to the stations less readily available. And it would cost much more than need be the case.

Staff proposes that Prop A funds be used for this. The staff presentation suggests that since funds are not coming from the general fund that cost is no object. It ignores the fact that we have a looming \$3Million+ obligation for the security building that is eligible for use of those funds.

The goal of microtransit and its implementation in the City should be limited to fostering the use of the subway by helping people get to and from the subway from

their homes or businesses.

Responsibility and Accountability

One individual City employee – not the Council as a whole or the City Manager, not a department, not a department head, not generic “staff” – **one named individual** – should be responsible for making useful microtransit happen and that future dealings with Metro are productive.

In short, we need an individual who will be our **“Metro Czar” who will be responsible and report regularly to Council.**

Why? Because the City’s dealings by committee with Metro have been a case study in bungling. When a committee (and Council is a committee) or department (and the Department of Public Works is always a case study in opaque-ness) is in charge, no one is in charge.

Examples:

The City wanted a “portal” or entrance to the Beverly Drive station on the north side of Wilshire (the “North Portal”). The City agreed to share Metro’s claimed cost of construction 50/50 with Metro but neglected to negotiate a cap on our share. When the projected costs escalated to

nearly three times what the City anticipated, the idea of a North Portal was abandoned – after the City had spent at least \$1.5 million on the North Portal design.

The City agreed to pay Metro’s claimed cost of construction of the security building on the Wilshire/ La Cienega station plaza that was to open when subway service began on May 8. Once again, the City did not negotiate a cap on these costs. Initially, they were estimated to be approximately \$500K. Now, they are projected to be \$3 million but who knows what they will really be or when it will really open. Had the actual cost been known, we may have continued to use the security space behind the Plaza’s eastern wall at nominal cost. We no longer have that option.

The City has known the Metro was coming for at least a decade and has been fumbling around with ideas for so-called “first mile/last mile” access for at least five years. Expensive consultants have been retained and countless (but uncounted) hours of staff time have been expended. Nothing sensible has come of this and the current proposal is no exception.

I challenge you to find any individual

who will take responsibility for any one of these bumbles.

I respectfully suggest that if one person is assigned responsibility, there is a chance, not a guarantee, that the results of our dealings with Metro will improve and provision of efficient access to and from the subway stations will happen.

Here’s a note from last Saturday’s *Wall Street Journal* for those of us who, from time to time, forget how fortunate we are:

In 2022, when the NYC Metropolitan Transit Agency which runs the City’s subways opened applications for jobs cleaning subway cars and platforms, more than 75,000 people applied for jobs paying \$20.89/hour.

Greg Barton, the beloved Chief of the BHFD, has announced that he is retiring later this fall once a replacement has been named. (See page 3). I have never heard a word of criticism about the Chief and he will be greatly missed. I will write more about him once I can get on his schedule for a chat and one of his favorite Australian meat pies.

AN ORDINANCE OF THE CITY OF BEVERLY HILLS TO AMEND ACCESSORY DWELLING UNIT REGULATIONS CONSISTENT WITH REQUIREMENTS IN GOVERNMENT CODE SECTIONS 66310 THROUGH 66342 AND FINDING THE ORDINANCE TO BE EXEMPT UNDER THE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA)

The draft ordinance is intended to improve clarity, eliminate confusion, and streamline regulations of the Beverly Hills Municipal Code (BHMC) and align it with current state law. The amendments in the draft ordinance would affect topics including, but not limited to:

- Reorganization of the article [BHMC Article 50];
- Aligning the number of ADUs allowed consistent with state law [BHMC §10-3-5000.A.1 and §10-3-5001.A.1];
- Amendment to the owner occupancy requirement for JADUs meeting certain criteria [BHMC §10-3-5000.A.7];
- Clarifications to the provision regarding conversion of unenclosed accessory structures [BHMC §10-3-5000.A.4, §10-3-5000.A.9, and §10-3-5001.A.4];
- Amendment to the covenant requirements [BHMC §10-3-5000.A.14 and §10-3-5001.A.12];
- Update to the historic resource protection provision [BHMC §10-3-5000.A.18 and §10-3-5001.A.19]; and
- Clean-up of the window requirement for multifamily ADUs [BHMC §10-3-5001.A.18].

The Planning Commission previously reviewed this topic at the June 11, 2026 regular meeting and adopted Planning Commission Resolution No. 2124 unanimously recommending the City Council adopt the ordinance.

This summary of the ordinance is prepared and published in accordance with the requirements of Government Code §36933. A certified copy of the entirety of the text of the proposed ordinance will be available for review during normal business hours at the Office of the City Clerk Office located at City Hall, 455 N. Rexford Drive, Second Floor, Beverly Hills, CA 90210 at least five days before the City Council will consider adoption of the ordinance.

ENVIRONMENTAL REVIEW

This project has been assessed in accordance with the authority and criteria contained in the California Environmental Quality Act (CEQA, Public Resources Code Sections 21000 et seq.), the State CEQA Guidelines (California Code of Regulations, Title 14, Sections 15000 et seq.), and the environmental regulations of the City. Pursuant to §15282(h) of the CEQA Guidelines and §21080.17 of the California Public Resources Code, the adoption of an ordinance regarding accessory dwelling units to implement the provisions of Government Code §65852.1 and §65852.2 is statutorily exempt from CEQA requirements. As a result, staff recommends the City Council find the draft ordinance exempt under these provisions from further environmental review under CEQA.

Public comment via video conference will be no longer than three (3) minutes per each individual comment, subject to City Council discretion based on the anticipated length in the meeting. Any interested person may participate in the meeting and be heard or present written comments to the City Council. According to Government Code Section 65009, if you challenge the Council’s action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City, either at or prior to the public hearing.

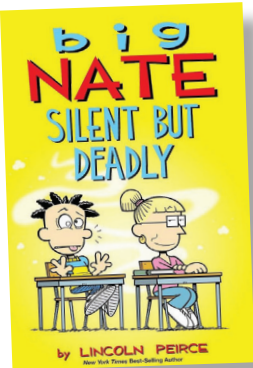

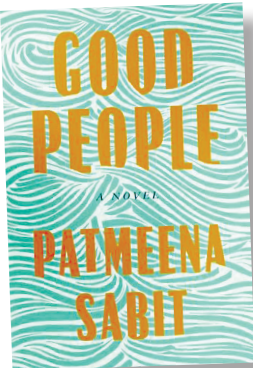

What Are Your Neighbors Reading?

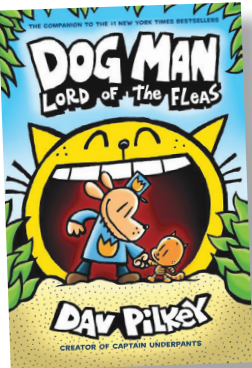

While the Beverly Hills Public Library's annual Summer Reading Club concludes July 31, summer remains one of the busiest seasons for readers looking for their next book.



This year's Summer Reading Club, themed "Plant a Seed, Read," encourages readers of all ages to explore new authors and genres while making reading part of their summer routine. According to the library, the theme draws a comparison between a farm, which grows food that nourishes the body, and a library, which offers ideas that nourish the mind.



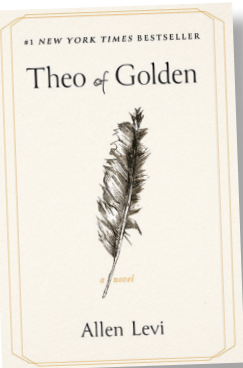
Karen Butth, Beverly Hills city librarian, said "readers of all ages are invited to branch out into new stores and bloom into lifelong learners."



Butth has worked at the Beverly Hills Public Library since 1983, overseeing the cataloging and care of the library's collection. "Reading is my favorite activity — especially in the summer on my swing by the pool," Butth said. "I can relax and live in a whole new world with science fiction and fantasy or help a detective solve a mystery. I love to share titles with my family."

BHEF President Tina Wiener is reading The Vanishing Act of Esme Lennox, by Maggie O'Farrell, and listening to the audiobook Atonement, by Ian McEwan. "I love the parallel themes in these books regarding the concepts of truth, conflicting versions of events, and skewed perspectives, all which have life-long consequences for the female protagonists. Next up is Good People by Patmeena Sabit, which is the title for the August 'Beverly Hills Reads' event." Former Health & Human Relations Commissioner Erica Felsenthal is reading The Tattooist of Auschwitz by Heather Morris. "It's a powerful story that educates about the Holocaust and humanizes the unimaginable, a reminder of why we must keep telling these stories, especially as fewer survivors remain to share them firsthand." BHEF Director of Development & Operations Tiffany Davis is reading Lighter

by Yung Pueblo. "I have always loved biographies, and in recent years have been drawn to biographies which also teach me something about myself and help me evolve personally." Recreation and Parks Commissioner Donna Gillman is reading "Percy Jackson and the Olympians" by Rick Riordan. "My son has been really enjoying reading the series, so I thought it would be great for me to read it alongside him. It's been a fun way for us to share something together." Recreation and Parks Chair JR Dzubak is reading Written Before I Knew: A Story of Divine Faith and Purpose by Julie Dell'Aquila Hernandez. "What I like so far is that it is a human-interest story of connection, spirituality and how you can discover yourself through various lenses."



Along with encouraging reading throughout the summer, the library has also tracked some of the books community members have been checking out most frequently. Among adults, popular titles include Good People by Palmeena Sabit, Whistler by Ann Patchett, Corre-

spondent by Virginia Evans and Theo of Golden by Allen Levi. Beverly Hills is in good hands." Board Approves \$175,500 Mental Health Services Agreement The Board of Education approved a professional services agreement with Elham

Samadi at its Tuesday meeting to continue providing mental health and wellness services for students and families. However, the board declined to renew their MFT contract with three other counselors previously brought in, making Samadi the only counselor. Under the one-year agreement, Samadi will serve as Mental Health & Wellness Supervisor, providing mental health counseling and intervention services, conducting student assessments, facilitating monthly parent forums, and more.

The agreement increases the hourly rate from \$130 to \$135.20 for up to 6.5 hours per day. The contract has a not-to-exceed cost of \$175,500, which will be funded through the district's Special Education budget.
