Beverly Hills Considers New Adopt-A-Tree And Park Bench Donation Programs

The City Council provided direction to move forward with the proposed Adopt-a-Tree program and expand the existing Park Bench Donation Program to provide additional opportunities for community members to support and memorialize city parks.

The City Council also agreed that tree dedications would include a 25-year replacement obligation if a dedicated tree is lost. After that period, replacement would be at the city's discretion. City staff was also directed to revise the donation agreement language to clarify the program's terms.

Under the proposed Adopt-a-Tree program, donors would contribute \$20,000 to dedicate either a new or existing tree in a city park.

Certain locations would not be eligible, including areas of Beverly Gardens Park with existing donor agreements and areas used for the Beverly Hills Art Show.

Donors would receive recognition through a low-profile marker designed to avoid impacting park walkways, open

space or tree growth. Funds would be transferred to the city for park maintenance and improvements.

City Council Reviews Proposed Beverly Hills Microtransit Pilot Program

The Beverly Hills City Council opted not to move forward with the proposed microtransit pilot as presented during its Aug. 4 study session.

The city was weighing a proposed two-year microtransit pilot program designed to connect community members to the Metro D Line stations and expand local mobility across the city.

As presented Tuesday, the pilot would have been funded entirely through Los Angeles County Proposition A transit funds. The city has about \$4.8 million in reserves and receives roughly \$840,000 annually.

The proposed program was estimated to cost about \$3.1 million.

The service was looking into integrating with Dial-A-Ride and considered overflow support through a Waymo partnership.

Influencer Held Without Bail Following Beverly Hills Arrest

Social media influencer Adva Lavie was ordered held without bail Friday after being arrested earlier this week in Beverly Hills on a warrant from Riverside County, according to *FOX 11*.

Lavie, 29, who is also known as Mia Ventura, was arrested last week on North Cannon Boulevard and Brighton Way by the Beverly Hills Police Department. Jail records show she was taken into custody on a Riverside County warrant stemming from a grand theft charge, *FOX 11* reported.

According to the Los Angeles District Attorney's office, prosecutors allege that from 2023 to 2025, Lavie used dating apps and cultivated relationships to burglarize and steal from wealthy older

men and younger women in Westlake Village, West Hollywood, Los Angeles and Beverly Hills.

According to the DA, Lavie is accused of posing as a girlfriend to gain access to victims' residences to steal cash, and other luxury items. If convicted on all counts, Lavie faces up to 11 years, eight months in state prison.

“At her trial, we will prove beyond a reasonable doubt that this defendant exploited trust built through online relationships to gain access to victims' homes and steal from them. Her ability to deceptively influence others, whether in person or online, has now come to an end. Our office is committed to holding accountable anyone who uses deception and manipulation to prey on others,” District Attorney Nathan Hochman said in March.

She previously pleaded not guilty to all charges.

Israel Supports Beverly Hills October 7th Memorial Project With \$10,000 Contribution

The City Council approved a participation agreement with the State of Israel, through its Consulate in Los Angeles, accepting a \$10,000 contribution toward the city's October 7th Memorial Project.

The city has committed \$500,000 toward the project, while the Community Charitable Foundation will continue seeking additional contributions to support remaining project costs.

Under the approved agreement, the State of Israel will provide the \$10,000. The Consulate will receive recognition at the memorial site.

The agreement includes updated language regarding the refunding of contributions if the project is canceled. If cancellation occurs before construction begins, the Community Charitable Foundation would refund the full par-

ticipation amount to the Consulate. If cancellation occurs after construction begins, refunds would be issued proportionally with refunds to other donors and contributors from remaining unused project funds.

Beverly Hills Fire Department Conducts Emergency Training At BHUSD Campus

The Beverly Hills Fire Department conducted an emergency response training exercise Sunday at the district's Lasky Building.

The exercise allowed firefighters to practice response procedures in a school setting, including simulated fire conditions, rescue operations, hose and ladder deployment, ventilation procedures and incident command coordination.

BHUSD said providing first responders access to facilities helps emergency personnel become more familiar with layouts, entrances and operating conditions before an actual emergency occurs.

"One of Beverly Hills' greatest strengths is the close partnership between our City and our schools. Today's joint training exercise with the Beverly Hills Fire Department is another example of what can be accomplished when agencies work together with a shared mission of protecting our community," said BHUSD Board of Education President Judy Manouchehri. "Preparedness is not something we take for granted at BHUSD, and we are deeply appreciative of the Fire Department's commitment to ensuring our campuses, students, and staff are ready for any situation. Together, we are building a safer and stronger Beverly Hills."

City Council Approves Run Of The Stars 5K Event

The City Council approved a request from Not Today Cancer to host the "Run of the Stars" 5K Run/Walk on Sunday, Oct. 18 around El Rodeo Elementary School.

The approval allows the event to use sidewalks and parking lanes along the race route and includes a waiver of city permit fees and personnel costs totaling \$4,909.

The event will begin and end at El Rodeo, with setup scheduled from 6 a.m. to 8:30 a.m. The race will take place from 8:30 a.m. to 10:30 a.m., followed by cleanup until noon.

Organizers expect approximately 1,000 attendees, including about 800

Meet the Chief

I had the great pleasure recently of sitting down with the new Chief of BHPD, **Max Subin**, to discuss his three decade journey to this position. And what a journey it has been for this local guy who is the first Chief appointed from the ranks of BHPD in over forty years.

So, let's start at the beginning.

Chief Subin's parents grew up in New York and met at **Woodstock**, the most famous music festival in American history. Its full name was the **Woodstock Music & Art Fair**, and occurred from August 15 through 18, 1969, on dairy farmer Max Yasgur's farm in Bethel, New York. It was attended by nearly **500,000 people**, far more than had been anticipated or could comfortably be accommodated. Performers included The Who, Janis Joplin, Jefferson Airplane, The Grateful Dead and Jimi Hendrix, whose singing of our national anthem was one of the greatest performances in rock history. I remember all of these but I don't expect you to. Suffice it to say that this was a momentous event. And somehow, Chief Subin's parents found each other there.

Not long after Woodstock they drove across the country and moved to Venice Beach. Chief Subin has lived in that vicinity his entire life.

His course, as these things happen, was set from a casual conversation with one of his friends while he was attending Santa Monica High School. After class, his friend was changing into something that looked like a police uniform. He explained that he was in a Santa Monica PD "Explorer" program for high school students who wanted to learn about police work. It sounded good to young Max so he signed up and that was the start.

He then attended California State University at Northridge where he received an undergraduate degree and then a Masters in Public Administration. This training explains why he is such a good communicator. All through his days at CSUN he worked as a Police Cadet with SMPD. Unlike the Explorer program, as a Cadet, he points out, he was paid. I plan to cover the Explorer and Cadet programs in a future column.

He then started the application process for a job with a police department. During this period, he worked as a parking lot attendant at Gladstone's at the Beach. He described that as a "fantastic" job. (I did not probe further into the details.)

Among the police departments that he applied to were SMPD and BHPD. Of the two, he much preferred SMPD because that's where his friends from the Explorer and Cadet programs worked and, in his view, there was much more "action" there than in Beverly Hills. However, he was advised to take the job with the department that called him first. Fortunately for us, it was BHPD. He was 23 years old and after only a few weeks on the job, he came to appreciate the unique relationship between BH residents and BHPD and has never looked back.

Since joining the Department, the Chief has done everything and come full circle. He showed me a photo of his swearing in by then Chief Iannone in the same office that he now occupies as Chief. The office looks the same and our youthful new Chief hasn't changed much.

In 1999, he started as a patrol officer after training at the Police Academy. He moved from that to the plain clothes "Crime Suppression Unit", now called the "Crime Impact Team".

He then moved to the Detective Bureau and was then promoted to Sergeant and was a supervisor of patrol officers. He then came "inside" where he was with the Professional Standards group and was the Public Information Officer using those communication skills. He was promoted to Detective Sergeant and Lieutenant.

In 2021, the Chief was promoted to Captain. That was a particularly trying time as there were protests in the City for 32 consecutive weeks starting in 2020.

In his view, his appointment as Chief from within is very important for several reasons: it gives more advancement hope to young officers, we have a Chief who knows the community and has great institutional knowledge about the Department and can directly apply lessons learned, for example, using experience in dealing with the opening of the Wilshire/La Cienega Metro station in preparation for the opening of the Beverly/Wilshire Metro station.

He takes pride in the Department's uniquely extensive use of technology including 3500 cameras around the City, strategically located license plate readers, drones and advanced labs to analyze DNA. And this technology will only get better. He points out the full staffed Real Time Watch Center and the new Dispatch Center. The Dispatch Center handles over 31,000 911 calls per year and an astonishing (to me at least) 156,000 non-emergency calls per year. Think about it - nearly 200,000 calls per year; that's nearly 570 calls per day or more than one every two minutes.

Finally, I asked him to tell me his wish list. His response:

- 1) Fifteen new well-qualified officers;
- 2) For crime to go down; and
- 3) Better technology as it develops.

Chief Subin is off to a very good start and my impression is that he has the qualifications and qualities that will make him an outstanding Chief.

God speed, Chief.

At its study session on Tuesday Au-

gust 4, the Council delivered a mixed but inevitable message of bad news and good news regarding the so-called MicroTransit to and from the two Metro Subway stations.

The bad news is that we won't have a City provided badly needed way for easy access to and from the Metro subway any time soon.

The good news is that we will not have the nonsensical and expensive system that was one more in a line of similarly ill-conceived proposals from the City's Department of Public Works.

This proposal involved a combination of the City's current free dial a ride program for seniors and others who need transport to/from medical appointments with a subsidized on call (sort of) system which would take someone from their home in the hills to an ice cream shop. **An estimated only 20-30% of the rides would actually take someone to or from the Metro stations.** This would cost a bit over \$1.5M/year and take restricted funds away from necessary improvements to the stations such as the security facility at Wilshire/La Cienega station and, possibly, other needed improvements at the Beverly/Wilshire station.

This proposal was clearly a **Non Starter** for any objective observer to see.

The five Council Members were far more polite and measured in their rejection of this proposal than I would have been. But their message was clear:

You have had nearly a decade to come up with a way for people to get to and from two Metro stations that offer no parking and are miles from the homes of many residents.

Now the La Cienega station has been open for several months and we have nothing.

Go back to the drawing boards and come up with a proposal that serves the Metro stations and nothing more and that is affordable and sustainable.

And please at least try to give us something that makes sense by the time that the Beverly/Wilshire station opens.

I will be watching hopefully but not optimistically.

Ike Zekaria Reflects On His Family's Decades-Long Connection To Beverly Hills Schools Ahead Of New Arena Naming

The BHUSD Board unanimously approved a 15-year naming agreement for the basketball arena in the Konheim Building, which is currently under construction at Beverly High. The venue will be named Zekaria Arena and is supported by a donation from Ike and Leon Zekaria through the Beverly Hills Athletic Alumni Association.

How did your family get to Beverly Hills?

My parents had four children, and in 1967 the family was living in Burbank. Their dream was to give their children the best education possible, and they believed the way to do that was by sending us to Beverly Hills schools.

So they made the move to Beverly Hills, and it was a real financial stretch. There's a story my older sister likes to tell. She was 9 years old at the time and could see how stressed our parents were about the move. She even offered my dad the money from her piggy bank to help. Of course, he refused, but it showed how much she wanted to help.

This was not only my parents' vision, but I think my siblings really understood the opportunity they were being given. And so they moved to Beverly Hills at that time. Later on, I was born, and the five of us went to Beverly Hills schools, including the high school.

We took full advantage of the opportunities that the community and the school offered. I had one sister very involved in theater arts. My other siblings were all very involved in student government, my brother included, who was the ASB president. And then myself, who was more driven toward athletics.

It really became our foundation. Our friends, our social circle and our community all centered around Beverly Hills and the school district. That was the source of everything for us.

My brother and I are now business partners in the women's clothing business, Windsor, which is also a kind of family legacy business.

How did the Beverly Hills Athletic Alumni Association help bring this

naming agreement together?

They really educated me about what was happening in the school district, the direction the district was heading, and the investments being made in the schools. And I just wanted to be a small part of it and help in any way I could.

And my family was very much aligned with it. And BHAAA facilitated the entire process and made it possible.

What prompted your family to support the naming of the new Beverly High arena?

It was something that I spoke to my siblings about. We understood that this was a full-circle moment for us, for the family, and for the community.

My parents, Maurice and Alice Zekaria, came to this country with very little more than their dreams. My mother was from Mexico and my father was from Iraq. I believe the culmination of their dream, one they may have never even fathomed themselves, would have been to be able to help the school district that they so desperately wanted to belong to in some meaningful way and ultimately keep that dream alive for others.

That dream that started with my parents sending their kids to get the best education is now kind of bubbling up again with what the school district has done to the school and the investment that they've made.

And so, we realized that we wanted that dream to live on for the next generation. The school and the community have really put themselves in that position for this to now happen again, for Beverly Hills to kind of have the premier school district.

And I think it really sets up perfectly for that. So, we thought the timing was right as a result.

My wife, [Lara Nicolayevsky Zekaria] who I met after high school, also attended Beverly Hills schools, as did all of her siblings. Her family story very much paralleled ours in that her parents prioritized the schools and the community. So when it came to making this decision, there was complete

understanding and alignment on how important supporting the community is for us.

As evidenced by my family story, as well as my wife's, this is not a unique story. The dream of sending your kids to the best schools and the sacrifices made by families to do so is archetypal. That dream is alive and well for upcoming generations in Beverly Hills.

You described the Swim Gym as an important part of your high school experience. What made that facility so meaningful to you?

I think what's pretty cool about what's happening now is that, at the time when I was in high school, the gym, the Swim Gym in particular, with basketball, was my refuge. That was my safe space before safe spaces. That's where I made a ton of my best friends and lifelong friendships that continue today.

A lot of those kids at the time that I played basketball with were on opportunity permits. So, they were athletes or kids that had leadership abilities in sports and were good students, or in theater arts, and were allowed to come into the school on opportunity permits.

I think we're at that point now where we can get back to providing such opportunities for kids in the district. It's a bit of a full-circle moment. They built this incredible state-of-the-art facility that will also attract the best students. And so, I think that's a fascinating aspect of all this.

Part of it was the pride of being associated with that facility. The pride that I had access to this incredible facility that was so unique at the time and that is still unique. As an adolescent, when you find a place or something that you can attach yourself to and take pride in, that you put work into, and work on your craft, that's the beginning of finding yourself.

That's why it's such a strong association for me. And you look today at this new jaw-dropping 45,000-square-foot athletic facility and basketball arena, and you're like, it's undeniable how impactful that will be for students. It will be the center of the community.

I think we're going to get back to that full-circle moment where Beverly High and the Beverly Hills Unified School District are going to become the primary option for where parents want to send their kids to school, just like it was for me.

I think we're getting back to that place.

I really commend the district's vision and the investment it's made in these schools. It's truly inspiring.

Your family initially hesitated about attaching the Zekaria name to the arena. What ultimately led you to move forward with the naming agreement?

We were hesitant to attach our name because generally we like to just lead with humility and gratitude, because it's really not about us.

But when we thought about what it would represent, we realized how much it would mean to my mother. As soon as we mentioned it might be a possibility, we could see how proud she was.

I think that's where the whole story comes in—the leap of faith my parents made 60 years ago to make this happen. They literally had to borrow a third of the down payment from their broker and another third from a friend just to buy their home. It was a huge stretch. So for my mother to go from that to, 60 years later, holding this basketball was a moment we wanted to give her.

What role do you think alumni can play in supporting Beverly High and its students?

I think it's about staying engaged, staying connected, continuing to care, and doing whatever you can to help ensure the schools and the community continue to thrive and move in the right direction.

Is there anything else you would like to add?

We're incredibly grateful to be able to help in any way, and that's the greatest honor, whether our name is on it or not. We hope to see the school prosper, the students thrive, and the facility continue to serve as a major center for the community.
