WILSHIRE BOULEVARD & SOUTH SANTA MONICA BOULEVARD INTERSECTION IMPROVEMENTS

Beginning on August 3, 2026, until September 16, 2026

Typical work hours, including traffic control set-up, will be Monday through Saturday, 7:00 a.m. to 6:00 p.m. (weather permitting), and may vary by activity and location.

Construction will occur at all four corners of the intersection of Wilshire Boulevard and South Santa Monica Boulevard.

At least one lane in each direction will be maintained and intermittent turn restrictions are expected.

WHAT TO EXPECT:

- If necessary, intermittent overnight or weekend activity may take place. No noisy activity will be allowed between 9:00 p.m. and 8:00 a.m.
- Driveway, pedestrian, and business access will be maintained during construction. Crosswalk access may be temporarily redirected around active construction areas.
- "No Parking" signs will be posted, and street parking near work areas will be temporarily restricted.
- Overnight lane closures may remain in place to maintain a safe work zone around open trench areas.

Planning Commission to Consider Changes to Proposed 9111 Wilshire Boulevard Hotel

The Planning Commission is expected to consider proposed changes to a previously approved hotel project at 9111 Wilshire Blvd., including reducing the number of rooms and adding a restaurant, at its Thursday meeting.

The project would convert the existing 10-story office building into a 147-room hotel with restaurant and related uses. The Planning Commission originally approved a 154-room hotel at the site in 2020.

Under the revised plans, the project would include a 4,986-square-foot restaurant on a new 11th floor and a smaller, reconfigured pool deck on the third level.

The property was designated a local historic landmark in 2016. The revised plans would retain portions of the building's historic features.

The project would increase the building's height to about 150 feet, exceeding existing development standards for the property. The applicant is seeking amendments to its Historic Incentive Permit to allow the deviations.

A traffic analysis found the revised project is not expected to result in significant transportation impacts.

City staff is recommending conditional approval.

Theatre 40 to Present World Premiere of C. Auguste Dupin Play

Theatre 40 will present the world premiere of “The Case-Book of C. Auguste Dupin,” a new play based on the works of Edgar Allan Poe, beginning Sept. 17.

The production, adapted and directed by John Stryzik, brings together Poe's three Dupin stories: “The Murders in the Rue Morgue,” “The Mystery of Marie Roget” and “The Purloined Letter.”

The play centers on C. Auguste Dupin, a detective created by Poe who is widely regarded as an early model for later fictional detectives such as Sherlock Holmes and Hercule Poirot. The production follows Dupin as he uses logic and deduction to investigate a series of mysteries.

BHHS Academic Rankings

The 2026-2027 US News and World Report public high school rankings have just been published.

These rankings are very significant because they use a comprehensive consistent set of objective factors to measure both absolute performance by students and relative performance compared to other high schools. For example, absent comparisons we do not know that reported improvements by one school in isolation may not keep up with better improvements by comparable or neighboring schools.

The most surprising news for those who have not watched the BHHS conditions in recent years are how far the rankings of BHHS (once one of the very best in the US) have fallen when compared with other Los Angeles area high schools, California high schools and U.S. high schools.

Here are the BHHS rankings:

- Los Angeles Area: #174
- California: #357
- US: #2184

Think about that – there are 173 Los Angeles area public high schools ranked higher than BHHS.

An important but not the sole factor (40% of the total) is how our students perform on state proficiency examinations in English, Math and Science.

The US News rankings are important because they compare the public high schools. Comparative rankings tell us far more than scores standing alone.

And when BHHS is compared with neighboring schools or other schools in similarly affluent sections of the Los Angeles area, the comparison is disappointing.

Thus, BHHS ranks below Culver City High School (#61 in LA; # 129 in CA)

, Santa Monica High School (#34 in LA; #82 in CA) and even Venice High School (#132 in LA; #177 in CA) which is part of the troubled Los Angeles Unified School District. And BHHS ranks below Palos Verdes Peninsula HS (#12 in LA; # 38 in CA), Mira Costa [Manhattan Beach] HS (#59 in LA; #126 in CA) and Redondo Union HS (#57 in LA; #123 in CA).

This is even more surprising and difficult to understand when we reflect upon the fact that BHUSD receives far more revenue per student than any of these other districts.

A chart prepared by former Mayor **Bob Wunderlich** showing more detail about the scores and rankings of a number of these schools taken directly from the US News report is in this issue.

U.S. News explains that:

“To determine the top science, technology, engineering and math (STEM) schools, U.S. News looked at its top 2,000 ranked high schools from the national rankings and then evaluated the participation and success of those schools’ AP students on the science and math AP exams. From that group, the top 500 schools were ranked in the Best High Schools for STEM.”

As BHHS is not ranked in the top 2,000 U.S. high schools, unlike all of the others listed in Bob Wunderlich’s charts, it was not eligible for STEM ranking.

Notably, because of the need to compile data from all over the country, the proficiency exam scores are from the 2023-4 school year. There is no reason to believe that more recent scores from all of the schools would materially change the rankings.

Board President **Judith Manouchehri** discounts the rankings. She said:

“One important point of context is

that the U.S. News rankings are, by their nature, **lagging indicators**. They rely on historical academic data and prior student cohorts rather than current-year performance. To put that lag into perspective, when U.S. News released its 2025–2026 Best High Schools rankings in August 2025, it expressly stated that the rankings used data from the **2022–2023 school year**. [As explained above, the current rankings used some test data from the 2023–24 school year, Ms. Manouchehri’s second year on the Board.] Certain measures, such as graduation rates, also necessarily reflect the performance of student cohorts whose high school experience began years earlier.”

Given Ms. Manouchehri’s comment, we can take a quick look at how BH elementary schools compare with neighboring LA Unified elementary schools according to US News. Once again, our schools do not fare well.

Here is how they and neighboring LAUSD schools rank of all CA elementary schools:

- Horace Mann #1044 in CA
- Hawthorne (pre-ElRodeo) #643

LA Unified Elementary Schools in the neighborhood

- Canfield Avenue #600
- Castle Hts. #326
- Fairburn #87
- Overland Avenue #16
- Warner #158
- West Hollywood #486

So it seems Ms. Manouchehri may be correct – the problems in the high school begin in the elementary schools.

Importantly, the US News rankings compare all schools using the same metrics. Cherry-picked alleged improvements comparing one year’s BHHS 11th graders with last year’s BHHS 11th graders really tell us very little. Certainly they do not reveal how the performance of those 11th graders compare, for example, with the performance of SaMoHi’s 11th graders.

And there is a sizable gap between state proficiency exam scores between the two schools.

In English, 62% of BHHS students met the proficiency standards v. 84%

at SaMo; in Math, 48% of BHHS students met the standards v. 57% at SaMo; in Science only 35% of BHHS students met the standards v. 58% at SaMo.

The US News rankings are consistent with *School Digger*, another ranking service, which also prepares comparative rankings.

School Digger reports that BHHS ranked #283 among California Public High Schools in 2023, then dropped to #406 in 2024 and essentially stayed at that disappointing level with a ranking of #402 in 2025.

In Ms. Manouchehri’s case, the excuse of stale data isn’t persuasive because, under her watch, BHHS rankings have dropped each year of her term.

In 2024, BHHS was ranked #157 in LA and #344 in CA; in 2025: #166 in LA and #348 in CA; and, as noted above, in 2026: #174 in LA and #357 in CA.

No one who has watched – even from a distance – Ms. Manouchehri’s behavior and performance during those years on the Board would believe that, after three years, she has recently found a magic wand and turned things around.

I do not presume to have the solution to what ails our schools. It is clear to me that substantial changes, not nibbling around the edges and touting small alleged “improvements” as though they have discovered fire, are needed.

The good news is that we have a lot of great experienced teachers and we can still turn things around.

High Impact tutoring and comprehensive summer school programming are reasonable interventions that the district has recently implemented. The reorientation of high school counseling and the dual language programs are steps in the right direction.

But more is needed.

First and foremost, we need a functioning Board of Education that will set sensible policies, forgo behavior that serves as a litigation magnet, use their abundant resources prudently, cease the mindless micromanagement and get out of the way so that the educators can do their job.

PLANNING COMMISSION TO CONSIDER CHANGES TO ONE BEVERLY HILLS DEVELOPMENT AGREEMENT

Promenade Could Add New Surgical Center

By Danielle Berjikian

The Planning Commission will consider proposed changes to the One Beverly Hills plan that would allow outpatient medical uses on the property and create a program allowing some units to be rented for as little as one night.

The discussion is expected to take place at its Thursday meeting.

The One Beverly Hills project lies on

9876, 9900 and 9988 Wilshire Blvd. The area includes the Beverly Hilton, a former Robinsons-May site and a former Union 76 gas station site. The Waldorf Astoria property at 9850 Wilshire Blvd. would not be affected by the proposed changes.

The City Council approved the development agreement in 2021.

Under the proposed changes, about 11,000 square feet of the Promenade area could be used for medical and outpatient surgical services. The spaces would be located below street level and away from public street frontages, according to a city staff report. City staff is recommending that the uses be located at least 50 feet from public street-facing facades to preserve areas for pedestrian-oriented uses.

The proposal would also establish a Residences Rental Program that could allow units to be rented for at least one night. Owners could choose to participate, but no more than 44 units could be rented on any given night.

The Planning Commission is expected to make a recommendation to the City Council. The staff report is recommending conditional approval.

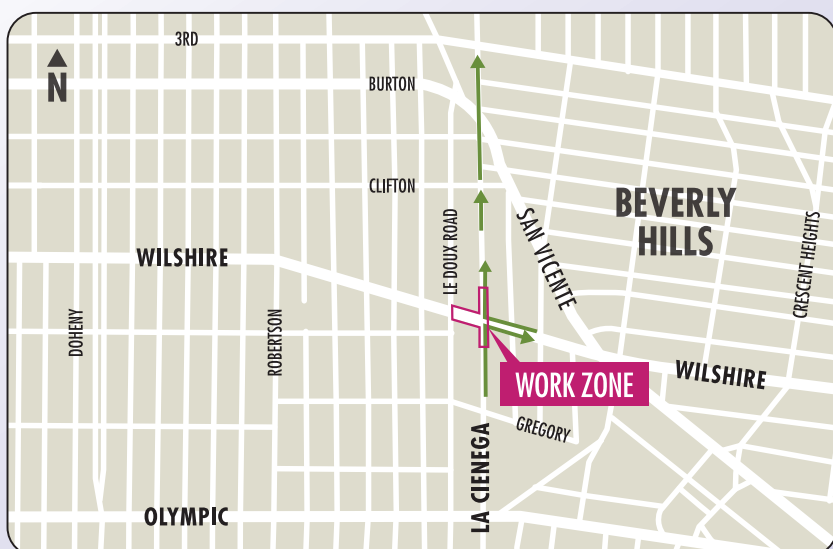
